

PRAYER:

That on acceptance of this appeal the respondents may kindly be directed to release monthly salaries of the appellant w.e.f. 25.6.2019 till date. Any remedy which this august Court deems fit may also be awarded in favor of appellant.

R/SHEWETH:
ON FACTS:

- 1- That the respondent No.3 issued advertisement for filling up various posts including the post of pathology technician (BPS-12). That the appellant having the requisite qualification for the post of Pathology Technician (BPS-12) applied for the said post and after participated in the written test and interview the appellant was appointed against the said post vide order dated 25.6.2019. Copies of the advertisement, Domicile, educational testimonials and appointment order are attached as annexure .. **A, B, C & D.**

- 2- That in response to the said appointment order dated 25.6.2019 the appellant submitted his arrival report vide dated 25.6.2019 and started his duty quite efficiently and up to the entire satisfaction of his superiors. Copies of the Medical certificate, arrival report, verification and service are attached as annexure **E, F, G & H.**
- 3- That after arrival the appellant started performing her duties quite efficiently and up to the entire satisfaction of his superiors. That inspite of regular performance of duty salaries of the appellant has not been released and when the appellant visited the concerned quarter for the release of his salaries. That in response the appellant was handed over the letter dated 21.10.2019 whereby due to political interference the salaries of the appellant have been withheld. Copies of the letters and attendance are attached as annexure **I & J.**
- 4- That appellant feeling aggrieved from the inaction of the respondents filed Departmental appeal vide dated 20.12.2019 for the release of his salaries but no reply has been received so far. Copy of the Departmental appeal is attached as annexure **K.**
- 5- That having no other remedy the appellant filed this instant appeal on the following grounds amongst the others.

GROUND:

- A- That the inaction of the respondents by not releasing the monthly salaries of the appellant w.e.f. 25.6.2019 till date is against the law, facts, norms of natural justice and materials on the record.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C- That the respondent Department acted in arbitrary and malafide manner by not releasing the monthly salaries of the appellant w.e.f. 25.6.2019 till date.
- D- That the appellant has been discriminated by the respondent Department on the subject noted above and as such the respondent violated the principle of natural justice.
- E- That the documents of the appellant have properly been verified by the respondents from the quarter concern but

inspite of that the respondents are not willing to release the monthly salaries of the appellant.

- F-** That the respondent Department also violated the principle of "WORK DONE MUST PAID" by not releasing the monthly salaries of the appellant.
- G-** That the inaction of the respondents by not releasing the monthly salaries of the appellant w.e.f. 25.6.2019 till date is politically motivated.
- H-** That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that appeal of the appellant may be accepted as prayed for.
