1. That the appellant is highly qualified is serving in BPS-20 and was posted as Principal Govt. College Peshawar on 18-03-2013.

- 2. That the appellant while posted as Principal, Govt. College Peshawar a Committee was constituted for admissions to the first year 2013.
- 3. That during admissions, the local member of the ruling party namely Ziaulllah, with another member of the provincial assembly namely Javed Naseem approached the appellant for allowing admissions to the students out of merit, which illegal act was refused by the appellant, resulting in an unto wards incident, where after the appellant was scandalized alleging by the mentioned members that the appellant along with others is involved in allowing admissions in violation of the merit, which incident was also reported in the press. The appellant was threatened of dire consequences by the mentioned members of the ruling party. (Copy of press cutting is enclosed as Annexure A).
- 4. That the appellant was issued charge sheet along with statement of allegations, which was replied in detail denying the allegations. (Copy of charge sheet and reply are enclosed as Annexure B & C).
- 5. That thereafter the impugned notification dated 06-03-2014 was issued whereby the appellant was transferred from Govt. College Peshawar to Govt. Degree College Hayatabad as Professor. (Copy of the Notification is enclosed as Annexure D).
- 6. That the appellant filed representation on 11-03-2014, and also approached the August Peshawar but of no avail, and the representation of the appellant has not been responded so far despite the lapse the ninety days. (Copy of representation is enclosed as Annexure E).
- 7. That the impugned Notification dated 06-03-2014 is against the law, facts and principles of justice on grounds inter alia as follows:-

#### GROUNDS:-

A. That the impugned Notification is illegal and void ab-initio.

- **B.** That the appellant has not been treated in accordance with law and mandatory provisions of law, rules and policy on the subject have been violated by the respondents and the respondents have violated all norms of justice.
- **C.** That the impugned orders are based on malafide, favoritism and political interference.
- **D.** That the appellant was transferred prematurely in violation of the rules and policy on the subject, which action is not permitted by law and the same has resulted in grave injustice to the appellant.
- E. That the allegations against the appellant are totally false and baseless which is proved from the fact that the report of the inquiry officer was even not awaited and the appellant was transferred just after one day of his submission of reply to the charge sheet.
