- 10. That there is no bar to Restore the appeal of the appellant.

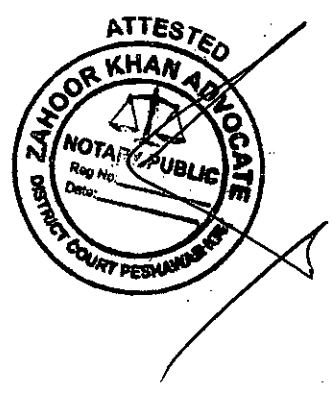
