

2. Mr. Khoidad Khan son of Gul Deen hereinafter referred to  
as the appellant has preferred the instant service appeal under  
Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974  
against impugned orders dated 18.02.2012 and 21.07.2012 vide  
which recovery of salary from the pension of the appellant was  
ordered and hence the instant service appeal.

3. Learned counsel for the appellant has argued that the  
appellant was retired Army personnel and was appointed as  
Sweeper at Government Middle School, Ghurai Pain, and District  
Kohat w.e.f. 05.09.1988. That he performed his duties till  
31.10.2011 when the competent authority ordered his retirement  
from service w.e.f. 03.06.2008 and directed recovery of the  
amount of Rs. 4, 55,199/- paid to the appellant as salary from his



pensionary benefits. That the salary was paid to the appellant in lieu of services rendered by him. That the omission to retire the appellant from service is not attributable to the appellant and as such the disputed amount cannot be recoverable from his pensionary benefits. Reliance was placed on case law reported as PLD-2013 S.C 829 and 2007-PLC (C.S) 364 (Supreme Court of Pakistan).

4. Learned Government Pleader has argued that the appellant was responsible for receiving the excess salary as he had manipulated the service record which was in his custody. That due to the said act of the appellant he is not entitled to retain the excess amount received by him as salary.

5. We have heard arguments of learned counsel for the parties and perused the record.

6. Service record of the appellant would indicate that the appellant was allowed to perform his duty upto 31.10.2011 and was accordingly paid salary. The date of retirement of the appellant from service was later on notified and appellant stood retired from service w.e.f. 03.06.2008. There is no evidence on record to observe that the appellant has manipulated entries in the service record. Since the appellant has performed duty and, in lieu thereof received salary, as such and keeping in view the fact that the omission is attributable to the authority we hold that the respondents are not competent to direct recovery of the said amount paid to the appellant as salary.

7. In view of the above we accept the present appeal and set aside the impugned orders, leaving the parties to bear their own costs. File be consigned to the record room.

- 2- Annexures of the appeal may be attested.



Service appeal under section 4 of the Khyber Pakhunkhwa Service Tribunal Act, 1974 against the Order of respondent No.2 dated 18-02-2012 and order dated 21-07-2012 addressed to respondent No.4 wherein (i) prospective sanction has been accorded to the grant of encashment of lieu of LPR w.e from 05-12-2007 to 02-06-2008 (180) days on full pay of the appellant(ii) got him retired from service w.e from 03-06-2008 (iii) recovery of amount Rs.4,55,199/- w.e.f 04-06-2008 to 31-10-2011(salaries) and against which appellant had filed writ petition No.2468/2013, wherein the Honourable High Court vide order dated 28-01-2014 was pleased to converted the same into departmental appeal with further direction to the respondent No.1 to decide the same within 1 month positively, but not decided within the stipulated period hence the instant appeal with the pray

that on acceptance of the instant appeal this Honourable Tribunal may graciously be pleased to declare the impugned order as illegal, unlawful and without lawful authority and has no adverse effect upon the rights of the appellant and set aside the same with the directions to the respondent to grant the appellant his full pension without any sort of recovery and got him retired w.e.f 18-02-2012 and also declare the encashment of LPR is illegal, unlawful and without lawful authority.

Respectfully Sheweth,

Facts giving rise to the present appeal are as under:-

1. That appellant is an illiterate. He was primarily recruited in Chagi Militia Nushki and was got retired w.e from 05-01-1986 (Annexure-A).
2. That after retirement he was offered the post of Sweeper at Govt: Middle School (Now High School) Ghurazai Payan Kohat on 05-09-1988.
3. That appellant served as such till 31-10-2011 and then submitted an application for proceeding on pension (Annexure-B).
4. That the application for proceeding on pension was duly processed and during the process it was found that petitioner has served beyond the period of superannuation for four continuous years (Annexure-C).
5. That process for recovery has been initiated against the appellant and now has been order for the recovery of Rs.4,55,199/- (Annexure-D).
6. That the malafide of the respondents can best be judged from the fact that they have got the petitioner retired w.e.from 03-06-2008 vide

Order dated 18-02-2012 (Annexure-E) and more so accorded encashment lieu of LPR from 15-12-2007 to 02-06-2008 which has no factual and legal support and further more the impugned recovery has been order with effect from 04-06-2008 to 31-10-2012 the period for which the appellant has actually performed his duty.

7. That appellant is an illiterate. The respondents have maintained his service book and the same have been verified by them till 01-12-2011 (Annexure-F).
8. That appellant has performed his duty till the end of the year, 2011 with full dedication and to the entire satisfaction of his superiors.
9. That appellant has received his salaries during the impugned period for the actual performance of his duty and he was not overage as per record and if so it was the duty of the respondents to get him retired on attaining the age of superannuation being the custodian of the record and for which appellant could not be punished.
10. That appellant has not received his pension till the date for the reason stated above, and therefore the appellant submitted Writ Petition No 2468-P/2013 dated 21-01-2014 the Hon'able High Court converted, treated the same as Departmental Appeal /representation and referred to respondent No 1 with direction to decide the same with in Month Positively (Annexure-G)
11. That the impugned order of recovery is not only illegal but also unwarranted and undesirable and also against the spirit of the teaching of the Holy profit (PBUH).

12. That appellant, being aggrieved of impugned recovery order and the acts and actions of Respondents and having no other adequate and efficacious remedy, files this constitutional petition inter-alia on the following grounds:-

**Grounds:**

- A. That Respondents have not treated appellant in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973. appellant has performed his duty during the impugned period and it was the duty of the respondents to get him retired on attaining the age of superannuation if so, but they did not notice the same at the relevant time and when appellant himself approached for proceeding on retirement, they are now got from sleep and made an order for recovery of the alleged outstanding amount, therefore the impugned order of recovery is unlawful, unjust, unfair and hence not sustainable in the eye of law.
- B. That the appellant has actually performed his duty and therefore, he was entitled for the salary even though beyond the age of superannuation. The Principle of Locus Poenitentiae also favours the appellant.
- C. That an employee becomes entitled for his remuneration the moment he performs his duty. Appellant has performed his duty and therefore, as per teaching of our Holy religion, he was entitled for remuneration of the same and therefore, the so called recovery at this belated stage is not only unlawful but also unwarranted and undesirable.
- D. That appellant would like to submit further grounds at the time of hearing.

For the aforesaid reasons, it is therefore, humbly prayed that appeal may kindly be allowed as prayed for above/heading.

Any other relief as deemed appropriate in the circumstances of case not specifically asked for, may also be granted to petitioner.

3. That petitioner served as such till 31-10-2011 and then submitted an application for proceeding on pension (Annexure-B).
4. That the application for proceeding on pension was duly processed and during the process it was found that petitioner has served beyond the period of superannuation for four continuous years (Annexure-C).
5. That process for recovery has been initiated against the petitioner and now has been order for the recovery of Rs.4,55,199/- (Annexure-D).
6. That the malafide of the respondents can best be judged from the fact that they have got the petitioner retired w.e.from 03-06-2008 vide Order dated, 18-02-2012 (Annexure-E) and more so accorded encashment lieu of LPR from 15-12-2007 to 02-06-2008 which has no factual and legal support.
7. That petitioner is an illiterate. The respondents have maintained his service book and the same have been verified by them till 01-12-2011 (Annexure-F).
8. That petitioner has performed his duty till the end of the year, 2011 with full dedication and to the entire satisfaction of his superiors.
9. That petitioner has received his salaries during the impugned period for the actual performance of his

10. That petitioner has not received his pension till the date for the reason stated above.
11. That the impugned order of recovery is not only illegal but also unwarranted and undesirable and also against the spirit of the teaching of the Holy profit (PBUH).
12. That petitioner, being aggrieved of impugned recovery order and the acts and actions of Respondents and having no other adequate and efficacious remedy, files this constitutional petition inter-alia on the following grounds:-

**Grounds:**

- A. That Respondents have not treated petitioner in accordance with law, rules and policy on subject and acted in violation of Article 4 of the Constitution of Islamic Republic of Pakistan, 1973. - C. That an employee became entitled for his remuneration the moment he performed his duty. Petitioner has performed his duty and therefore, as per teaching of our Holy religion, he was entitled for remuneration of the same and therefore, the so called recovery at this belated stage is not only unlawful but also unwarranted and undesirable.
- D. That petitioner would like to submit further grounds at the time of hearing.

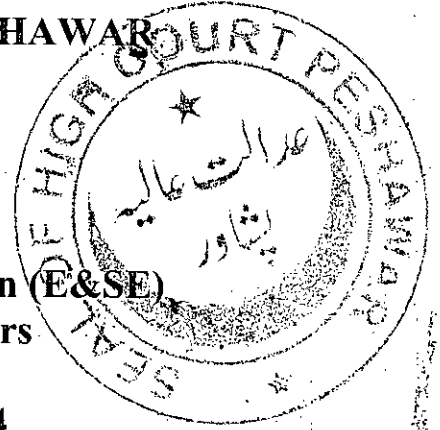





RESPECTFULLY SHEWTH:

Para wise comments in respect of Respondent No 1 & 2 are as under:-

Preliminary Objections:-

1. That appellant has got no cause of action.
2. That appellant has no locus stands.
3. That the appellant has not come with clean hands to August Service Tribunal, Peshawar.
4. The appeal is bad in its present form for non-joinder of necessary parties hence liable to be dismissed on this sole ground.
5. That the instant appeal is barred by law..

Facts:-

1. Incorrect, the appellant has signed the first page of service book duly attested by the SDEO Male Kohat. The appellant Joined Chagi Militia on 04-06-66 at

the age of 18 years his date of birth according to discharge book is 04-06-1948. His date of retirement from chagi militia is 05-01-1986. He served in Chagi Militia for 19 years, seven months and 01 day.

At the time of his retirement from Chagi Militia his age was 37 years, seven months and 01 day. (Annexure A)

2. Correct, the appellant joined education department on 05-09-1988 at the age of 40 years, 03 months and 01 day as ex -serviceman.

He was likely to be retired on 01-06-2008 at the age of 60 years. But he wrongly continued his service up to 30-11-2011 by tempering his date of birth in his service book as 20-08-1960.(Annexure B)

3. Correct, but extended that the appellant is a habitual cheater. He started cheating during his service in chagi militia. On 13-12-1984 he got NIC bearing no.616-60-120348. According to this NIC his date of birth is 20-08-1960 (copy attached). This shows how cunning he was and he is. After 03-02-2006 he tempered / changed his date of birth in his service book as 20-08-1960. Instead of 04-06-1948. (Annexure C)

4. During scrutiny of his pension papers and service book it was found that the appellant changed / tempered his date of birth as 20-08-1960 instead of 04-06-1948.

As a result of this tempering he wrongly continued his service up to 30-11-2011. Which is about 3 years 05 months and 26 days and has illegally drawn Rs. 455199/-. (Annexure D)

5. In this connection this office nominated one senior officer BPS-18 vice principal Govt. High School No.3 Kohat for detail inquiry. He also recommended the recovery of overpaid amount. (Annexure E)

6. Incorrect, as per rules the appellant is entitle with full benefits up to 02-06-2008 i.e. gratuity /LPR encashment / GPF and monthly pension. (Annexure F)

7. As per record of service book, pension papers and school attendance register the appellant recorded the Urdu signature. (Annexure G)

8. Pertains to Record.

9. Incorrect. The appellant has wrongly drawn salary up to 30-11-2011 by virtue tempering made by him in his date of birth in his service book. (Annexure H)

10. The appellant's pension papers along with other necessary documents have already been submitted to the district account officer Kohat vide letter No.2738 dated 21-03-2012. (Annexure I)

11. Incorrect. The appellant caused loss of Rs. 455199/- to Government treasure by committing tempering in his date of birth in his service book. (Annexure J)

12. Incorrect, the appellant's pension papers have also been submitted to the district accounts office Kohat with the request that recovery outstanding against the Ex-sweeper (Khoidad Khan) and Rs. 455199/- may be deducted out of his gratuity /LPR encashment /GPF final payments and monthly pension. (Annexure K)

Grounds:-


- (A) Incorrect, the appellant worked directly under the control of the Head Master Govt. High School Ghurzai Payan Kohat. All headmasters / principals of high / higher secondary schools are the D.D.O of all those teaching staff / non teaching staff who work in their schools. Service books and other relevant record is also maintained by the headmaster concerned. But unfortunately most of the time GHS Ghurzai Payan Kohat has remained without a regular headmaster. All most school was run by a C.T teacher. As a sweeper, the appellant had in easy approach to the record room and making the advantage of it, the appellant stole his service book and brought the desirable change in it. According to the statement of EX-D.D.O the original service book is still in the custody of the appellant. It is true in the sense that how can his lawyer attest the photo copy of his service book without seeing the original service book. The appellant is repeatedly requested to return the original service book to the office of the headmaster GHS Ghurzai Payan Kohat and finally he handed over his original service book to the Headmaster GHS Ghurzai payan Kohat on 13-06-2015.
- (B) Incorrect, because the appellant wrongly performed his duty to which he was not entitled.
- (C) Incorrect. The appellant is entitled for pension along with other benefits up to 02-06-2008. As per his original date of birth.
- (D) The tempering was deliberate, intentional and a mala fide act of the appellant himself. How can it be possible that the same headmaster attests two different dates of birth of the same person at the same time and on the same date, the appellant has attempted to deceive, the honorable service tribunal and the department as well. The case is

directives that it should be settled departmentally. So it is therefore humbly prayed that his appeal may kindly be dismissed. The appellant discharge book of militia force and service book of education department attached for ready reference.

- (E) The respondents would like to submit further grounds at the time of hearing. It is requested that the appeal may be dismissed with cost.

reaching to the age of sixty years, the Civil Servant deemed to be retired from Govt: service automatically.



That the respondents Department has been ordered he recovery for the appellant form 04.06.2008 to 31.10.2012 during the said period appellant served for the respondent Department quite efficiently and upto the entire satisfaction of his superiors.

7- Incorrect and not replying accordingly hence denied.

8- Admitted Correct by the respondent No 1 and 2 while the respondent No. 4 is incorrect hence denied.

9- Incorrect and not replied accordingly. That appellant performed his duty quite efficiently till the end of 2011 for which it is necessary the appellant was entitled for the salaries according to the principle of "WORK DONE MUST BE PAID" and the appellant could not be punished for the fault of the respondents.

10- Admitted correct by the respondents hence need no comments.

11- Incorrect and replying accordingly hence denied.

12- Incorrect and not replying accordingly hence denied.

**GROUND:**

**(A TO D):**

All the grounds of main appeal are correct and in accordance with law and prevailing rules and that of the respondents are incorrect and baseless hence denied. That the recovery of the salaries from the appellant is illegal, unlawful and against the principle of "WORK DONE MUST BE PAID". That appellant performed his duty till the end of 2011 quite efficiently and upto the entire satisfaction of his superior due to which the appellant was the right to withdraw his monthly salaries according rules. That the respondent Department showing malafide to recover the salaries from the appellant which the appellant which the appellant has been withdrawn according to the law and rules and the appellant could not be punished for the fault of the others.

It is therefore most humbly prayed that on acceptance of this rejoinder the appeal of the appellant may be accepted as prayed for.
