Subject; **POSTING / TRANSFER OF MR. MUKHTIAR AHMED ROGRESS OFFICER (BPS-16) AS ASSISTANT DIRECTOR (BPS-17) LOCAL GOVT & RDD TEHSIL GHAZI, DISTRICT HARIPUR.**

It is submitted that the posting/transfer of the subject mentioned officer was made in contrary to the judgment dated 04/06/2021 of the Hon'able Service Tribunal KPK passed in Service Appeal No.457/2018 (Syed Hasnain Kazmi V/S Govt. of KPK).


The Administrative Department took up the case with the KPK Law Department for filing Appeal/CPLA before the Hon'able Supreme Court of Pakistan vide No. SO(Lit)/LG/2-283/2017/2951 dated 07/07/2021 but the same was declared unfit for filing Appeal/CPLA before the court of law vide No. SO(Lit)LD/8-20/LG/2021/178-81 dated 04/08/2021.

The prayer of the above mentioned Service Appeal is reproduced as under:

"ON ACCEPTANCE OF THIS APPEAL, THE APPELLANT MAY VERY GRACIOUSLY BE REINSTATED IN SERVICE WITH ALL BACK BENEFITS, FOUR (04) ILLEGAL NOTIFICATIONS DATED 07/08/2017, 30/08/2017, 08/09/2017, AND 12/10/2017 BE SET ASIDE AND THE RESPONDENTS BE DIRECTED TO SANCTION MEDICAL LEAVE OF THE APPELLANT AS RECOMMENDED BY THE STANDING MEDICAL BOARD"

It is pertinent to mentioned over here that when the Service Appeal was decided in favour of the appellant, it means the prayer has been accepted. It is crystal clear from perusal the prayer that the appellant may be posted as Assistant Director Local Govt. & RDD for the whole District Haripur for a period of two (02) years. The Administrative Department followed the court orders & posted the petitioner as Assistant Director (Senior) Local Govt. & RDD District Haripur vide order dated 16/02/2022. Later on in contrary to the court orders the Administrative Department posted the subject mentioned official as Assistant Director Local Govt. & RDD Tehsil Ghazi vide order dated 21/09/2022 copy attached.


