

**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE INACTION OF THE RESPONDENT NO.3 BY NOT ADJUSTING/POSTING THE APPELLANT AGAINST THE POST OF SST SCIENCE (BPS-16) IN PURSUANCE OF THE NOTIFICATION DATED 29.10.2021 AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal the respondent may kindly be directed to act upon the promotion notification of the appellant vide dated 29.10.2021 by adjusting/posting the appellant against the post of SST Bio/Chemistry w.e.f 29.10.2021 with all back benefits including seniority. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

**Brief facts giving rise to the present appeal are as under:-**

- 1- That the appellant was initially appointed as PST BPS-07 vide order dated 07.04.2004 and promoted to the post of CT (BPS-15) vide order dated 19.03.2015 in the respondent department and performing his duties quite efficiently and whole heartedly and up to the entire satisfaction of his high ups. Copies of Appointment Order dated 07.04.2004 and Promotion Order dated

- 2- That subsequently the appellant was promoted to the post of SST (Bio/Chemistry) upon recommendation of Departmental Selection Committee on regular basis vide notification dated 29.10.2021. Copy of the notification dated 29.10.2021 is attached as Annexure .....**B.**
- 3- That all the recommended teachers of the province belonging to different districts whose promotion notifications were issued simultaneously with that of the appellant have been promoted w.e.f due date while the appellant has not been promoted till date. Copies of the promotion orders are attached as Annexure .....**C.**
- 4- That the appellant time and again visited the office concerned regarding his posting/adjustment but to no avail. That the respondent department reluctant to implement the promotion order of the applicant without any lawful reason.
- 5- That the appellant feeling aggrieved filed departmental appeal for his posting/adjustment as SST (Bio/Chem) but in vain. Copy of the departmental appeal is attached as Annexure .....**D.**
- 6- That appellant having no other efficacious remedy but to file the instant appeal on the following grounds amongst the others.

**GROUND:**

- A-** That the inaction of the respondent No.3 by not adjusting/posting the appellant against the post of SST science (BPS-16) in pursuance of the notification dated 29.10.2021 are against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside.
- B-** That appellant has not been treated in accordance with law and rules by the respondent department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C-** That all the recommended teachers of the province belonging to different districts whose promotion notifications were issued simultaneously with that of

the appellant have been promoted w.e.f due date while the appellant has not been promoted till date which is sole discrimination.

D- That the inaction of the respondent No.3 by not adjusting/posting the appellant against the post of SST science (BPS-16) in pursuance of the notification dated 29.10.2021 in arbitrary and mala fide manner, therefore, the same is not tenable in the eye of law and liable to be struck down.

E- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal may kindly be accepted as prayed for.
