On Preliminary Objections:

All the preliminary objections are wrong, incorrect, misleading and misconceived, hence denied.

On Facts:

- 1. Para No "1" of Service Appeal is admitted to be correct, hence needs no reply.
- 2. Para No "2" of the Service Appeal is correct as per record.
- 3. Para No "3" of the Service Appeal is correct as per record.
- 4. Para No "4" of the comments is partially correct, whereas some material facts have been concealed by the respondents. In fact, prior to the issuance of the Notification dated 19-10-2018, the provincial cabinet had held in its meetings held on 15-10-2018 that the technical allowance be granted to all the engineers working in Provincial Government, which is evident from the copy of minutes annexed with the service appeal.
- 5. Para No "5" of the comments is wrong, incorrect, misleading and misconceived, hence denied. In fact, the grant of Technical Allowance on the basis job nature is neither mentioned in the minutes of the cabinet meeting nor in the Notification dated 19-10-2018 and subsequent modified Notification dated 07-07-2021, thus the respondents have done pick and chose, cherry picking which is not warranted under the law.

Furthermore, it is totally wrong, incorrect, misleading, misconceived and against the facts that the job/duty of Engineers working in the Agriculture Department is just desk type. In fact, the respondents in its Official letter dated 16-07-2021 annexed with the Service Appeal has categorically stated that the Engineers working in On Farm Water Management deals with the civil works/Engineering works i.e., Construction, designing, improvement, preparation of BOQ/estimates, of the following innervations, improvement of tertiary irrigation system, construction of water storage Tanks, installation

of high efficiency irrigation system (Drip & Sprinkle), PCC, PCPS, Bricks and pipe lining. In the aforesaid letter the respondents have requested to grant Technical Allowance to the engineers working in the respondent Department.




