
1. Pertains to record.

3. Pertains to record.

The petitioner was promoted to the rank of senior clerk after promotion of Mr. Chandi Khan to the post of Assistant (BPS-16), through joint seniority list, the administrative head of the petitioner was adjusted in Food Department, since the position vacant was in Food department. Which has not been bifurcated as yet. It is also noteworthy to mention that the petitioner did not raise any objections with regards to his promotion in vacant posts under administrative head of Food department (Copy attached).
