






The grievance of the appellant relates to notification of Government of Khyber Pakhtunkhwa Board of Revenue issued on 13.05.2019 wherein by virtue of amendment in Appendix quota reserved for promotion of Senior Clerk and Junior Scale Stenographer for promotion to the post of Naib Tehsildar has been deleted which was previously allotted under the notification of the Government of Khyber Pakhtunkhwa dated 25.01.2016. Points raised need consideration. The appeal is admitted for hearing subject to all legal objections including that of limitation to be determined during full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 28.12.2021 before the D.B.


