



According to factual account in the memorandum of appeal and documents annexed therewith, the appellant was transferred to GGHS Laiq Zaman Kot vide order dated 24.08.2018 and after having served for a period of about two years and 10 months there, he was transferred to the office of DEO North Waziristan against the post of Junior Clerk from the date of his taking over charge vide order dated 31.03.2021. He took over the charge of new posting on 01.04.2021 (F.N) as per copy of charge report annexed with the appeal. However, the said order was withdrawn by the appellate authority vide order dated 06.04.2021 and simultaneously another order of similar date, whereby respondent No. 4 was also



transferred from DEO office has also been withdrawn. In the given scheme of withdrawal of transfer orders, it appears that the appellant has been removed from the post of Junior Clerk in DEO office to make it available for respondent No. 4. Learned counsel for the appellant contends that the exercise of authority by the respondent No. 2 is highly unfair and against the norms of justice. Let the respondents be put on notice for full hearing of the appeal. Therefore, this appeal is admitted for full hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively.
