**SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER  
PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974  
READ WITH ALL ENABLING PROVISIONS OF LAW AS  
AMENDED FROM TIME TO TIME, AGAINST THE  
SENIORITY LIST OF MALE CERTIFIED TEACHERS  
(CTs) OF DISTRICT BAJUAR ISSUED ON 02/04/2020 BY  
THE RESPONDENT NO. 5.**

**PRAYER:**

**ON THE ACCEPTANCE OF INSTANT SERVICE APPEAL, BY DECLARING THE SENIORITY LIST OF CTs DATED 02/04/2020 ISSUED BY RESPONDENT NO. 5 AS ILLEGAL & AGAINST THE EXISTING LAW, THE RESPONDENTS MAY PLEASE BE DIRECTED TO PREPARE THE SENIORITY LIST ON THE BASIS OF AGE AS MAINTAINED IN THE YEAR 2017 & 2019. ANY OTHER RELIEF WHICH THOUGH HAS NOT BEEN SPECIFICALLY PRAYED FOR BUT FOR WHICH THE APPELLANT ARE OTHERWISE ENTITLED, MAY ALSO BE GRANTED PLEASE.**

*Respectfully Sheweth:*

Brief facts giving rise to the instant appeal are as under:

- 1) That the appellant was appointed to the post of CT vide appointment order bearing Endst: No. 4887-92/Estab.Dated Khar the 19/04/2013 by the Agency Education Officer, District Bajaur. Copy of the appointment order is annexed herewith as “Annexure A”.
  
- 2) That later on in the year 2017, a final seniority list of male CTs working in the Agency Education Department was prepared on the basis of age and on the strength of that very seniority list about 70 CTs (BPS-15) were promoted to Sr.CTs (BPS-16) vide Notification bearing Endst: No. 7689-7772/promotion/CT/Male dated 22/02/2017. Copy of the seniority list of 2017 and Notification regarding promotion are annexed herewith as “Annexure B & C” respectively.

- 3) That, similarly in the year 2019 vide Notification bearing Endst: No. 4888-93 dated 06/05/2019 promotion was given to various teachers from CTs/SCTs to SSTs on the strength of a seniority list of male CTs which was prepared on the basis of age and subject as per law & prevailing rules. Copy of the seniority list and Notification regarding promotion are annexed herewith as “**Annexure D & E**” respectively.
  
- 4) That likewise in the year 2019 another notification regarding promotion of SCTs/CTs was issued vide Endst: No. 5321-50 dated 29/03/2019 in which too seniority of the CTs/SCTs were maintained on the basis of age and subject with the further observance of 25% quota for open merit and 75% quota for departmental promotion. Copy of the *ibid* Notification is annexed herewith as “**Annexure F**”.
  
- 5) That contrary to the above procedure existing/prevailing laws for the preparation of seniority list, the respondent No. 5 has now prepared and issued seniority list on 02/04/2020 about the CTs in District Bajuar not on the basis of age but on the basis of score / points which badly disturbed the seniority of the appellant alongwith many other CTs so committed violation of rules and procedure. Copy of the impugned herein seniority list dated 02/04/2020 is annexed herewith as “**Annexure G**”.
  
- 6) That being aggrieved from the *ibid* seniority list dated 02/04/2020, the appellant requested repeatedly through *whatsapp* number given in the impugned herein seniority list for the correction of the seniority list to the respondent No. 5 but in vain therefore, the appellant then submitted written applications / objections on the impugned seniority list and

until filing of the instant appeal no decision / reply was given to the appellant.

- 7) That having so dishearten and dissatisfied, the appellant then preferred departmental appeal/representation dated 21/04/2020 to the respondent No. 3 for the restoration of their age wise seniority but that too fell on deep ears. Copy of the departmental representation is annexed herewith as "Annexure H".
- 8) That having no other adequate remedy and to entertain the constitutional right to appeal, the appellant prefers the instant appeal before this Hon'ble Tribunal for the restoration of their *inter se* age wise seniority *inter alia* on the following grounds/reasons with so many others:

**GROUND:**



- a) That the respondent No. 5 has committed violation of Article 10A of the constitution of the Islamic Republic of Pakistan, 1973 which guarantees that all the citizens of the state are to be treated alike and with equality *exempli gratia* seniority lists for the cadre of Sr. CTs and that of PSTs were prepared and both were issued on 07/04/220 in which age wise seniority was given to each individual but the CTs including the appellant were not treated like those of Sr.CTs & PSTs, hence illegal and is liable to be declared null and void on this score alone.
- b) That the act of the respondent No. 5 is the clear & vivid violation of Section 17, sub-section 3 & 4 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 and cannot be held lawful and in consonance with the prevailing rules devised for the very

purpose of preparation of same batch civil servants seniority list, therefore, cancellation of the impugned herein seniority list of CTs District Bajuar is direly required for the dispensation of justice and equality.

- c) That the appellant have been treated discriminately when they were refused to give seniority on the basis of age amongst same batch members which rules of seniority were considered for all PSTs & Sr.CTs of District Bajuar therefore, contrary to the Constitution of the Islamic Republic of Pakistan 1973, which safeguards the citizens of the state from discrimination. That is why the impugned seniority list dated 02/04/2020 is squarely unconstitutional and has been intended to usurp the rights of the appellant.
- d) That in order to protect the precious rights of the present appellant, this very appeal is being filed by impugning the seniority list dated 02/04/2020 which is in its very essence untenable in the eye of law and contradictory to the existing rules on the subject.
- e) That in the impugned seniority list observance of 25% Open Merit Quota & 75% Departmental promotion has also not been followed in light of the notifications issued by the respondents No. 2 & 3 and hence such act of respondent No. 5 is the utter disregard of rules & The Constitution.
- f) That the as per the requirements of law, advance copies of the instant appeal have been sent to the respondents via registered mail and receipts have been annexed with the instant appeal.

g) That further grounds will be agitated at the time of arguments with prior permission of this hon'ble Tribunal.

In light of the above submissions, it is, therefore, humbly prayed that on the acceptance of instant appeal, the seniority list of CTs District Bajuar dated 02/04/2020 issued by the respondent No. 5 may be declared null & void and by cancelling the same, the respondents may be directed to prepare the seniority list in light of the provisions of section 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 as prepared and maintained in the year 2017 and 2019. Any other relief which though specifically has not been prayed for but for which the appellants are otherwise entitled may also be granted, please.




1. They would be on probation for a period of one year, extendible for another one year.

SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 READ WITH ALL ENABLING PROVISIONS OF LAW AS AMENDED FROM TIME TO TIME, AGAINST THE SENIORITY LIST OF MALE CERTIFIED TEACHERS (CTs) OF DISTRICT BAJUAR ISSUED ON 02/04/2020 BY THE RESPONDENT NO. 5.

**PRAYER:**

ON THE ACCEPTANCE OF INSTANT SERVICE APPEAL, BY DECLARING THE SENIORITY LIST OF CTs DATED 02/04/2020 ISSUED BY RESPONDENT NO. 5 AS ILLEGAL & AGIANST THE EXISTING LAW, THE RESPONDENTS MAY PLEASE BE DIRECTED TO PREPARE THE SENIORITY LIST ON THE BASIS OF AGE AS MAINTAINED IN THE YEAR 2017 & 2019. ANY OTHER RELIEF WHICH THOUGH HAS NOT BEEN SPECIFICALLY PRAYED FOR BUT FOR WHICH THE APPELLANTS ARE OTHERWISE ENTITLED, MAY ALSO BE GRANTED PLEASE.

*Respectfully Sheweth:*

Brief facts giving rise to the instant appeal are as under:

- 1) That the appellants were appointed to the post of CT vide appointment order bearing Endst: No. 4887-92/Estab.Dated Khar the 19/04/2013 by the Agency Education Officer, District Bajaur. Copy of the appointment order is annexed herewith as "Annexure A".

- 2) That later on in the year 2017, a final seniority list of male CTs working in the Agency Education Department was prepared on the basis of age and on the strength of that very seniority list about 70 CTs (BPS-15) were promoted to Sr.CTs (BPS-16) vide Notification bearing Endst: No. 7689-7772/promotion/CT/Male dated 22/02/2017. Copy of the seniority list of 2017 and Notification regarding promotion are annexed herewith as "**Annexure B & C**" respectively.
- 3) That, similarly in the year 2019 vide Notification bearing Endst: No. 4888-93 dated 06/05/2019 promotion was given to various teachers from CTs/SCTs to SSTs on the strength of a seniority list of male CTs which was prepared on the basis of age and subject as per law & prevailing rules. Copy of the seniority list and Notification regarding promotion are annexed herewith as "**Annexure D & E**" respectively.
- 4) That likewise in the year 2019 another notification regarding promotion of SCTs/CTs was issued vide Endst: No. 5321-50 dated 29/03/2019 in which too seniority of the CTs/SCTs were maintained on the basis of age and subject with the further observance of 25% quota for open merit and 75% quota for ~~Departmental~~<sup>Departmental</sup> promotion merit. Copy of the ibid Notification is annexed herewith as "**Annexure F**".
- 5) That contrary to the above procedure existing/prevaling laws for the preparation of seniority list, the respondent No. 5 has now prepared and issued seniority list on 02/04/2020 about the CTs in District Bajuar not on the basis of age but on the basis of score / points which badly disturbed the seniority of the appellants alongwith many other CTs so committed violation of rules and procedure. Copy of the

impugned herein seniority list dated 02/04/2020 is annexed herewith as “Annexure G”.

- 6) That being aggrieved from the *ibid* seniority list dated 02/04/2020, the appellants requested repeatedly through *whatsapp* number given in the impugned herein seniority list for the correction of the seniority list to the respondent No. 5 but in vain therefore, the appellants then submitted written applications / objections on the impugned seniority list and until filing of the instant appeal no decision / reply was given to the appellants.
- 7) That having so dishearten and dissatisfied, the appellants then preferred departmental appeal/representation dated 21/04/2020 to the respondent No. 3 for the restoration of their age wise seniority but that too fell on deep ears. Copy of the departmental representation is annexed herewith as “Annexure H”.
- 8) That having no other adequate remedy and to entertain the constitutional right to appeal, the appellants prefers the instant appeal before this Hon’ble Tribunal for the restoration of their *inter se* age wise seniority *inter alia* on the following grounds/reasons with so many others:

**GROUND:**

- a) That the respondent No. 5 has committed violation of Article 10A of the constitution of the Islamic Republic of Pakistan, 1973 which guarantees that all the citizens of the state are to be treated alike and with equality *exempli gratia* seniority lists for the cadre of Sr. CTs and that of PSTs were prepared and both were issued on 07/04/220 in which age wise seniority was given to each individual



but the CTs including the appellants were not treated like those of Sr.CTs & PSTs, hence illegal and is liable to be declared null and void on this score alone.

- b) That the act of the respondent No. 5 is the clear & vivid violation of Section 17, sub-section 3 & 4 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 and cannot be held lawful and in consonance with the prevailing rules devised for the very purpose of preparation of same batch civil servants seniority list, therefore, cancellation of the impugned herein seniority list of CTs District Bajuar is direly required for the dispensation of justice and equality.
- c) That the appellants have been treated discriminately when they were refused to give seniority on the basis of age amongst same batch members which rules of seniority were considered for all PSTs & Sr.CTs of District Bajuar therefore, contrary to the Constitution of the Islamic Republic of Pakistan 1973, which safeguards the citizens of the state from discrimination. That is why the impugned seniority list dated 02/04/2020 is squarely unconstitutional and has been intended to usurp the rights of the appellants.
- d) That in order to protect the precious rights of the present appellants, this very appeal is being filed by impugning the seniority list dated 02/04/2020 which is in its very essence untenable in the eye of law and contradictory to the existing rules on the subject.
- e) That in the impugned seniority list observance of 25% Open Merit Quota & 75% *Departmental promotion* Quota has



also not been followed in light of the notifications issued by the respondents No. 2 & 3 and hence such act of respondent No. 5 is the utter disregard of rules & The Constitution.

- f) That the as per the requirements of law, advance copies of the instant appeal have been sent to the respondents via registered mail and receipts have been annexed with the instant appeal.
- g) That further grounds will be agitated at the time of arguments with prior permission of this hon'ble Tribunal.

In light of the above submissions, it is, therefore, humbly prayed that on the acceptance of instant appeal, the seniority list of CTs District Bajuar dated 02/04/2020 issued by the respondent No. 5 may be declared null & void and by cancelling the same, the respondents may be directed to prepare the seniority list in light of the provisions of section 17 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989 as prepared and maintained in the year 2017 and 2019. Any other relief which though specifically has not been prayed for but for which the appellants are otherwise entitled may also be granted, please.


