ORDER

WMAR ATA BANDIAL, CJ- The Petitioner filed a Revision Petition against the departmental appellate order dated 01.11.2016 before the Regional Police Officer (RPO), Mardan. This remedy of revision provided under Rule 11(A) of the Police Rules, 1975 is competent if availed within 30 days of the impugned order. There is no power with the Revisional Authority to grant condonation of delay in filing such a revision petition. The Revisional Authority decided the Petitioner's revision petition vide order dated 08.05.2017. The learned Service Tribunal took note of the fact that the revision petition filed by the Petitioner was delayed and, therefore, time barred. Consequently, it held that the Petitioner's service appeal was not maintainable.

The learned counsel submits that since his revision petition was dismissed on merits, therefore, the delay, if any, in filing the same stood condoned. The submission by the learned counsel ignores the fact that the Revisional Authority is not competent to condone the delay in the filing of a revision petition before it. Therefore, the consideration of the Petitioner's case on merits is of no consequence. On the other hand, if the matter is examined from the point of view that the appellate order dated 01.11.2016 is under challenge before the Tribunal, then even such challenge is also time barred. Accordingly, in both respects, the Petitioner's case before the Tribunal was rightly dismissed. This petition is, accordingly, dismissed and leave refused.
