Counsel for the appellant present. Preliminary arguments heard and case file perused. The appellant was appointed as CT (BPS-9) now upgraded in (BPS-16). That later on a corrigendum dated 30.10.1993 was issued by the respondent whereby the appellant was posted at GHSS Khawrai Noshwera. The appellant submitted his charge report and started performing duty on the concerned station. Thereafter, the appellant was transferred from Nowshera to GHS Masho Gagar, Peshawar vide order dated 25.05.2011. That after transfer from District Nowshera to District Peshawar till date the seniority of the appellant has not been maintained; neither in District Nowshera nor in District Peshawar. His name is not mentioned in the final seniority list dated 31.10.2014. Feeling aggrieved, the appellant filed departmental appeal on 19.09.2019 which has not been responded within the statutory period of ninety days, hence the instant service appeal. Learned counsel for the appellant further contended that maintaining seniority of a cadre/service is mandatory under Section-8 of Khyber Pakhtunkhwa Civil Servants Act, 1973 and Rule-17 of Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules 1989. As such the inaction of the respondents by not maintaining/enlisting the seniority of the appellant in the seniority list prepared for the cadre of C.T of District Peshawar is against the law, facts and norms of natural justice.

Points urged need consideration. Service appeal is admitted subject to all legal objections. Appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 02.09.2020 before S.B.
