



Counsel for the appellant Aman Khan present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant was serving as Senior Primary School Teacher in Education Department. It was further contended that he alongwith others Senior Primary School Teachers/Primary School Head Teachers were promoted to the posts of Certified Teachers (C.Ts) BPS-15 vide order dated 26.08.2017 on the basis of government notification mentioned in the promotion order. It was further contended that the official respondents had appointed private respondents as Certified Teachers on the basis of NTS examination in the year 2014. It was further contended that the official respondents issued seniority list dated 26.10.2019 of Certified Teachers belonging to District Dir Lower wherein the name of the appellant has not been mentioned although as per under section-4 of Regularization Act 2017, the respondent-department was required to place the name of the promotee/appellant senior to those who were appointed on the basis of NTS examination, therefore, feeling aggrieved, the appellant filed departmental appeal on 30.10.2019 but the same was not responded hence, the present service appeal. It was further contended that the respondent-department was bound to rectify the aforesaid seniority list of Certified Teachers belonging to District Dir Lower as per section-4 of the Regularization Act 2007.

The contention raised by learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to limitation and all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 30.03.2020 before S.B. Learned counsel for the appellant also submitted application for restraining the official respondents from further promotion of the private respondents. Notice of the same be also issued to the respondents for the date fixed.



**APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE FINAL SENIORITY LIST OF CERTIFIED TEACHERS (BPS-15) CIRCULATED ON 26.10.2019 WHEREBY THE NAME OF THE APPELLANT HAS NOT BEEN INCLUDED AND THE PRIVATE RESPONDENTS HAVE BEEN ALLOWED/GRANTED SENIORITY FROM THE DATE OF ADHOC/CONTRACTUAL APPOINTMENT I.E. 30.4.2014 IN UTTER VIOLATION LAW & RULES AND AGAINST NOT TAKING ACTION ON THE DEPARTMENTAL APPEAL OF THE APPELLANT ON NO GOOD GROUNDS WITH IN THE STIPULATED PERIOD OF NINETY DAYS**

**PRAYER:**

**That on acceptance of this appeal the impugned seniority list circulated on 26.10.2019 may kindly be modified/rectified to the extent of enlisting the name of the appellant at the right position and also to the extent of private respondents by allowing them seniority from the date of regularization on the post of certified teacher (BPS-15) and not w.e.f. the date of initial contractual/adhoc appointment i.e. w.e.f. 7.3.2018 instead of 30.4.2014. Any other remedy which this august Tribunal deems fit that may also be awarded in favor of the appellant.**

**R/SHEWETH:**

**ON FACTS:**

- 1-** That appellant was initially appointed as PST (BPS-7) now BPS-12 in the respondents Department vide order dated 13.11.2006. Copy of the appointment order is attached as annexure ..... **A.**
- 2-** That During service the appellant was promoted to the post of SPST (BPS-14) on regular basis and on the recommendation of the Departmental promotion committee vide order dated 09-11-2016, and to the post of CT (BPS 15) vide order dated 26-08-2017, Consequently the appellant submitted his charge report and started his duty as CT teacher quite efficiently and up to the entire satisfaction of my superiors. Copy of the promotion order is attached as annexure ..... **B.**
- 3-** That recently the District Education Officer (M), Dir Lower i.e. respondent No.3 circulated final seniority list of certified teachers of Dir lower whereby the name of the appellant has totally been ignored while those NTS teachers who have been appointed as adhoc/contract C.T in BPS-15 in the year 2014 and were regularized vide office order dated 7.3.2018 have been allowed seniority in the cadre of C.T (BPS-15) from the date of initial contractual/Adhoc appointment i.e. w.e.f. 30.4.2014. Copies of the impugned seniority list and regularization order of the private respondents are attached as annexure ..... **C and D.**
- 4-** That feeling aggrieved the appellant and his colleagues visited the office of the respondent No.3 and in response the respondent No.3 seeks guidance from the respondent No.2 vide letter dated 23.10.2019 but of no avail. Copy of the letter is attached as annexure ..... **E.**

- 5- That feeling aggrieved the appellant filed Departmental appeal before the respondent No.2 but no response has been received from the concerned quarter. Copy of the Departmental appeal is attached as annexure ..... F.
- 6- That, feeling aggrieved from the inaction of the respondent by not rectifying/Correcting the impugned seniority listed dated 26.10.2019 and having no other adequate remedy prefer the instant appeal on the following grounds amongst the others.

**GROUND:**

- A- That the impugned seniority list circulated on 26.10.2019 issued by the respondents is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be modified/ rectified.
- B- That the appellant has not been treated by the respondent Department in accordance with law and rules and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the treatment meted out to the appellant is discriminatory in nature.
- D- That the impugned seniority list dated 26.10.2019 has been issued by the respondents in arbitrary and malafide manner, therefore not tenable and liable to be modified.
- E- That according to Law and Rules seniority shall always be reckoned from the date of first regular appointment but in this case seniority has been granted/allowed to the private respondents from the date of contractual appointment which is illegal and against the prevailing rules.
- F- That the said seniority list is violative of section-8 of the Civil servant Act, 1973 as well as appointment, promotion and transfer Rules 1989, hence not tenable and liable to be modified/rectified.
- G- That, the act of the respondent is against the dictum enshrined in Article 38 (e) of the Constitution of Islamic Republic of Pakistan, that to "*reduce disparity in the income and earning of the individual including persons in different classes in the service of Pakistan*".

H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.



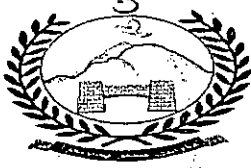



Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturers, Instructors & Doctors) Regulatory Act, 2011, and such rules and regulations as may be issued from time to time by the government.
2. Their pay shall be released subject to verification of academic documents/testimonials from the concerned Board/University by the District Education Officer Concerned.
3. Their services shall be considered regular and they shall be eligible for pension/deduction of GP fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.
4. Their services are liable to termination on one month prior notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government treasure.
5. They shall possess the same qualification and experience required for a regular post.
6. They shall have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground before commencement of this ACT. The DDO concerned should ensure this condition before the drawal of their pay as regular servants.
7. Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.
8. They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this ACT are to be appointed to the cadre, irrespective of their actual date of appointment.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in the case of two or more employees is the same, the employees older in age shall rank senior to the younger one.
10. Errors and omissions will be acceptable within the specified period.
