





APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE INACTION OF RESPONDENTS OF NOT PROMOTING THE APPELLANT AS SENIOR CERTIFIED TEACHER (BPS-16) FOR WHICH DEPARTMENTAL APPEAL OF THE APPELLANT HAS NOT BEEN RESPONDED SO FAR DESPITE THE LAPSE OF MORE THAN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:-

On acceptance of this appeal the respondents may kindly be directed to promote the appellant as Senior Certified Teacher (BPS-16) with effect from 11-11-2019 with consequential service benefits.

Respectfully Submitted:-

1. That the appellant is highly qualified, having passed her Master Degree besides Bachelor of Education and Master of Education.

2. That appellant was initially appointed as PTC on 24-11-2004 who performed her duties and continued her service till the posts of Certified Teachers were advertised by the respondents and appellant being perfectly fit and eligible and coming up to the criteria also applied for the same through proper channel. **(Copy of Appointment Order is enclosed as Annexure A).**
3. That the appellant after due process was called for interview and finally upon the approval and recommendations of Departmental Selection Committee was appointed as Certified Teachers (BPS-15) herein after referred to as CT vide Appointment Order dated 19-04-2013 in Tehsil wise merit and all the appellant accordingly took the charge of the post. **(Copy of Appointment Order dated 19-04-2013 is enclosed as Annexure B).**
4. That the name of the appellant was also placed in the General Seniority List of Females Senior Certified Teachers and Certified Teachers as evident from the Seniority List of the year 2017 maintained of SCTs and CTs of Merged District Bajaur. **(Copy of Seniority List of SCTs and CTs 2017 is enclosed as Annexure C).**
5. That accordingly promotions from time to time were made from the Seniority List maintained by the respondents, and in the year 2018 eight Female Certified Teachers (BPS-15) were promoted as Senior Certified Teachers (BPS-16) from the said Seniority List vide Notification dated 31-05-2018. **(Copy of Notification dated 31-05-2018 is enclosed as Annexure D).**
6. That in the year 2019 there were thirteen posts for promotion as Senior Certified Teachers (BPS-16), appellant being perfectly fit, Senior and eligible and coming up to the criteria was eligible and hopeful for promotion as Senior Certified Teacher (BPS-16) and accordingly respondent No 1 displayed proposed list of teachers of various cadres including the appellant for her promotion as Senior Certified Teachers (BPS-16) in the first week of November 2019 wherein it was mentioned that the

Departmental Promotion Committee meeting will be held on 11-11-2019. **(Copy of proposed list is enclosed as Annexure E).**

7. That appellant was thus hopeful of her promotion however for reasons best known to respondent No 1, the displayed list was changed and the names of the appellant was removed from the list, which list was even not displayed, where upon the appellant filed Civil suit in the Court of Civil Judge-III Bajaur and respondents were restrained from making illegal promotions, however finally the plaint of the appellant was rejected under Order-7 Rule-11 CPC vide Order dated 03-12-2019.
8. That in the meanwhile appellant filed departmental appeal against not including her name in the Departmental Promotion Committee meeting going to be held for making promotions of the CTs. to SCTs. and also requested for including her name for consideration for promotion as Senior Certified Teacher (BPS-16) in the forthcoming meeting of Departmental Promotion Committee but of no fruit till date despite the lapse of statutory period of ninety days. The appellant along with two others also approached the Peshawar High Court Peshawar by filing Writ Petition No 7355/2019 which was dismissed for want of jurisdiction. **(Copy of Departmental Appeal is enclosed as Annexure F).**
9. That this action of the respondents of not promoting the appellant as Senior Certified Teacher (BPS-16) from due date, is against the law, facts and principles of justice on grounds inter-alia as follows:

GROUND:

- A. That the omission and commissions of the respondents are illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Tribunal.

- B.** That the appellant is senior, perfectly fit and eligible and coming up to the criteria have got every right to be promoted as Senior Certified Teacher (BPS-16) from due date i,e 11-11-2019.
- C.** That seniority cum fitness is the sole criteria for promotion according to which criteria and formula the appellant as per the Seniority List is entitled for promotion as Senior Certified Teacher (BPS-16) from due date.
- D.** That respondents for making promotion to 13 vacant posts of Senior Certified Teachers (BPS-16) first displayed the proposed list for Departmental Promotion Committee, wherein the appellant was placed at her relevant positions and as per her seniority while on the following day changed the list for no legal reason.
- E.** That in the year 2018 and even before, promotions have been made from the seniority list while respondents for reasons other than fair and bonafide are not ready to act as per law and rules.
- F.** That thirteen posts of Senior Certified Teacher (BPS-16) are lying vacant and appellant being perfectly fit, senior and eligible has got every right to be promoted against the post of Senior Certified Teacher (BPS-16).
- G.** That the appellant is discriminated and treated unequally in violation of the constitution of the land as even in past promotions were made accordingly while in case of the appellant respondents are not ready to shoulder their responsibility.

H. That the fundamental rights of the appellant guaranteed in the Constitution are badly violated and she is not treated as per law and rules governing the matter.

I. That the appellant seeks the permission of this honorable Court for further/additional grounds at the time of arguments.

It is therefore prayed that Appeal, of the appellant may kindly be accepted, as prayed for.

Any other relief not specifically asked for and deemed appropriate in the circumstances of the case, may also be granted in favor of the appellant.

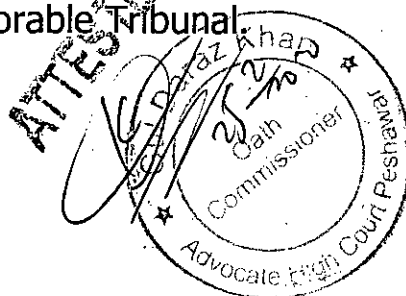

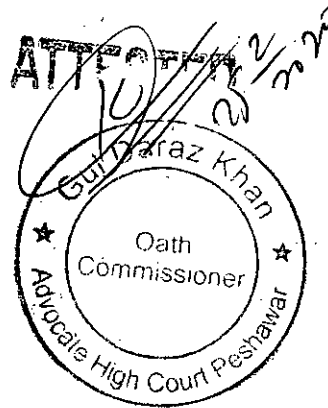

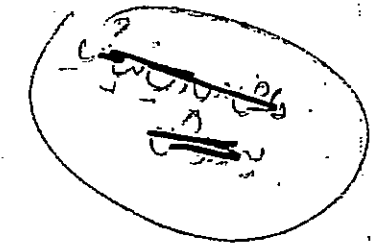
