Respectfully Sheweth:

The brief facts necessitating this Appeal are submitted as under:-

- 1. That appellant is law abiding citizen of Pakistan and permanent bonafide resident of Sub-Division Hassan Khel, Tehsil and District Peshawar.
- 2. That initially appellant was appointed as Librarian (BPS-17) in Directorate of Archives and Libraries, on 15 May, 2013. (Copy of Appointment Order is attached as Annexure "A").
- 3. That the appellant has been performing his duty to the entire satisfaction of his superiors and no complaint whatsoever has ever been made against him from any quarter.
- 4. That one Mr. Ali Rehman (Respondent No. 4) college cadre librarian whose posting was under the directorate of director colleges and was transferred to the post of librarian under the Directorate of Higher Education Department. (Copy of the impugned order dated 13.09.2019 is attached as Annexure "B").
- 5. That the appellant submitted departmental appeal/representation to the Chief Secretary but the same has not been responded so for. (Copy of the Appeal is attached as annexure "C").
- 6. That the appellant now prefers this appeal for the following amongst other grounds;-

GROUNDS:

- A. That the impugned transfer order is a flagrant violation of **transfer & posting policy** under the same department and therefore the same is not maintainable.
- B. That the impugned order has been passed under undue rather undesirable political influence which clearly militates against the fundamental right of the appellant.

C. That the impugned order is against the Notification dated 13.12.2019 of Respondent No. 2. (Copy of Notification dated 13.12.2019 is attached as Annexure "D"), and thus it is prima facie based on malafide.

- D. That one Mr. Ali Rehman (Respondent No. 4) college cadre librarian whose posting was under the directorate of director colleges and was transferred to the post of librarian under the Directorate of Higher Education Department. It is pertinent to mention here that even the seniority of appellant department and respondent No. 4 department are maintained by their respective departments. (Copies of the Seniority List of Liberian of Directorate of Archives & Libraries Department and Seniority List of Librarian of Higher Education Department are attached as Annexure "E" & "F").
- E. That even otherwise under the Service Rules, respondent No. 4 does not qualify for the post as Librarian in Rehman Baba Public Library Peshawar because Respondent No. 4 is the employee of Higher Education Department while Appellant is the employee of Directorate of Archives & Libraries Department and thus on this score alone, the impugned order dated 13.09.2019 is liable to be set aside. (Copies of the Service Rules are attached as annexure "G" & "H").
- F. That the appellant has been clearly discriminated as he belong to Public Library Cadre whereas he has been substituted by a person from the College Library Cadre.
- G. That the appellant has been treated unequally before the law and thus he has been deprived of equal protection of law.
- H. That the transfer order of the appellant speaks volume for violation of public policy & good governance motivated by political favoritism & nepotisms which are disapproved by rule of law.
- I. That the impugned order is void ab-initio and illegal as the same has

been passed in utter violation of the law and policy and rules of the Higher Education, Archives and Libraries.

- J. That the impugned order has no legal footing to stand upon as the same has been passed in utter disregard of the posting transfer policy of the Higher Education Department.
- K. That the impugned transfer order is prima facie discriminatory as the appellant is performing his duties with zeal and zest and no complaint whatsoever has been made against him and hence he has been treated unequally and in violation of Articles 4 and 25 of the Constitution.

It is, therefore, prayed that by accepting this appeal the impugned order of respondent No.2, dated 13.9.2019 may please be declared as illegal, unlawful, motivated by political influence and thus ineffective upon the right of the appellant and consequently appellant may be allowed to perform his duty as Librarian (BPS-17) Rehman Baba Public Library, Peshawar.

In this regard, the services of Mr. Ali Rahman, Librarian, GDC, Banda Dawood Shah, Karak, was placed at the disposal of this Directorate vide HED notification No. SO(C-IV)HE/placement Committee/2018 dated 07-05-2018, whereof, he was temporarily adjusted against the post of Librarian in Public Library, Kohat on stop gap basis, however, the was again transferred from Public Library, Kohat to Rahman Baba Public Library, Peshawar with subsequent replacement/transfer of Mr. Fazle Amin, Librarian, from Peshawar to Kohat vide HED notification No. SO(C-IV)/1-1/Vol-II/Ali Rehman/1058-64 dated 13-09-2019. Copies attached.

1t is pertinent to mention that Mr. Fazle Amin, Librarian belonging to FR Peshawar complied with his transfer order to Kohat despite having genuine reservations over his transfer/replacement by an outsider Librarian of Directorate of Higher Education(colleges) who has been temporarily adjusted in this Directorate.
