JUDGMENT

AHMAD SULTAN TAREEN, CHAIRMAN:- The appellant through the service appeal described in the heading has invoked the jurisdiction of this Tribunal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 with the prayer as copied below:-

"On acceptance of the appeal, the impugned termination Order No. 7394-99/MS/DHQ(H) dated 25.10.2018 and 25.07.2019 may graciously be set aside and appellant may kindly be reinstated in service with all back benefits by restoring

appointment order dated 03.06.2019."



- Briefly stated, the facts of the appeal are that the appellant was 2. appointed as Tube Well Operator in DHQ Hospital Haripur in the year 2009. His services were terminated by M.S DHQ Hospital Haripur vide order No. 7394-99/MS/DHQ (H) dated 25.10.2018. On appeal to the higher authority i.e. Director General Health Services Khyber Pakhtunkhwa Peshawar, he was reinstated into service vide order dated 7734-36 dated 03.06.2019 on acceptance of appeal by the appellate authority. For unknown reasons, the reinstatement order dated 03.06.2019 was withdrawn and termination order dated 25.10.2018 was restored vide letter No. 9102-5 dated 25.07.2019. The appellant purported to have submitted an application in the office of Director General Health vide Diary No. 8474 dated 16.03.2020 mentioning therein that the appellant is hanging and reinstatement of the appellant was not made practically. Subsequently, he filed departmental appeal before the respondent No. 2 and having received no response, the present service appeal has been preferred. The appellant submits that the impugned termination order dated 25.10.2018 and subsequent order dated 25.07.2019 are illegal, unlawful, without justification and against the law and facts. He prayed for acceptance of his appeal.
- 3. After admission of appeal notice was given to the respondents. As the notices were served upon the respondents for reply as per office note, the appeal was fixed before S.B on 25.01.2022. According to order sheet of said date, adjournment was sought by learned AAG which was granted requiring him to take the respondents on board to furnish reply/comments on or before the next date positively, failing which their right for reply/comments would be deemed as struck off. On the next date i.e. 31.01.2022, the written reply/comments were not submitted; therefore,



right for reply of the respondents was struck off and the case was fixed for arguments on 01.02.2022. On the next date, none was present on behalf of the appellant. Notice was issued to the appellant and his counsel for arguments on 08.02.2022 before the D.B. However, the appellant turned up on 02.02.2022 and submitted application for early hearing and the same was allowed. After reflecting the case in hearing list for 02.02.202, the arguments have been heard and record has been perused.

According to the copy of order dated 25.10.2018 as annexed with 4. memorandum of appeal, the appellant was proceeded against under E&D Rules, 2011 for multiple charges including misconduct, in-efficiency, absenteeism and of disobedience among others. Consequently, he was dismissed from service. However, according to office order bearing No. 7734-36/Personnel dated 03.06.2019 of the Director General Health Services, the order dated 25.10.2018 was withdrawn and the appellant was reinstated in service with immediate effect. On copy of order dated 03.06.2019 as annexed with the appeal, there is a hand-written note under signature and stamp of Director Administration, Director General Health the Medical Khyber Pakhtunkhwa Peshawar marked to Superintendent DHQ Hospital, Haripur which speaks about discussion over phone for extending a single chance to the appellant and if he does it again, he shall be automatically terminated from his job. According to the application for mercy received in office of Director General Health Services vide Diary No. 8474 PR dated 16.03.2020 and discussed in the memorandum of appeal, it appears that the appellant was not given duty in pursuance to the reinstatement order passed by Director General Health Services on acceptance of his appeal.

Needless to say that the appointing authority subject to law is 5. empowered to proceed against a subordinate government servant under E&D Rules, if any ground for such action is made out as per satisfaction of said authority. The original dismissal order dated 25.10.2018 states that an enquiry was conducted and the court of enquiry recommended major penalty against the appellant who was then served with show cause notice and personal hearing was also afforded to him. If it is presumed that the original impugned order was passed in due compliance with the procedure provided under Khyber Pakhtunkhwa Government Servants E&D Rules, 2011, the same stood withdrawn by the higher authority i.e. Director General Health Services vide his order bearing endorsement No. 7734-36/Personnel dated 03.06.2019. The hand written note on the said order as discussed above gives a clue that the Medical Superintendent was not ready to comply with the order of the Director General Health Services. The subsequent withdrawal of the order of reinstatement and restoration of the original dismissal order is devoid of reason. Once the appellant was reinstated into service on withdrawal of the dismissal order dated 25.10.2018, the respondents were required to proceed against him having regards to requirements of E&D Rules, if there was any delinquency on his part. However, the order bearing endorsement No. 9102-05/Personnel dated 25.07.2019 did not mention as to what had made it expedient to withdraw the reinstatement order. Thus, the appellant has not been dealt with in accordance with law. The order dated 25.07.2019 is not tenable and liable to be set aside.

6. For what has gone above, the appeal in hand is accepted. The impugned order dated 25.07.2019 is set aside and in consequence of its

setting aside, the order dated 03.06.2019 stands restored. In consequence of restoration of order dated 03.06.2019, the original order dated 25.10.2018 having been withdrawn by the order dated 03.06.2019 is of no legal effect. The appellant shall be deemed to have been reinstated into service under the order dated 03.06.2019. The admissibility of back benefits in pursuance to order dated 03.06.2019 is left for the determination by departmental authorities. Parties are left to bear their own costs. File be consigned to the record room.

Counsel for the appellant present. Preliminary arguments have been heard.

As argued by the learned counsel for the appellant, the appellant was serving as Tube well Operator at DHQ Hospital Haripur is aggrieved of the impugned order dated 25.10.2018 whereby he was awarded major penalty of dismissal from service. The appellant submitted departmental appeal against the impugned order on 05.11.2018. It was considered and the impugned order was withdrawn on 03.06.2019. However, his reinstatement order was withdrawn and he was once again dismissed on 25.07.2019 without any reason or enquiry. No reason was given for the illegal and illogical second time dismissal. The appellant again submitted departmental appeal on 10.03.2021 which was not decided and the appellant therefore, approached the Service Tribunal on 05.07.2021. It was vehemently argued that the impugned orders dated 25.10.2018 and 25.07.2019 are illegal, unlawful, without lawful authority, without jurisdiction and being against the law, facts and circumstances are liable to be set aside and the appellant reinstated in service with all back benefits.

The appeal is admitted to regular hearing subject to all just legal objections including limitation. The appellant is directed to deposit security and process fee within 10 days. Thereafter notices be issued to respondents for submission of reply/comments. To come up for reply/comments on 08:02.2022 before S.B.

Copy of termination order is annexed as **Annexure "A".**
- 2. That appellant approached to the office of Respondent No.2 Director General Health Department KPK Peshawar and submitted departmental appeal vide diary No. 3348 dated 05.11.2018. Copy of appeal is annexed as <u>Annexure "B".</u>
- 3. That appeal of the appellant was accepted and services of the appellant was reinstated vide order No. 7734-36 dated 03.06.2019. Copy of reinstatement order is annexed as Annexure "C".
- 4. That due to some unknown reasons once again the reinstatement order dated 03.06.2019 was withdrawn and the termination order dated 25.10.2018 was restored vide letter No. 9102-5 dated 25.07.2019. Copy of letter is annexed as **Annexure "D".**
- 5. That the appellant submitted an application in the office of DG Health vide diary No.8474 dated 16.03.2020 mentioning

therein mentioning therein that the appellant is hanging and reinstatement of the appellant has not been made practically. Copy of application is annexed as **Annexure**"E".

6. That the appellant filed departmental appeal before the respondent No.2 Director General Health KPK Peshawar on 10.03.2021 but no positive response receive to appellant from the end of respondent No.2. Copy of departmental appeal is annexed as **Annexure "F".**

GROUNDS OF APPEAL:-



That the impugned termination Office Order No. 7394-99/ MS/DHQ(H) dated 25.10.2018 and 25.07.2019 are illegal, unlawful, without lawful authority, without jurisdiction, against the law, facts and circumstances of the case, discriminatory and ineffective upon the rights of the petitioner especially against the rule of locus potentia. Hence, liable to be set-aside.

- b. That the petitioner has been appointed as Tubw
 Well Operator being eligible because after proper
 scrutiny of the documents of petitioner.
- c. That valuable rights of the appellant is involved in the matter.





It is, therefore, humbly prayed that the appellant may also be reinstated and order of termination/removal from service may kindly be set aside in the best interest of justice.




