AMENDED SERVICE APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL 1974 AGAINST THE ORDER DATED 18.12.2014, WHEREBY THE APPELLANT REMOVED FROM SERVICE, AGAINST WHICH DEPARTMENTAL APPEAL WAS FILED. WHICH WAS NOT DECIDED EVEN MANDATORY PERIOD HAS BEEN EXPIRED.

Respectfully Sheweth:-

- 1. That the Appellant is peaceful and law abiding citizen of Pakistan and belongs to respectable family and entitled for all the legal and fundamental rights guaranteed under the constitution of Islamic Republic of Pakistan.
- 2. That the Appellant belongs to the merged area district Khyber and before promulgation of the 25th amendment of the Constitution the said area was fall in FATA and before merger of FATA the forefather of the Appellant offered the land for establishment of School and the competent authority appointed the Appellant on the post of Mali on dated 10.09.1995. (Copy of the Appointment Order and medical Report is attached as annexure A)

- 3. That since his appointment the Appellant performing his duty with great zeal and zest and no complaint whatsoever has been filed against the Appellant before the competent Authority.
- 4. That in the year 2014 the Appellant left the country for medical treatment and submitted Application to the Competent Authority for Ex-Pakistan Leave but without decision of the said Application, the Appellant proceeded Abroad for medical purpose. (Copy of the Medical history is attached as annexure B)
- 5. That the Respondent No 3 without deciding the Application of the Appellant, inquiry proceedings had been initiated against the Appellant and lastly the impugned order in respect of removal from service on dated 18.12.2014 has been issued. (Copy of the Inquiry proceedings and impugned Order are attached as annexure C)
- 6. That after the return of the Appellant from Abroad, he got the knowledge of removal from service, the Appellant submitted Application to the Respondent No 3 for issuance obtaining of impugned order and also filed Application for re-instatement into service, which Application was communicated to the Respondent No 1 & 2 for onward decision, but no avail. (Copy of the reinstatement Application is attached as annexure D)
- 7. That the Appellant submitted a proper Departmental Appeal after getting the impugned order to the Respondent No 1 & 2 and the Respondent No 1 & 2 are bound to decide the Departmental Appeal of the Appellant, however the Appellant was informed by the Respondent No 1 & 2 that the Appeal of the Appellant is kept pending. (Copy of the Departmental Appeal along with better Copy is attached as annexure E)
- 8. That the Respondents No 1 & 2 being the competent authority and it is the duty of the Respondents No 1 & 2 to decide the Departmental Appeal of the Appellant, but the Respondents are reluctant to decide the same without any cogent reasons.
- **9.** That thereafter the Appellant approaches the Hon'ble Peshawar High Court Peshawar in Writ Petition No.

3023-P/2022, in which the Hon'ble Peshawar High Court Peshawar issued direction to Approach this Hon'ble Tribunal vide Order and Judgment dated 25.08.2022. (Copy of Writ Petition and Order dated 25.08.2022 is attached as annexure F)

10. That the Appellant feeling aggrieved, now having no other adequate remedy but to approach this Hon'ble Court, inter alia on the following grounds:

GROUNDS:-

- A) That the Appellant is peaceful and law abiding citizen of Islamic Republic of Pakistan and is fully entitled to all the basic and fundamental rights as enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.
- B) That the fundamental right of the Appellant has blatantly violated by the Respondents and the Appellant have been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- C) That the acts of the Respondents of not following the same criteria which has been safeguarded by the law and rules and guidelines provided by the apex courts that when the serving on respective employee post competent authority is not allowed to removed the employee with malafide intention or for ulterior motives, while in the present case the respondents neither only violated the prescribed rules and regulations but also harassed the Appellant which can easily be gathered from the face of order, which is illegal, unlawful, unnatural, ab-initio, null and voidin the eye of law, hence liable to be declared so.

- E) That the respondents No. 1 & 2 violated the fundamental rights of the Appellant enshrined under the article 4 and 10 of the constitutional of Pakistan.
- F) That it is the bounded duty of the Competent Authority to issue speaking order, the public functionaries are bound to decide the cases of their subordinates after Application of mind with cogent reasons with reasonable time and according to the section 24-A of the Act 1897, however in the present case Respondent No 1 & 2 violated the prescribed procedure of Law and Rules.
- G) That according to the Article 4 & 5 every citizen has inalienable right to be treated in accordance with law as envisaged by Article 4 of the Constitution, the public functionaries are obliged to act within the four corners of mandate of constitution and law, even Chief Executive of the Country is not above the constitution and is bound to obey, command of constitution as envisaged under Article 5 of the Constitution.
- H) That any other ground not raised here specifically may graciously be allowed to be raised at the time of arguments.

It is therefore, most humbly prayed that "On acceptance of the instant Appeal, the Impugned Order dated 18.12.2014, whereby the Appellant was removed from service may kindly be set aside and the Appellant

may graciously be reinstated to his respective post with all back benefits"

Any other relief not specifically asked for may also graciously extended in favour of the Appellant s in the circumstances of the case.



WRIT PETITION UNDER ARTICLE 199, OF CONSTITUTION OF THE ISLAMIC REPUBLIC OF PAKISTAN, 1973.

Respectfully Sheweth:-

- That the Petitioner is peaceful and law abiding citizen of Pakistan and belongs to respectable family and entitled for all the legal and fundamental rights guaranteed under the constitution of Islamic Republic of Pakistan.
- 2. That the Petitioner belongs to the merged area district Khyber and before promulgation of the 25th amendment of the Constitution the said area was fall in FATA and before merger of FATA the forefather of the Petitioner offered the land for establishment of School and the competent authority appointed the Petitioner on the post of Mali on dated 10.09.1995. (Copy of the Appointment Order and medical Report is attached as annexure A)
- 3. That since his appointment the Petitioner performing his duty with great zeal and zest and no complaint whatsoever has been filed against the Petitioner before the competent Authority.

- 4. That in the year 2014 the Petitioner left the country for medical treatment and submitted Application to the Competent Authority for Ex-Pakistan Leave but without decision of the said Application, the Petitioner proceeded Abroad for medical purpose. (Copy of the Medical history is attached as annexure B)
- 5. That the Respondent No 3 without deciding the Application of the Petitioner, inquiry proceedings had been initiated against the Petitioner and lastly the impugned order in respect of removal from service on dated 18.12.2014 has been issued (Copy of the Inquiry proceedings and impugned Order are attached as annexure C)
- 6. That after the return of the Petitioner from Abroad, he got the knowledge of removal from service, the Petitioner submitted Application to the Respondent No 3 for issuance obtaining of impugned order and also filed Application for re-instatement into service, which Application was communicated to the Respondent No 1 & 2 for onward decision, but no avail. Copy of the reinstatement Application is attached as annexure Di
- 7. That the Petitioner submitted a proper Departmental Appeal after getting the impugned order to the Respondent No 1 & 2 and the Respondent No 1 & 2 are bound to decide the Departmental Appeal of the Petitioner, however the Petitioner was informed by the Respondent No 1 & 2 that the Appeal of the Petitioner is kept pending. (Copy of the Departmental Appeal along with better Copy is attached as appeared.
- 8. That the Respondents No 1 & 2 being the competent authority and it is the duty of the Respondents No 1 & 2 to decide the Departmental Appeal of the Petitioner, but the Respondents are reluctant to decide the same without any cogent reasons.
- That the Petitioner feeling aggrieved, having no other adequate remedy but to approach this Houble Court, inter alia on the following grounds:





GROUNDS:-

- A) That the Petitioner is peaceful and law abiding citizen of Islamic Republic of Pakistan and is fully entitled to all the basic and Pandamental rights as enshrined in the fundamental law of the state, interpreted and guaranteed by the law of the land.
- B) That the fundamental right of the Appellant has blatantly violated by the Respondents and the Appellant have been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- C) That the acts of the Respondents of not following the same criteria which has been safeguarded by the law and rules and guidelines provided by the apex courts that when the employee serving on respective post the competent authority is not allowed to removed the employee with malafide intention or for ulterior motives, while in the present case the respondents neither only violated the prescribed rules and regulations but also narassed the Petitioner which can easily be gathered from the face of order, which is illegal, unlawful, unnatural, ab-initio, null and voidin the eye of law, hence liable to be declared so.
- D) That it is well settled Law and consistent view of the August Superior Courts that whenever any major punishment the procedure provided under the E&D rules 2011 must be followed and without proper inquiry no order in respect of Civil Servant is sustainable in the eyes of law.
- E) That the respondents No. 1 & 2 violated the fundamental rights of the Petitioner enshrined under the article 4 and 10 of the constitutional of Pakistan.



- F) That it is the bounded duty of the Competent Authority to issue speaking order, the public functionaries are bound to decide the cases of their subordinates after Application of mind with cogent reasons with reasonable time and according to the section 24-A of the Act 1897, however in the present case Respondent No 1 & 2 violated the prescribed procedure of Law and Rules.
- G) That according to the Article 4 & 5 every citizen has inalienable right to be treated in accordance with law as envisaged by Article 4 of the Constitution, the public functionaries are obliged to act within the four corners of mandate of constitution and law, even Chief Executive of the Country is not above the constitution and is bound to obey, command of constitution as envisaged under Article 5 of the Constitution.
- H) That any other ground not raised here specifically may graciously be allowed to be raised at the time of arguments.

It is therefore, most humbly prayed that on acceptance of the instant Writ petition the impugned Order may kindly be declared illegal, void ab initio and in effective upon the rights of the Petitioner.

Furthermore the Respondent No 1 & 2 are bound to decide the Appeal of the Petitioner within the four corners of law and the act of the Respondent No 1 & 2, whereby the Petitioner has been informed that the Appeal of the Retitioner is kept pending without any cogent reasons is illegal,

unlawful, without lawful authority and they may be directed to decide the same in accordance with law.

Any other relief not specifically asked for may also graciously extended in favour of the Petitioners in the circumstances of the case.

Interim Relief:

By way of Interim Relief, the Respondents may be directed to decide the Appeal of the Petitioner, till the final disposal of the instant Writ Petition
