
JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that

the appellant was appointed as Village Secretary in the Local Government Department vide order dated 18-02-2019. The appellant joined his duty after fulfillment of all pre-requisite. In the meanwhile the appellant received notices dated 10-06-2019 & 22-06-2019 reminding the appellant that you were appointed on officiating/acting basis, which may be seriously kept in mind with further warning that the instant letter may be considered as final notice. Feeling aggrieved, the appellant filed departmental appeal dated 19-07-2019, which was rejected on 19-12-2019, hence the instant service appeal instituted on 17-01-2020 with prayers that the impugned notices may be set aside, the appellant may be considered as


regularly appointed civil servant, may be treated as per law regarding his probation period and his salaries may be released since September, 2019.

2. Learned counsel for the appellant has contended that the appellant was appointed against a regular post of Village Secretary on the recommendations of Departmental Selection Committee; that the appellant has gone through the process of medical fitness, police verification, where-after he submitted arrival report and his service book was also prepared and that his appointment is also against the regular post, therefore, the respondents are wrong in treating him appointed on officiating/temporary basis; that personal number is issued only to regular employees against a regular post, which was also issued to the appellant by District Account Office Charsadda and the appellant drawn his salaries through District Account Office Charsadda like any other civil servants, which clearly shows that the appellant was a civil servant and was appointed against the regular post; that the appointment order dated 18-02-2019 in respect of the appellant was deliberately phrased in a manner with malafide intension, so as to dispense with his services at any time as per the whims and wishes of the respondents; that the appointment letter shows that the appellant was appointed as officiating/acting Village Secretary, whereas Rule-3 of KP (appointment, promotion & transfer) Rules, 1989 provides for method of appointment with no mention of officiating or acting charge in initial appointment; that rule-9 of the rules ibid provides for acting charge appointment for in-service employees, who is appointed against a higher grade on acting charge, whereas in initial appointment there is no concept of acting charge appointment. The learned counsel added that the appellant performed his duty with zeal and enthusiasm, but malafide of the respondents surfaced when the appellant received the first notice, rather a warning dated 10-06-2019, wherein no reason was mentioned for dispensing with service of the appellant; that the 2nd Notice Dated 22-06-2019 again reminded the appellant that he was appointed on officiating/acting charge and was also on probation, therefore, he may be terminated any time without assigning any reason, against which the appellant filed departmental appeal on 19-07-2019, which was rejected on 19-12-2019 without any plausible reason; that salary of the appellant was stopped from the month of September, 2019, but sufficient documentary proof is available on the record, which shows that the appellant performed his official duty even after issuing of the alleged relieving order; that it was upon submission of comments of the respondents in the instant appeal that it was divulged by the respondents that the appellant has been relieved from officiating/temporary duty vide order dated

20-09-2020, which however was not served upon the appellant nor was it implemented as the appellant performed active duty till June, 2020, which is evident from the record available on file; that the letter dated 20-09-2019 was issued in back date with the malafide intension to make the appeal in-fructuous; that as is evident from a number of the bank cheques signed on 01-10-2019 by the appellant as a co-signatory with the Nazim UC, as well as his signatures on birth/death/marriage certificates as well other such documents showing the appellant present on his job; that another evidence to show the relieving order as fake is that departmental appeal of the appellant was rejected on 19-12-2019, which means that the appellant was still serving with the respondents, otherwise they could have informed the appellant that you are no more on job; that although one of similarly placed officials had filed a writ petition No 6365-P/2019, which was dismissed in *limine*, however the case of the appellant is quite distinguished from the case of the said employee as the appellant performed official duty for a considerable period even after issuing of the alleged relieving order; that the relieving order of the appellant surfaced for the first time during the proceedings in the instant appeal, therefore, the same was challenged in the rejoinder filed by the appellant and this Tribunal has got ample powers to set-aside the reliving order also through the principle of molding of relief. Reliance was placed on 1995 SCMR 435, 2012 CLC 360, PD 1995 Supreme Court 406, 1995 SCMR 1748, 2010 SCMR 984, 2020 MLD 562, 2016 MLD 1453, 2016 YLR 233, 2009 YLR 1265, 2000 CLC 1559, 1999 MLD 3156, PLD 1989 Karachi 404, 2011 SCMR 80, 2006 SCMR 688 and PLD 1978 Supreme Court 220.

3. Learned counsel appearing on behalf of respondents has contended that the appellant was appointed on officiating/temporary basis without fulfillment of legal requirements, which should have been advertised through ETEA but in the instant case, the post has not been advertised, whereas the appellant has been appointed purely on temporary basis as is evident from Para-3 & 6 of the appointment order, hence his appointment order purely made on temporary basis was ultimately withdrawn; that the appointment order was made in violation of KP Civil Servant (appointment, promotion & transfer) Rules, 1989, therefore the same was cancelled/withdrawn; that submission of medical fitness certificate, police clearance certificate and arrival report could not regularize the illegal and temporary appointment order; that it is correct that service book of the appellant was prepared and salaries were released, but the same was not found according to rule, therefore appointment order being illegal has been withdrawn; that post of the

village secretary is a regular post, but the appellant was illegally appointed without observing legal requirements; that notices were issued to the appellant before withdrawal of the appointment order; that there is no original/appellate order to be challenged by the appellant hence under section-4 of the service tribunal Act, the instant case is not maintainable; that similarly placed employee had filed writ petition No. 6365-P/2019, which was dismissed in *limine* and case of the appellant is similar in nature to that case, hence is liable to be dismissed.

4. We have heard learned counsel for the parties and have perused the record.

5. A perusal of the record would show that the instant appeal was filed by the appellant, challenging the impugned notices dated 10.06.2019 & 22.06.2019, however upon submission of reply/comments by the respondents, it divulged that the appellant has been removed from service vide relieving order dated 20.09.2019. Learned counsel for the appellant has vehemently contended that the aforementioned relieving order was issued in back date, which was never served upon the appellant and has been challenged in the rejoinder and the same can also be annulled by this Tribunal through invoking the principle of molding. We have carefully considered the submission so put forth by learned counsel for the appellant, however we are of the view that after issuance of the relieving order dated 20.09.2019, the appellant was legally required to have filed a departmental appeal challenging the said order. In this scenario, the appeal in hand has become infructuous, however keeping in view the fact and circumstances of the case and in order to shorten the litigation, the instant service appeal of the appellant as well as his rejoinder are treated as departmental appeal and the same are sent to the appellate Authority for passing an appropriate order on it strictly in accordance with law within a period of one month of the receipt of copy of this judgment. In case the appellant is aggrieved of the outcome of the decision of the appellate Authority, he may seek his remedy by making recourse to the Tribunal. Parties are left to bear their own costs. File be consigned to the record room.

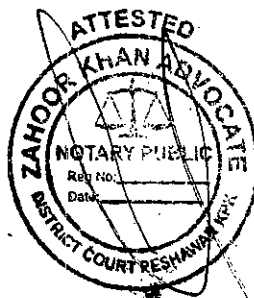



- B. Incorrect. Submission of Medical Certificate, Police Clearance Certificate and arrival could not regularize the illegal & temporary appointment of the appellant.
- C. Correct to the extent that service book of the appellant was prepared and the salaries were released but the same was not found according to rules therefore, appointment order being illegal has been withdrawn. (Annexure-C)
- D. Incorrect: Performing of duties efficiently by the appellant are denied as appointment of the appellant was not according to Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion and Transfer rules, 1989), therefore, a notice has been issued prior to withdrawal/cancellation of appointment order of the appellant. (Annexure-D)
- E. Incorrect: The appointment order of the appellant was withdrawn under para 3 & 6 of terms & conditions mentioned in the appointment order moreover, notices were also issued to the appellant. (Annexure-E)

Appellant's Reply to the Parawise Comments of Respondent NO. 1, 2 & 3 on Facts.

A. Reply of Respondents to Para A contains incorrect, twisted and misleading allegations, hence denied. The appointment of the Appellant, for all practical and legal purposes, was a regular initial appointment vide order dated: 18-02-2019 (already annexed with Appeal as Annexure: A). Because, it was on recommendation of **'Departmental Selection Committee'** and against a **'Regular'** post. The **'Regular'** status of the post has been admitted by Respondents in Reply to Para H of 'Grounds'. The Appellant is 'qualified for the appointment'; vide KP Gov't Gazette, Extra Ordinary, Dated: 12th June 2019 [Copy attached]. He received his monthly salaries after due preparation of his 'Service Book', as admitted by Respondents in Reply to Para C of Grounds. The appointment was on a 'permanently sanctioned' post and his salary was paid from the 'sanctioned regular budget', with concurrence of Distt: Account Officer (DAO). The Appellant's arrival was duly accepted, he was posted and he occupied the post which was 'vacant' at that time and even subsequently many posts of Junior Village Council/ Neighborhood Council (VC/NC) Secretaries were vacant as per updated list of vacant posts submitted by Respondent No. 3, to Respondent No. 2, vide letter No: AD/ LG&RDD/CHD/ 1837-39 dated 25-09-2020. All the legal requirements have been duly complied with at the part of the Appellant. The Appellant is not liable or answerable for any alleged deviation or laps at the part of Respondents. The appellant having been so appointed, the appointing Authority cannot be allowed to take benefit of its own lapses to terminate his service. This principle based on natural justice, was applied in the case of "Director Social Welfare NWFP ...Vs...Sadullah Khan", reported in 1996- SCMR- at page 1350 and many other judgments, is squarely attracted in the instant case. The Respondents had no power to bypass the law and Principles of Natural Justice to relieve the Appellant from the job.

Furthermore, it is also essential in the interest of justice to highlight the following important aspects of the case:

- I. That the so called withdrawal order regarding the Appellant's appointment order and the alleged Notices (other than the impugned notices dated: 10-06-2019 & dated: 22-06-2019) have never ever been served upon the Appellant nor the Appellant was stopped to work on the post of Village Secretary, Matta Rustam Khel-II, Tehsil Shabqaddar, even after 20-09-2020. For the first time the so-called withdrawal/relieving order dated: 20-09-2019 came in the knowledge of the Appellant through the Reply/ Farawise Comments of the Respondents, which is illegal, un-served on Appellant, an afterthought, un-implemented, void '*ab-initio*', without lawful authority, in contravention of law as well as Principles of Natural Justice and in effective over the rights of the Appellant.

ATIQU-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that the appellant was appointed as Village Secretary in the Local Government Department vide order dated 18-02-2019. The appellant joined his duty after fulfillment of all pre-requisite. In the meanwhile the appellant received notices dated 10-06-2019 & 22-06-2019 reminding the appellant that you were appointed on officiating/acting basis, which may be seriously kept in mind with further warning that the instant letter may be considered as final notice. Feeling aggrieved, the appellant filed departmental appeal dated 19-07-2019, which was rejected on 19-12-2019, hence the instant service appeal instituted on 17-01-2020 with prayers that the impugned notices may be set aside, the appellant may be considered as

regularly appointed civil servant, may be treated as per law regarding his probation period and his salaries may be released since September, 2019.

2. Learned counsel for the appellant has contended that the appellant was appointed against a regular post of Village Secretary on the recommendations of Departmental Selection Committee; that the appellant has gone through the process of medical fitness, police verification, where-after he submitted arrival report and his service book was also prepared and that his appointment is also against the regular post, therefore, the respondents are wrong in treating him appointed on officiating/temporary basis; that personal number is issued only to regular employees against a regular post, which was also issued to the appellant by District Account Office Charsadda and the appellant drawn his salaries through District Account Office Charsadda like any other civil servants, which clearly shows that the appellant was a civil servant and was appointed against the regular post; that the appointment order dated 18-02-2019 in respect of the appellant was deliberately phrased in a manner with malafide intension, so as to dispense with his services at any time as per the whims and wishes of the respondents; that the appointment letter shows that the appellant was appointed as officiating/acting Village Secretary, whereas Rule-3 of KP (appointment, promotion & transfer) Rules, 1989 provides for method of appointment with no mention of officiating or acting charge in initial appointment; that rule-9 of the rules ibid provides for acting charge appointment for in-service employees, who is appointed against a higher grade on acting charge, whereas in initial appointment there is no concept of acting charge appointment. The learned counsel added that the appellant performed his duty with zeal and enthusiasm, but malafide of the respondents surfaced when the appellant received the first notice, rather a warning dated 10-06-2019, wherein no reason was mentioned for dispensing with service of the appellant; that the 2nd Notice Dated 22-06-2019 again reminded the appellant that he was appointed on officiating/acting charge and was also on probation, therefore, he may be terminated any time without assigning any reason, against which the appellant filed departmental appeal on 19-07-2019, which was rejected on 19-12-2019 without any plausible reason; that salary of the appellant was stopped from the month of September, 2019, but sufficient documentary proof is available on the record, which shows that the appellant performed his official duty even after issuing of the alleged relieving order; that it was upon submission of comments of the respondents in the instant appeal that it was divulged by the respondents that the appellant has been relieved from officiating/temporary duty vide order dated

20-09-2020, which however was not served upon the appellant nor was it implemented as the appellant performed active duty till June, 2020, which is evident from the record available on file; that the letter dated 20-09-2019 was issued in back date with the malafide intension to make the appeal in-fructuous; that as is evident from a number of the bank cheques signed on 01-10-2019 by the appellant as a co-signatory with the Nazim UC, as well as his signatures on birth/death/marriage certificates as well other such documents showing the appellant present on his job; that another evidence to show the relieving order as fake is that departmental appeal of the appellant was rejected on 19-12-2019, which means that the appellant was still serving with the respondents, otherwise they could have informed the appellant that you are no more on job; that although one of similarly placed officials had filed a writ petition No 6365-P/2019, which was dismissed in *limine*, however the case of the appellant is quite distinguished from the case of the said employee as the appellant performed official duty for a considerable period even after issuing of the alleged relieving order; that the relieving order of the appellant surfaced for the first time during the proceedings in the instant appeal, therefore, the same was challenged in the rejoinder filed by the appellant and this Tribunal has got ample powers to set-aside the reliving order also through the principle of molding of relief. Reliance was placed on 1995 SCMR 435, 2012 CLC 360, PD 1995 Supreme Court 406, 1995 SCMR 1748, 2010 SCMR 984, 2020 MLD 562, 2016 MLD 1453, 2016 YLR 233, 2009 YLR 1265, 2000 CLC 1559, 1999 MLD 3156, PLD 1989 Karachi 404, 2011 SCMR 80, 2006 SCMR 688 and PLD 1978 Supreme Court 220.

3. Learned counsel appearing on behalf of respondents has contended that the appellant was appointed on officiating/temporary basis without fulfillment of legal requirements, which should have been advertised through ETEA but in the instant case, the post has not been advertised, whereas the appellant has been appointed purely on temporary basis as is evident from Para-3 & 6 of the appointment order, hence his appointment order purely made on temporary basis was ultimately withdrawn; that the appointment order was made in violation of KP Civil Servant (appointment, promotion & transfer) Rules, 1989, therefore the same was cancelled/withdrawn; that submission of medical fitness certificate, police clearance certificate and arrival report could not regularize the illegal and temporary appointment order; that it is correct that service book of the appellant was prepared and salaries were released, but the same was not found according to rule, therefore appointment order being illegal has been withdrawn; that post of the

village secretary is a regular post, but the appellant was illegally appointed without observing legal requirements; that notices were issued to the appellant before withdrawal of the appointment order; that there is no original/appellate order to be challenged by the appellant hence under section-4 of the service tribunal Act, the instant case is not maintainable; that similarly placed employee had filed writ petition No. 6365-P/2019, which was dismissed in *limine* and case of the appellant is similar in nature to that case, hence is liable to be dismissed.

4. We have heard learned counsel for the parties and have perused the record.

5. A perusal of the record would show that the instant appeal was filed by the appellant, challenging the impugned notices dated 10.06.2019 & 22.06.2019, however upon submission of reply/comments by the respondents, it divulged that the appellant has been removed from service vide relieving order dated 20.09.2019. Learned counsel for the appellant has vehemently contended that the aforementioned relieving order was issued in back date, which was never served upon the appellant and has been challenged in the rejoinder and the same can also be annulled by this Tribunal through invoking the principle of molding. We have carefully considered the submission so put forth by learned counsel for the appellant, however we are of the view that after issuance of the relieving order dated 20.09.2019, the appellant was legally required to have filed a departmental appeal challenging the said order. In this scenario, the appeal in hand has become infructuous, however keeping in view the fact and circumstances of the case and in order to shorten the litigation, the instant service appeal of the appellant as well as his rejoinder are treated as departmental appeal and the same are sent to the appellate Authority for passing an appropriate order on it strictly in accordance with law within a period of one month of the receipt of copy of this judgment. In case the appellant is aggrieved of the outcome of the decision of the appellate Authority, he may seek his remedy by making recourse to the Tribunal. Parties are left to bear their own costs. File be consigned to the record room.


