

**On acceptance of this appeal, the  
respondents may kindly be directed to grant  
Proforma promotion in BPS-18 to the  
appellant with effect from the date of her  
eligibility with all back benefits.**

**Respectfully Sheweth:**

**Brief Facts:-**

1. That appellant was serving in the Health Department as Nursing Superintendent, in Women and Children Hospital Rajjar Charsadda and got retired on attaining superannuation.
2. That during the employment the Department asked for the production of relevant documents in order to consider the appellant for promotion from BPS-17 to BPS-18.
3. That respondents delayed the matter on different pretext, and despite appellant name on the top of the seniority list, have not issued the promotion order to the appellant after retirement of appellant the department issued promotion notification & promoted Junior to the appellant in BPS-18.
4. That appellant filed departmental appeal but the same is not considered by the respondent. **(Copy of Departmental Appeal is annexed as Annexure "A")**.
5. That appellant is entitled for promotion and back benefits as per law from 11.07.2017 when she got entitled for promotion hence aggrieved from the

promotion order on the following amongst other grounds:-

**GRUNDS:**

- A. *That the act and omission of respondents by not promoting the appellant is against the law & facts and they have not treated the appellant in accordance with law.*
- B. *That the appellant being on top of the seniority list and fulfilled the requisite criteria for promotion to the next grade but respondents deliberately delayed the promotion & failed to consider the appellant for the same, which is violation of law.*
- C. *That the appellant has served the department with utmost satisfaction of the highups & got retired on attaining the age of superannuation, but despite the spotless career, the respondents violated the law & not promoted the appellant, and deprived her of her legal fundamental rights.*
- D. *That the respondents by not treating the appellant in accordance with law, have violated the law & constitution of Pakistan and the golden principle that all citizens are to be treated likely.*
- E. *That junior to the appellant were promoted & appellant is deprived from the benefits, hence this appeal.*

- F. That the respondents has also failed to decide the departmental appeal of the appellant, hence act & omission is against the law.
- G. That appellant may also be allowed to rely on additional grounds at the time of arguments please.

**Therefore, it is humbly submitted that On acceptance of the instant appeal, the respondents may kindly be directed to grant Proforma promotion in BPS-18 to the appellant with effect from the date of her eligibility i.e 11.07.2017 with all back benefits.**

**Any other relief which is not specifically asked may also be granted in favour of appellant.**

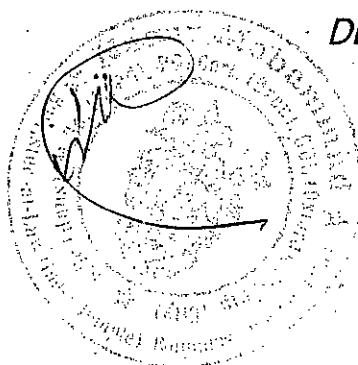



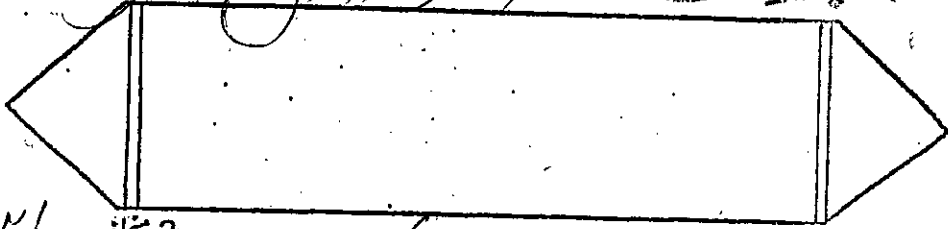
