

APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICES TRIBUNAL, ACT 1974 (KP ACT NO.1 OF 1974), R/W ALL ENABLING PROVISIONS OF LAW, GOVERNING THE SUBJECT, AGAINST THE IMPUGNED ACTION OF RESPONDENTS BY IGNORING THE DATE OF APPOINTMENT OF APPELLANT AT PAR WITH HIS OTHER COLLEAGUES WHICH WERE APPOINTED THROUGH ONE AND THE SAME ADVERTISEMENT DATED: 23.10.2012.

**RESPECTFULLY SHEWETH:**

1. That the appellant is law abiding peaceful citizen of Pakistan, domicile of supra address mentioned in the heading of appeal. (COPY OF NIC ALONG-WITH SERVICE CARD IS ATTACHED AS ANNEXURE "A").
2. That Respondent No.4, the then Agency Education Officer (FATA) issued numerous jobs advertisement on **23.10.2012** through Daily **MASHRIQ**, wherein, applications were invited from the eligible and suitable candidates of FR Bannu & FR Lakki, moreover, the office of Additional Education Officer was the same for both the FR's. (COPY OF ADVERTISEMENT DATED: **23.10.2012** IS ATTACHED AS ANNEXURE "B").
3. That the appellant was qualified and applied for the post of Theology Teacher "TT", successfully gone through the entire process of selection, the proper merit list of selectee was prepared by the respondents, moreover, his batch mates who belongs to FR Lakki now defunct, Bajaur and Orakzai were appointed through office orders dated: **22.04.2013, 24.05.2013 & 30.04.2013** endst No.1366-85 & 4365-70 , but the appointment of appellant was delayed by the respondents for illegal gain, however, he was appointed through office order dated: **21.09.2017** with almost delay of five years. (COPIES OF APPOINTMENT LETTER DATED: **21.09.2017** OF APPELLANT AND HIS OTHER BATCH MATE ORDERS DATED: **22.04.2013, 24.05.2013 & 30.04.2013** ARE ATTACHED AS ANNEXURE "C" "D" "E" & "F" RESPECTIVELY).
4. That appellant approached through proper channel to respondent No.4 Vide representation/departmental appeal dated: against the discriminatory treatment of respondent by not considering the appellant seniority at par with his other batch mates appointed through one and the same advertisement dated: **23.10.2012** the representation ibid is still pending before the competent authority. (COPY OF DEPARTMENTAL APPEAL DATED: **18.9.18** IS ATTACHED AS ANNEXURE "G").
5. That appellant approached through Writ Petition No. **91-B/2019**, which was decided on **16.11.2022** by the august Peshawar High Court Bannu Bench, Bannu. (COPIES OF WRIT PETITION NO. **91-B/2019** & JUDGMENT DATED: **16.11.2022** IS ATTACHED AS ANNEXURE "H" & "I" RESPECTIVELY).

6. That the appellant is having no other efficacious and alternative remedy, hence approaches this Hon'ble Tribunal inter alia on the following grounds

**GROUND**S

- A. That it is the constitutional vested rights of the appellant to be dealt in accordance with law.
- B. That the act of the respondents by ignoring the date of seniority of the appellant at par with his batch mates is illegal, unlawful, void-ab-initio and is disregard of law.
- C. That the appellant has been treated discriminatorily and his batch mates are senior to the appellant. However, advertisement, test, interviews & lists were originated by respondents on the same date.
- D. That the impugned orders have been issued in surmises and conjectures rather based on misreading and non-reading of the facts of the case hence, deserves to be set at naught. Furthermore, the respondents have no lawful authority to ignore the appellant without any justified reasons.
- E. That the respondent No.4 was initially issued the advertisement dated: **23.10.2012** through Daily **MASHRIQ** wherein, the application was invited from the eligible candidates of erstwhile FR Bannu, FR Lakki Marwat & Other districts, Meanwhile, the list of successful candidates was issued by the respondent No.4 of all both the districts, astonishingly the appointment of all the candidates belonging to erstwhile FR Lakki, Orakzai & Bajaur was made on.22.04.2013, 30.04.2013 & 24.05.2013, while the appointment of appellant was ignored/stopped without any cogent and plausible reason, meanwhile the appellant was appointed with the delay of almost five years, hence, the action of respondents is discriminatory in nature in the eye of law.
- F. That the appellant was deprived of his appointment as a teacher with his batch-mates, who were appointed through supra orders, as such the appointment of the appellant was delayed without plausible reasons, furthermore, the appellant is entitled to be allowed seniority with his colleagues in light of section 8 of the Khyber Pakhtunkhwá Civil Servants Act. 1973, however, the appellant having been appointed in a same



selection process as such his seniority is to be determined in accordance with the order of merit, assigned by the selection committee.

G. That any other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

It is therefore, most humbly prayed, that on the acceptance of instant appeal, the respondents may please be directed to reckon the seniority of appellant from the date of his other first batch colleagues appointed through one and the same advertisement dated: 23.10.2012 with all back benefits. So as to secure the ends of justice and equity


Any other relief not specifically prayed for and deemed appropriate to this Hon'ble Tribunal, may also be granted in favour of appellant.
