APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 FOR ADJUSTMENT AGAINST THE POST OF PST (BPS-12) AND FOR RELEASE OF SALARIES W.E. FROM THE DATE OF 1<sup>ST</sup> APPOINTMENT i.e. 15.01.2019 TILL DATE AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS

#### PRAYER:

That on acceptance of this appeal the respondent Department may very kindly be directed to adjust the appellant against the post of PST (BPS-12) and release the monthly salaries of the appellant w.e.f the date of 1<sup>st</sup> appointment i.e. 15.01.2019 till date with all other back benefits. Any other relief which this august Tribunal deems fit that may also be awarded in favor of the appellant.

#### R/SHEWETH: ON FACTS:

#### Brief facts of fact of the present appeal are as under:-

- 2. That unfortunately during service the appellant got an accident while riding Motor Cycle and got severe injuries due to which the appellant remained under treatment at the hospital. That due to such injuries the appellant was

- 3. That after recovery from the said injuries the appellant re-join his duty with full of his devotion and honesty and with all zeal and zest.
- 4. That it is pertinent to mention here that family of the appellant was involved in serious enmity and the enemies of the appellant were residing in the nearby area of the duty station of appellant. That due to such reason the appellant moved an application before the respondent No.2 alongwith documentary proofs (FIR's) before the competent authority for his transfer from GPS Nazar Wali, Lakki Marwat to GPS Syed Azam Baragi.
- 5. That the respondent No.4 despite knowing the fact refused the said application for transfer of the appellant but the appellant remained in duty at the concerned station despite of having the life threats. That it is also pertinent to mention here that the appellant was regularly performing his duty at the concerned station but the salary of the appellant had not been released by the authorities. Copies of the duty certificates are attached as annexure.
- 6. That the appellant time and again requested the authorities through written and verbal requests to release the monthly salaries of the appellant from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 but in vain. That appellant feeling aggrieved from the inaction of the authorities by not releasing the monthly salaries filed writ petition No. 921-B/2020 before the Peshawar High Court, Bannu Bench but the same was disposed of with the directions to approach the proper forum i.e. Service Tribunal vide judgment dated 12.10.2020. Copies of the applications, attendance register and judgment are attached as annexure.
- 7. That then after the appellant once again approached the departmental authority and made a request for release of his salary but the authorities had not been given any response on the same and finally due to the ill response of the authorities the appellant remain absent for sometime from his duty. That later on the appellant made several requests for his adjustment against the post of PST (BPS-12) and release of his salaries from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 till date but the authorities are not willing to do so.
- 8. That the appellant feeling aggrieved from the inaction of the respondents by not allowing him for joining of his duty and as such not releasing the monthly salaries of the appellant from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 preferred departmental appeal before the respondent No.1 but no reply has been received so far. Copy of the departmental appeal is attached as annexure.

9. That the appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

#### **GROUNDS:**

- A-That the inaction of the authority concerned by not allowing the appellant for rejoining of his duty and as such not releasing monthly salaries of the appellant is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the authority concerned in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the authority concerned acted in arbitrary and malafide manner by not releasing the monthly salaries of the appellant w.e.f. the date of 1<sup>st</sup> appointment till date and as such not allowing the appellant to re-join his duty.
- D- That the authority concerned violated the principle of natural justice by withholding salaries of the appellant without any lawful justification.
- E- That not releasing monthly salary of the appellant is violative of Article-11 of the Constitution of Islamic Republic of Pakistan, 1973.
- F- That no adverse order has been passed by the respondents against the appellant, therefore under the law the appellant is fully entitle to be adjusted against the post of PST (BPS-12).
- G- That till date the respondents kept the appellant in hanging position and as such the respondents No.2 is not willing to adjust the appellant on the post of PST (BPS-12).
- H- That valuable right of the appellant has been accrued, therefore under the prevailing rules the appellant is entitled to be adjusted on the post of PST with all back benefits.
- I- That the inaction of the respondent Department by not accepting the arrival report of the appellant against the post of PST (BPS-12) and not releasing the monthly salaries of the appellant is against the principle of natural justice.
- J- That the appellant seeks permission to advance other grounds at time of hearing.

It is, therefore, most humbly prayed that the appeal of appellant may be accepted as prayed for.



petitioner was appointed as PST by the respondent No.2. He

took the charge of the said post on 16.01.2019 at GPS Nazir Wali Lakki Marwat. Due to severe enmity in the village near the adjacent GPS Nazir Wali/ place of posting the petitioner could not continue his service in the said school and application respondent No.2 submitted adjustment/transfer in some other school which was not accorded. The petitioner again started teaching in the said school on 13.5.2019 after the lapse of three months and continued till date and moved an application to the respondent No.2 for release of his salary but the same was not allowed and the petitioner was served with final show cause notice by the respondent No.2. He was also served with another show cause notice for one day salary deduction bearing NO.1104 dated 08.6.2019. The petitioner again submitted an application for releasing of his pay which was duly recommended by the ADEO, but in vain. Hence the instant writ petition.

3. Arguments heard, record perused.

4. The petitioner being civil servant has filed the



instant writ petition for issuing directions to the respondents to release the salary/pay to the petitioner which relates to terms and condition of service. The jurisdiction of this Court is explicitly barred under Article 212 of the Constitution in service matters and the proper forum available for redressal of grievance of the petitioner would be the service Tribunal. Thus this petition being not maintainable stands dismissed in

#### RESPECTED SIR,

#### Brief facts of the case are as under:-

- 1. That the appellant was appointed as Primary Shool Teacher (BPS-12) vide order dated 15-01-2019 and after appointment the appellant took over the charge of the said post at GPS Nazar Wali District Lakki Marwat and started performing his duty quite efficiently and upto the entire satisfaction of his superiors.
- 2. That unfortunately during service the appellant got an accident while riding Motor Cycle and got severe injuries due to which the appellant remained under treatment at the hospital. That due to such injuries the appellant was unable to perform his duty.
- 3. That after recovery from the said injuries the appellant re-join his duty with full of his devotion and honesty and with all zeal and zest.
- 4. That it is pertinent to mention here that family of the appellant was involved in serious enmity and the enemies of the appellant were residing in the nearby area of the duty station of appellant. That due to such reason the appellant moved an application alongwith documentary proofs (FIR's) before the competent authority for his transfer from GPS Nazar Wali, Lakki Marwat to GPS Syed Azam Baragi. Copies of the FIR's & application are atteched.
- 5. That the authority concerned despite of knowing the fact refused the said application for transfer of the appellant but the appellant remained in duty at the concerned station despite of life threats. That it is also pertinent to mention here that the appellant was regularly performing his duty at the concerned station but the salary of the appellant had not been released by the authority concerned. Copies of the duty certificates are attached.
- 6. That the appellant time and again requested the authorities through written and verbal requests to release the monthly salaries of the appellant from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 but in vain. That appellant feeling aggrieved from the inaction of the authorities by not releasing the monthly



salaries filed writ petition No. 921-B/2020 before the Peshawar High Court, Bannu Bench but the same was disposed of with the directions to approach the proper forum i.e. Service Tribunal vide judgment dated 12.10.2020. Copy of the judgment is attached.

- 7. That then after the appellant once again approached the departmental authority and made a request for release of his salary but the authorities had not been given any response on the same and finally due to the ill response of the authority concerned the appellant remain absent for sometime from his duty. That later on the appellant submitted several applications for his adjustment against his post and release of his salaries from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 till date but the authorities are not willing to do so.
- 8. That the appellant feeling aggrieved from the inaction of the authority concerned by not allowing the appellant for joining of his duty and as such not releasing the monthly salaries of the appellant from the date of 1<sup>st</sup> appointment i.e. 15.01.2019 till date preferred the instant departmental appeal before your good self on the following grounds.

#### **GROUNDS:**

- A- That the inaction of the authority concerned by not allowing the appellant for rejoining of his duty and as such not releasing monthly salaries of the appellant is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be set aside.
- B- That the appellant has not been treated by the authority concerned in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the authority concerned acted in arbitrary and malafide manner by not releasing the monthly salaries of the appellant w.e.f. the date of 1<sup>st</sup> appointment till date and as such not allowing the appellant to re-join his duty.
- D- That the authority concerned violated the principle of natural justice by withholding salaries of the appellant without any lawful justification.
- E- That not releasing monthly salaries of the appellant is violative of Article-11 of the Constitution of Islamic Republic of Pakistan, 1973.





It is, therefore, most humbly prayed that on acceptance of this departmental appeal the authority concerned i.e. DEO (M) Lakki Marwat may very kindly be directed to adjust the appellant against the post of PST (BPS-12) and release the monthly salaries of the appellant w.e.f 15.01.2019 to till date. Any other relief which your good self deems fit that may also be awarded in favor of the appellant.
