

APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED FINAL SENIORITY LIST CIRCULATED BY THE RESPONDENTS IN THE YEAR- 2022 WHEREBY JUNIORS TO THE APPELLANT MARKED AS SENIOR BY PLACING NAME OF THE APPELLANT AT SERIAL NO. 121 INSTEAD OF SERIAL NO. 18 BELOW THE NAME OF MST: RAMIM BEGUM AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS.

PRAYER:

That on acceptance of this appeal the impugned final seniority list of 2022 may very kindly be rectified/corrected and the respondents please be directed to enlist the name of appellant on her correct seniority position i.e. at serial No.18 below the name of Mst: Ramim Begum and above the name of Mst: Nishat Begum instead of S.No. 121. Any other relief which this august Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Briefs facts of the present appeal are as under:-

- 1- That the appellant was initially inducted in the respondent Department as CT (BPS-09 now BPS-15) vide order dated 06.08.1995. That after appointment

the appellant started performing her duty at GGMS Sadiq Abad, Bajaur Agency quite efficiently and upto the entire satisfaction of her superiors. Copy of the appointment order is attached as annexure.....A.

2- That during service the appellant was transferred from Bajaur Agency to GGMS Nabi, Distric Swabi vide order dated 18.04.2003 and since then the appellant is performing her duty at District Swabi with all zeal and zest. Copy of the order dated 18.04.2003 is attached as annexure.....B.

3- That being senior most employee of the respondent department, the name of appellant was enlisted at Serial No. 31 below the name of Mst: Ramim Begum and above the name of Mst: Nishat Begum in the final seniority list circulated on 11.02.2019. Copy of the seniority list is attached as annexure.....C.

4- That later on it came into the knowledge of appellant that the seniority position from serial No.31 has been disturbed by the respondent Department and many junior colleagues have been marked senior to the appellant.

5- That appellant feeling aggrieved preferred departmental appeal followed by service appeal No.468/2022 before the Honorable Service Tribunal, Peshawar and during pendency of the service appeal the respondent department issued final seniority list of the year-2022 whereby name of the appellant has been enlisted at serial No. 121 instead of serial No.18 below the name of Mst; Ramim Begum and above the name Mst; Nishat Begum. Copy of the departmental appeal, seniority list and order sheet dated 31.10.2022 are attached as annexure.....D, E & F.

6- That appellant feeling aggrieved from the final seniority list of 2022 preferred departmental appeal before the appellate authority but no reply has been received so far. Copies of the departmental appeal is attached as annexure.....G.

7- That it is also pertinent to mention here that during pendency of the departmental appeal the respondent department issued letters dated 21.10.2022 whereby necessary documents have been called from the SCT's for further promotion on the basis of above mentioned disputed seniority list. Copies of the letters are attached as annexure.....H.

8- That the appellant feeling aggrieved and having no other remedy but to file the instant service appeal on the following grounds amongst the others.

GROUND:

- A- That the impugned final seniority list issued of 2022 is against the law, facts, norms of natural justice and materials on the record, hence not tenable and liable to be corrected.
- B- That the appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article-4 and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
- C- That the impugned seniority list of-2022 is violative of Section-8 of the Civil Servant Act, 1973 read with Rule-17 of the appointment, Promotion & Transfer Rules, 1989.
- D- That the respondent Department acted in arbitrary and malafide manner while issued the impugned final seniority list circulated in the year 2022 which is ineffective upon the rights of appellant, therefore not tenable and liable to be corrected.
- E- That the respondents discriminated the appellant amongst her colleagues by enlisting her name on incorrect position of the seniority list.
- F- That the respondents are knowing the fact that the appellant is the senior most employee of the respondent Department and have the position of enlisting her name below of one Mst. Ramim Begum and above the name of Mst: Nishat Begum but despite that they have issued the impugned final seniority list of 2022 by marking juniors to the appellant as senior, therefore, the same is not tenable in the eye of law and liable to be rectified/corrected.
- G- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is, therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.
