- 1. That the petitioner was appointed as ASI through KP Public Service Commission and was confirmed as ASI and brought his name in list "E" w.e.from 25.09.2006 along with his batchmates vide notification dated 01.01.2010. (Copy of notification dated 01.01.2010 is attached as Annexure-A)
- 2. That batchmates and juniors to the petitioner were confirmed in the rank of S.I w.e.f 14.03.2012 vide notification dated 10.09.2012, while the petitioner was not confirmed as SI in that notification and later on

confirmed in the rank of S.I with immediate effect vide notification dated 05.01.2017. (Copies of notification dated 10.09.2012 and notification dated 05.01.2017 are attached as Annexure-B&C)

- 3. That the name of batchmates and juniors to the petitioner were included in list "F" and also promoted to officiating Inspector vide notification dated 30.01.2013 and then confirmed in the rank of Inspector vide notification dated 19.10.2015 and were further promoted to the rank of DSP vide notification dated 29.11.2018, while the name of the petitioner was included in list "F" and also promoted the rank of officiating Inspector vide notification dated 22.10.2019 with immediate effect. (Copies of notification dated 30.01.2013, notification dated 19.10.2015, notification dated 29.11.2018 and notification dated 22.10.2019 are attached as Annexure-D,E,F&G)
- 4. That as the petitioner was not confirmed with his colleagues and juniors in the rank of S.I and included his name with in list "F" along with his batchmates colleagues and juniors and also not promoted him to the rank of Inspector and DSP, he filed service appeal No.271/2018 back dated promotion in order to bring the petitioner to the same status as colleagues are with the prayer to the treat and place the petitioner's seniority with colleagues of his batch 2006, in service with all back benefits. (Copy of memo of service appeal is attached as Annexure-H)
- 5. That service appeal of the petitioner was heard and decided on 22.06.2021 by the Honorable Tribunal in which the Honorable Tribunal observed that perusal of record reveal that the appellant was appointed/recruited as ASI upon the recommendation of KP Public Service Commission. He alongwith batchmates/colleagues was confirmed in the rank of ASI vide notification dated 01.01.2010 and his name was brought on promotion list "E" w.e.f 25.09.2026. Name of the appellant finds mention at Sr. No.4, whereas, his colleagues Joahr Shah, Abdur Rasheed and Khalid Khan have been placed at Sr. No.9,13 and 14 respectively. His above mentioned colleagues were confirmed in the rank of S.I w.e.f 14.03.2012 vide notification dated 10.09.2012, whereas, the appellant was confirmed in the rank of S.I with immediate effect vide notification dated 05.01.2017. The Honorable Tribunal accepted the appeal of the petitioner with the directions to the respondents to place the name of the petitioner in the confirmation list with his batchmates as Sub Inspector w.e.f 14.03.2012 when his colleagues were confirmed in the rank of S.I and

accordingly revise the seniority list with all consequential benefits. (Copy of judgment dated 22.06.2021 is attached as Annexure-I)

- 6. That as the respondent did not implement the judgment dated 22.06.2021 of this Honorable Tribunal, therefore the petitioner filed execution petition 147/2021 in this Honorable Tribunal for implementation of judgment dated 22.06.2021 and during the pendency of execution petition, the respondents provided the notification dated 18.02.2022, whereby the confirmation of the petitioner in the rank of SI was revised w.e.f 14.03.32012 instead of 05.01.2017 and provided another notification dated 03.03.2022, wherein the name of the petitioner was placed in the seniority list of inspector and sub inspector on list "F" as per his date of Sub Inspector i.e 14.03.2012 as stood on 07.09.2021. (Copies of notification dated 18.02.2022 and 03.02.2022 are attached as Annexure-J&K)
- 7. That the execution petition was fixed on 29.11.2022 and DPC for promotion of DSP was excepted to be held within few days and the petitioner informed the Honorable Tribunal about the DPC on which the Honorable Tribunal observed that the petitioner informed the Tribunal that DPC is excepted to be held within next 14 days and he may likely be promoted to the rank of DSP and then placed at his due place as per the terms of judgment, therefore, he does not press this petition for time being and requested that in case his grievances are not resolved in the forthcoming meeting of the DPC he may be allowed to re-agitate the matter and the execution petition was disposed of on the date fixed i.e 29.11.2022. 



JUDGMENT



ROZINA REHMAN, MEMBER (J): Facts gleaned out from the memorandum of appeal are that appellant was appointed as Assista Sub Inspector through Khyber Pakhtunkhwa Public Servic Commission on 20th October, 2006. He was promoted as Officiatin Sub Inspector and he performed the duties of an S.H.O in differe police stations. His batchmates were promoted but the appellant wo neither posted to complete his period of S.H.O ship nor was promoted.

with his batchmates despite repeated requests to his high-ups. Lastly, he was confirmed in the rank of S.I on 05.01.2017 and his name was placed on list "F" but with immediate effect. After confirmation, he filed departmental appeal but to no avail, hence the instant service appeal.

Learned counsel for appellant contended that the appellant was initially appointed as Assistant Sub Inspector on 20th October, 2006 and was confirmed in rank of A.S.I vide notification dated 01.01.2010. That in a D.P.C Meeting, other colleagues of the appellant were confirmed whereas the case of appellant was not considered. He submitted that the appellant was confirmed in the rank of S.I on 05.01.2017 but with immediate effect instead of confirming him from the date when his other colleagues were confirmed. Learned counsel further argued that appellant was treated in a discriminatory manner as some other Officiating Sub Inspectors who were deferred for want of deficiency, were confirmed with those colleagues who had been confirmed earlier. He submitted that there is nothing on file which could show any sort of bad entry on the record of the appellant and that he was never superseded. He submitted that in case of deferment for want of any deficiency, seniority is not affected and this is the legal right of the appellant to be confirmed from the date when his other colleagues were confirmed. He contended that such act of the respondents was discriminatory and against the law as the appellant was not treated in accordance with law and his rights guaranteed under the Constitution were badly violated. Reliance was

hitter Pakhtukhe Service Tribunsa Pexhavene placed on the judgments of this Tribunal in Service Appeal No. 79/2019; 407/2011; 1227/2013 and 197/2016, wherein, in similar nature cases, relief was granted by this Tribunal. He, therefore, requested for placing the name of the appellant in the confirmation list with his colleagues by ante dating his confirmation to meet the ends of justice with all back benefits.

- 3. Conversely, learned A.A.G submitted that the appellant was provided with several opportunities to show efficiency and good work in the discharge of his official duty as S.H.O but he failed to perform his duty up to the satisfaction of his seniors. He submitted hat he was suspended and was dealt with departmentally on account of inefficiency and misuse of official authority. He contended that confirmation in the rank of S.I is subject to qualifying the laid down criteria and the appellant on the fulfillment of said pre-requisite criteria, under Rule 13.10(2) was confirmed in the rank of S.I without any discrimination.

Name of the appellant finds mention at Serial No.4, whereas, his colleagues Johar Shah, Abdu Rasheed and Khalid Khan have been placed at Serial No.9, 13 and 14 respectively. rank of S.I w.e.f 14.03.2012 vide notification dated 10.09.2012, whereas, the appellant was confirmed in the rank of S.I with immediate effect vide notification dated 05.01.2017. There is nothing on file which could show that he was superseded rather he was not considered on the ground of not completing a period of one year as an Officiating Sub Inspector in independent charge of a Police Station in a district. The issue relating to confirmation of the appellant as Sub Inspector from the date when his colleagues were confirmed, holds ground as it was not within the authority of the appellant to post himself as an S.H.O of an independent Police Station. We did not find anything adverse on record except deferment to substantiate his confirmation on later date. It is established from the prevailing rules that civil servant selected for promotion to a higher past in one batch shall, on their promotion to the higher post, retain their inter-se seniority as in the lower post.

For the above-mentioned reasons, we are constrained to 5. accept the present appeal with directions to the respondents to place the name of appellant in the confirmation list with his batchmates as Sub Inspector w.e.f 14.03.2012 when his colleagues were confirmed in the rank of S.I and accordingly revise the seniority list with all consequential benefits. Parties are left to bear their own costs. File be consigned to the record room.

- That the petitioner has filed service appeal No.271/2018 for the back dated promotion in order to bring the petitioner to the same status as his colleagues are with the prayer that to treat and place the appellant's seniority instantly and designate his seniority with colleagues of his batch 2006, in service with all back benefits as his batchmates were confirmed as S.I on 14.03.2012, while the appellant was confirmed as S.I 05.01.2017.
- 2. The said appeal was finally heard by this Honourable Service Tribunal on 22.06.2021. The Honourable Service Tribunal was kind enough to accept the appeal with the direction to the respondents to place the name of the petitioner in confirmation list with his batchmates as Sub Inspector w.e.f 14.03.2012, when his colleagues were confirmed in the rank of S.I and accordingly revise the seniority list with all consequential benefits.
