



Learned counsel for the appellãnt contended that the appellãnt was initially appointed as C.T (BS-9) in District Kohistan, ^{vide} appointment order dated 04.07.2009. She was transferred/adjusted at GGMS Kariplian Haripur vide office order dated 28.02.2012. The respondent-department has issued promotion/adjustment order (06.01.2021) in respect of certain newly promoted senior CT and senior TT (Female) (BS-16) wherein private respondent No.4 appears at serial No.4 reflecting her appointment as regular C.T dated 04.3.2012. The appellãnt has challenged/assailed the said notification dated 06.01.2021 on the ground that private respondent No.4 is actually appointed as regular C.T in District Haripur on 28.02.2012, therefore the appellãnt is senior to private respondent No.4. The appellãnt preferred departmental appeal on 29.01.2021 which was not responded within the stipulated statutory period, hence the instant service appeal filed in the Service Tribunal on 27.04.2021. Learned counsel for the appellãnt was asked to produce seniority list of CT District Haripur on the basis of which the appellãnt claims her seniority. He expressed inability to have the same document and requested that the respondent-department would be in a better position to produce it. It, therefore, deems appropriate to issue pre-admission notice to the respondents to assist the Tribunal on the point. To come up for preliminary hearing on 13.01.2022 before S.B.

BENEFITS OF THE APPELLANT.**

PRAYER:-

On acceptance of the instant service appeal, the impugned order **Endst No. 8-529-33/CT-TT to Sr, Ct-Sr-TT/Promotion file** dated **06.01.2021** issued by **respondent No. 03**, may kindly be ordered to revised with direction to **respondent No. 03** to place the name of the appellant ahead of **respondent No. 04** being senior to her in terms of initial appointment, transfer and thereafter, appellant be considered for promotion and grant any other relief to which the appellant is legally found entitled in view of the facts and law on the subject.

Respectfully Sheweth:-

1. That, initially, appellant was appointed as CT in District Kohistan vide order No. **2412-17** on dated **04.07.2009** and thereafter appellant was transferred vide order No. **Endst 2891-95/F No. 51/V.III/PST/CT(F) Kohistan** on dated **28.02.2012** from District

Kohistan to District Haripur due to Spouse policy.

(Copy of appointment order and transfer order are annexed as annexure "A&B").

2. That, petitioner took over the charge in GGMS Kraplian on **01.03.2012**, thereafter submitted the charge report in the office of **respondent No. 03**.

(copy of charge report annexed as annexure "C").

3. That, respondent **No. 04** was fresh appointed against the **CT** post in Education department on **04.03.2012**.

4. That, **respondent No. 03**, required documents from all teachers for promotion cases, appellant also submitted the required documents for promotion.

5. That, thereafter **respondent No. 03** issued impugned order Endst No. 8-529-33/CT-TT to Sr, Ct-Sr-TT/Promotion file on dated **06.01.2021** whereas respondent No. 04 promoted from **CT (BPS-15)** to **Sr.CT (BPS-16)** in this regard the appellant become junior without any reason by means of the impugned promotion order affecting the service rights of the appellant.

(Copy of impugned order annexed as Annexure "D").

6. That, aggrieved from the impugned order, appellant filed a Departmental appeal with respondent **No. 02** on **29.01.2021**, which has not been responded so far.

(copy of Departmental appeal dated **29.01.2021** annexed as Annexure "E").

7. That, felling aggrieved from the impugned order dated **06.01.2021**, the appellant having no other remedy, files the present service appeal before this Honourable Tribunal for interference inter alia, on the following amongst other grounds.

GROUND:-

- A) That, under the law, rules and regulations on the subject, seniority is counted and determined on the strength of service. Appellant was initially appointed and transfer prior to the appointment of the respondent No. 04 against the same post. Appellant had been senior from respondent No. 04 for **06 days** in the entire record of the department but all of a sudden, respondent No. 03 without any prior notice to the appellant issued impugned order dated **06.01.2021**, whereby by respondent No. 04 made

senior to appellant and also promoted **CT to Sr.CT** for unknown reasons, violating the service rights of the appellant.

- B) That, when the appellant was transferred to Haripur no objection was raised by anyone, including respondent **No 04**, nor any appeal was filed in this behalf, but changing the position, all of sudden, by respondent **No. 03** is a mind boggling and a totally absurd exercise, mala-fide, violating the transfer promotion and other service rights of the appellant.
- C) That, neither any notice was issued to the appellant, nor she was heard before changing her position. The entire impugned exercise was undertaken just to benefit the respondent No. 04 in disregard of the law at the back of the appellant, whereby an adverse action was taken at her detriment.
- D) That, even the impugned seniority list or promotion order was not communicated to the appellant rather she came to know of her own sources, thereafter, she without loss of time approached respondent **No. 02**

through Departmental appeal which has not been responded so far.

- E) That, under the law and rules on the subject, changing the position of the appellant without any reason is patently illegal, unlawful, without lawful authority, without jurisdiction and of having no legal effect.
- F) That, due to the impugned order vested service rights of the appellant have been violated and infringed for no justifiable reason at all.
- G) That, before revising the impugned order/seniority list, due process of law was not followed by the respondent **No. 03**, due to which, legal rights of the appellant stood compromised.
