

**JUDGMENT:**


**SALAH-UD-DIN, MEMBER:-**

  
Precise facts forming the background of the instant service appeal are that the appellant joined Education Department as PST in the year 2016 and was regularized on 20.03.2018. Upon getting admission on the basis of Scholarship in Julin University of China in June 2018, the appellant submitted application on 15.08.2018, seeking leave with effect from 03.09.2018 till 31.07.2020. The appellant was, however proceeded against departmentally on the allegations of willful absence and he was removed from service vide order dated 21.05.2019. The

departmental appeal of the appellant was not responded within the statutory period of 90 days, therefore, he filed the instant service appeal for redressal of his grievance.

2. Notice was issued to the respondents, who submitted their comments.

3. Learned counsel for the appellant has contended that the appellant had submitted application for study leave and had proceeded abroad for higher education, however he was wrongly and illegally removed from service by the competent Authority. He further argued that the impugned order of removal of the appellant was passed in utter violation of the procedure prescribed in rule-9 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011. He next contended that whole of the proceedings were conducted at the back of the appellant, without providing him any opportunity of personal hearing or self defense. He further argued that the impugned order being wrong and illegal is liable to be set-aside.


 4. On the other hand, learned Deputy District Attorney for the respondents has contended that the application submitted by the appellant for leave without pay was rejected by the competent Authority on 06.09.2018 as the length of service of the appellant was less than 10 years, therefore, he was not entitled to avail leave without pay with effect from 03.09.2018 till 31.07.2020. He further contended that another application of the appellant for long leave was also dismissed by the competent Authority vide order dated 13.10.2018. He further argued that the appellant remained absent without any obtaining leave from the competent Authority, therefore, he was proceeded against on the allegations of willful absence and was rightly removed from service. He further argued that all legal and codal formalities were complied with and after conducting of proper inquiry the appellant was removed from service. Reliance was placed on 2009 SCMR 1121.

5. Arguments heard and record perused.

6. A perusal of the record would show that the appellant was proceeded against on the ground of willful absence, therefore, the

authority was required to have followed the procedure as laid down in Rule-9 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, which is reproduced as below:-

**"9. Procedure in case of willful absence:** *Notwithstanding anything to the contrary contained in these rules, in case of willful absence from duty by a government servant for seven or more days, a notice shall be issued by the competent authority through registered acknowledgement on his home address directing him to resume duty within fifteen days of issuance of the notice. If the same is received back as undelivered or no response is received from the absentee within stipulated time, a notice shall be published in at least two leading newspapers directing him to resume duty within fifteen days of the publication of that notice, failing which an ex-parte decision shall be taken against the absentee. On expiry of the stipulated period given in the notice, major penalty of removal from service may be imposed upon such Government servant".*




7. In view of the above mentioned reproduced rule-9 of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, the competent Authority was required to have issued notice to the appellant through registered acknowledgement on his home address, however copy of show-cause notice available on the record would show that the same was sent to the appellant on his school address despite the allegations that he was already absent from his duty. Moreover, the show-cause notice would show that copy of the same was forwarded to SDEO (Male) Katlang for issuance of absence notice upon the home address of the appellant, however nothing is available on the record, which could show that notice was issued to the appellant on his home address through registered acknowledgement, therefore, the impugned order of removal of the appellant from service is illegal and void ab-initio, hence not sustainable in the eye of law.

8. Vide admission notice dated 15.06.2018 addressed to the appellant by Jilin University, the appellant was offered admission for Master in Programme of International Relation to be completed in the period from September 2018 to July 2020. The

date of registration was from September 04, 2018 to September 05, 2018, therefore, the appellant submitted an application on 15.08.2018 for obtaining leave with effect from 03.09.2018 till 31.07.2020. The application of the appellant remained pending and was ultimately declined vide order dated 06.09.2018 by District Education Officer (Male) Mardan to ASDEO Circle Baizai. The decision on leave application of the appellant was unnecessarily delayed and nothing is available on the record to show that the outcome of the same was conveyed to the appellant. Moreover, the service of the appellant was though less than ten years, however in view of rule-12 sub-rule (1) of Khyber Pakhtunkhwa Civil Servants Revised Leave Rules, 1981, it is within the competency of the leave sanctioning Authority to grant extra-ordinary leave without pay for maximum period of two years even if the civil servant has not completed ten years of continuous service. The appellant was admittedly proceeding abroad for higher education, therefore, the departmental Authority should have exercised its discretion in granting leave to the appellant but the request of the appellant for leave was declined without any plausible reason.

9. As a sequel to the above discussion, the appeal in hand is accepted be setting-aside the impugned order dated 21.05.2019 and the appellant is reinstated in service. The period of his absence from duty may be treated as extra-ordinary leave without pay. Parties are left to bear their own costs. File be consigned to the record room.



Learned counsel for the appellant while arguing submitted that consequent upon getting admission on the basis of scholarship in China in June 2018 he applied for the study leave from 03.09.2018 to 31.07.2020 for the purpose of M.Phil on 15.08.2018 but it was not considered neither he was served with any charge sheet nor any show-cause notice resulting into non-observance of rule-9 of Government Servants (Efficiency & Discipline) Rules and ultimately he was removed from service by dent of order dated 21.05.2019 which was received by the appellant on 21.08.2019. He posed the question as to whether study leave could have been declined in the circumstances when he has fulfilled all the requirements.

The question raised besides other require resolution in its true prospective perspective in the light of law and rules in practice which mandates consideration, therefore, the appeal is admitted for regular hearing subject to all just legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments. File to come up for written reply/comments on 05.10.2020 before S.B.



RESPECTFULLY SHEWETH:

**FACTS:**

1. That the appellant joined the Education department as PST in year 2016 and regularized on 20.03.2018 and work with zeal and devotion. **Copy of appointment order and regularization order is attached as annexure A & B.**
2. That the appellant get admission on the basis of scholarship in china in June 2018. Thereafter, the appellant applied for the study leave from 03.09.2018 to 31.07.2020 for the purpose of .M.Phil in china On 15.08.2018. **Copy of documents and leave application is attached annexure C & D.**
3. That without observing codal formalities, including charge sheet, show cause etc, not served upon the appellant. Further it is added that Rule-9 of the E&D rules was also not followed. Thereafter, without show cause and personal hearing the appellant was removed from the service vide order dated 21.05.2019 received by the appellant on 21.08.2019. **copy of the impugned order and registered ad is attached as annexure E & F.**
4. That the appellant feeling aggrieved filed departmental appeal against the impugned order dated 21.05.2019 which was not responded within statutory period of 90 days hence the present appeal on the following grounds amongst others. **Copy of departmental appeal is attached as annexure-G.**

**GROUND:**

- A) That the order dated 21.05.2019 received by the appellant on 21.08.2019 and not responding departmental appeal within statutory period of 90 days is against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B) That the appellant has been condemned unheard and has not been treated according to law and rules.
- C) That the appellant was properly applied for the study leave and thereafter proceed for higher study but the department without following procedure and against the natural justice removed the appellant from service.





- D) That no proper regular inquiry was conducted if any then the appellant not associated with the inquiry, neither the statement recorded in presence of appellant nor was the chance of cross examination provided to the appellant and also not provided the inquiry report to the appellant and without final show cause notice the impugned order was passed which is against the law and rules and norms of justice.
- E) That as regards to absentia the undersigned properly submitted application and further it is added that before imposing major penalty rule 9 of the E&D rules 2011 would not followed neither charge sheet was issued nor inquiry was conducted so the impugned order has no legal value in the eye of law and liable to be set aside
- F) That the opportunity of personal hearing and personal defense was not provided to the appellant.
- G) That the appellant has not been treated according to law and rules.
- H) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.







PRELIMINARY OBJECTIONS:

1. That the appellant has got no cause of action as well as locus standi to file the instant appeal.
2. That the instant appeal is incompetent in its present form, hence the appeal is liable to be dismissed.
3. That the instant appeal is badly time barred.
4. That the appellant has not come to this Honorable Tribunal with clean hands.

13. That after fulfillment of all the codal formalities, the appellant was removed from service vide order Endst No 5583/ G dated 21-05-2019 in accordance with law.

1. Para No 1 pertains to record, hence needs no comments.

Para No E is incorrect, baseless as the detail reply Para No 06 to 12 in the preliminary objections, and the Respondent No 2 after fulfillment of all the codal formalities, and the appellant was removed from Service vide order Endst No 5583/ G dated 21-05-2019 in accordance with law, hence denied.
