

Subject: DEPARTMENTAL APPEAL/ REPRESENTATION AGAINST THE ORDER DATED 14.11.2017 PASSED BY SECRETARY E&SE, GOVT. OF KPK, PESHAWAR, WHEREBY JUNIORS TO THE APPELLANT I.E. MST. SOBIA, MST. NUSRAT JABEEN AND MST. NUZHAT HAVE BEEN PROMOTED AS SUBJECT SPECIALIST (BPS-17) W.E.F. 14.11.2017 WITH ALL BENEFITS BY IGNORING THE APPELLANT BEING SENIOR TO THEM

Sir,

Appellant humbly submits as under:-

- 1) That appellant was appointed as PST vide order dated 22.12.2006.
- 2) That appellant was appointed as S.S.T (General) in BPS-16 vide order dated 30.05.2012 after recommendation of Public Service Commission as per advertisement No.1/2009 and adjusted in GGHS Bakri Banda vide order dated 31.05.2012.
- 3) That appellant has best ACRs, Service Certificates/ Non-involvement in criminal case certificate, which were submitted by the DEO, Mardan to Director of Education KP vide letter dated 31.10.2017.
- 4) That as per law/section-8 of the KP Civil Servant Act, 1973, the order of merit assigned by the competent authority/ appointing authority is considered as the seniority list.
- 5) That appellant is earlier in order of merit than the employees junior to her (mentioned in the heading of the appeal) as visible from appointment order dated 30.05.2012.
- 6) That appellant stood senior from the persons, who were promoted on the post of Subject Specialist as per Tentative Seniority List as appellant is at S.No.2978, while the rest of the respondents/ employees were at S.No.2985, S.No.2994 and at S.No.3200.
- 7) That the Secretary E&SE, Peshawar passed order dated 14.11.2017, whereby the employees mentioned above at S.No.2985, 2994, 3200 of seniority list were promoted

and appellant at S.No.2978 is not considered for promotion without any rhyme or reason, which is illegal against law and facts, therefore, the instant departmental appeal/ representation on the following grounds:-

GROUND

- A. Because admittedly the employees junior to the appellant have been promoted to S.S English (BPS-17) and appellant being senior is ignored, which is illegal, against law and facts.
- B. Because appellant is eligible to be promoted as S.S English (BPS-17).
- C. Because appellant has not been dealt in accordance with law, dwntridding Article 4 of the Constitution of Pakistan, 1973.
- D. Because appellant has been discriminated, thereby infringing Article 25/27 of the Constitution, 1973

It is therefore, humbly prayed that, on acceptance of this appeal the order dated 14.11.2017 may please be modified by inserting name of appellant in promotion order dated 14.11.2017 as subject specialist (BPS-17) w.e.f. 14.11.2017 with all back benefits when the junior to the appellant were promoted. Any other relief deemed fit may also be graciously be granted.

Respectfully Sheweth :-

The Respondents submit as under :-

Preliminary Objections

- 1 That the appellant has got no cause of action/locus standi .
- 2 That the instant Service Appeal is badly time barred.
- 3 That the appellant has concealed material facts from this Tribunal in the instant service appeal.
- 4 That the instant service appeal is based on mala-fide intentions.
- 5 That the appellant has not come to this Honorable Tribunal with clean hands.
- 6 That the appellant is not entitled for the relief she has sought from this Tribunal.
- 7 That the instant Service Appeal is against the prevailing law & rules.
- 8 That the instant Service Appeal is not maintainable in its present form.
- 9 That the instant Service Appeal is bad for mis-joinder & non joinder of the necessary parties.
- 10 That the instant Service Appeal is barred by law.
- 11 That the appellant is not competent to file the instant appeal against the Respondents.
- 12 That the impugned Notification dated 14/11/2017 of the Respondent No: 2 is within legal sphere.

ON FACTS.

- 1 That Para-I needs no comments, being relates to the appointment against the PST(female) Post vide Notification dated 22/2/2006, annexed as (**Annexure-A**).

- 2 That Para-2 is also relates to the Service record of the appellant to the extent of her appointment vide Notification dated 30/5/2012 against the SST (G) Post in BPS-16 through the KPK Public Service Commission in view of the advertisement No: 1/2009 & adjusted at GGHS Bakri Banda District Mardan (**Copies of the same are already attached with the Judicial files as Annexure B&C**).
- 3 That Para-3 is incorrect & denied on the grounds that as matter of routine the Respondent is normally called ACRs/PERs from the eligible SST, for the purpose of working papers & DPC for further necessary Departmental action in view of the vacant post lying with the Respondent against the SS Post in BPS-17 on the basis of seniority cum fitness, wherein the appellant could not be found fit & eligible for the grant of promotion against the SS Post in BPS-17 by the Respondent No: 2 on the grounds that the appellant has not submitted her ACRs/PERs & other relevant documents mandatory for processing the case of the appellant in the Working Papers to the competent authority. Hence, she has not been promoted against the SS Post due the non-inclusion of her name in the relevant working Papers submitted by the Directorate of E&SE Department to the Secretary E&SE Department for issuance of final Notification.
- 4 That Para-4 is also incorrect & denied on the grounds that the appellant has been recommended by the Khyber Pakhtunkhwa Service Commission against the SST(F) Post & has been adjusted by the Director E&SE Department KPK at GGHS Bakri Banda District Mardan vide notification dated 30/5/2012. (**Copy of the same is annexed as annexure-D**). Therefore, her seniority is determent on the basis of her inter-Se seniority prepared by the Khyber Pakhtunkhwa Service Commission among her own batch mate having no interference by the Respondent Department.
- 5 That Para-5 is also incorrect & misleading. Detailed reply to this para has been given in above Para of the present reply. Hence, needs no further comments.
- 6 That Para-6 is incorrect & not admitted. Hence, need no further comments.
- 7 That Para-7 is correct to the extent of the impugned Notification dated 14/11/2017 by the Respondent No: 2 vide which the eligible SSTs have been promoted against the SS Post in BPS-17 on the basis of their respective seniority cum fitness basis which is legal & liable to be maintained in favour of the Respondent Department.
- 8 That Para-8 is incorrect & denied. No Departmental Appeal against the impugned Notification has been filed by the appellant nor is any such record available in the Respondent Department.
- 9 That Para-9 is incorrect & misleading. The impugned Notification dated 14/11/2017 of the Respondent No: 2 is legally competent & liable to be maintained. Hence, the appeal in hand is deserved to be dismissed on the following grounds inter alia: -


GROUND.

- A Incorrect & misleading. The appellant is junior to the Respondent No: 3 to 5 in view of their Respective inter se seniority maintained by the KPK Public Service Commission whom the appellant has not made party in the column of Respondents on mala-fide intentions.
- B Incorrect & denied. The appellant is not entitled for the grant of promotion against the Subject Specialist (English) BPS-17 Post in view of the foregoing submissions in the instant reply.
- C Incorrect & denied. The appellant has been treated as per law, rules & criteria vide the impugned Notification dated 14/11/2017 by the Respondent No: 2 having no violation of Article-4 of the Islamic Republic of Pakistan 1973.

D- Incorrect & denied. The appellant has not been discriminated in the instant case nor have violated the mandatory provisions of Article of 25 & 27 of the Islamic Republic of Pakistan 1973 with the additional submission that the Respondents No: 1&2 may kindly be allowed to submit additional grounds record & case law of at the time of arguments on the date fixed, please.

In view of the above made submissions, it is most humbly prayed that this Honorable Tribunal may very graciously be pleased to dismiss the instant Service Appeal with cost in favor of the Respondent Department.
