JUDGMENT

ATIO-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the case are that the appellant while serving as Patwari, was proceeded against on the charges of misconduct and was ultimately removed from service vide order dated 15-07-2020, against which the appellant filed departmental appeal, which was rejected vide order dated 24-09-2020, hence the present service appeal with prayers that the impugned order dated 15-07-2020 and 24-09-2020 may be set aside and the appellant may be re-instated in service with all back benefits.

02. Learned counsel for the appellant has contended that the impugned orders are against law, facts and norms of natural justice and material on record, therefore, not tenable and liable to be set aside; that in the first inquiry the appellant was exonerated of the charges and without showing any reason for de-

novo inquiry, in second inquiry the appellant was held guilty without issuing charge sheet/statement of allegation and without conducting regular inquiry, which is violation of Article-10 of the Constitution; that in case the authority disagree with findings of the inquiry officer, reason must be recorded but in case of the appellant no such reason was recorded; that no charge sheet/statement of allegation was served upon the appellant, no proper inquiry was conducted as the appellant was not associated with proceedings of the so called inquiry; that neither statement of the witnesses including the complainant were recorded in presence of the appellant nor the appellant was afforded opportunity to cross-examine such witnesses; that copy of the so called inquiry was not handed over to the appellant alongwith show cause notice, which was mandatory; that the mutation in question had correctly been prepared by the appellant in light of the contents of revenue record of the mouza concerned and there exist no mistake or irregularity either in the factum of the sale transaction reported to appellant or the contents of the sheet of subject mutation.

03. Learned Assistant Advocate General for the respondents has contended that upon a complaint lodged against the appellant, proper inquiries were conducted against the appellant and he was afforded appropriate opportunity of defense; that proper show cause was served upon him, but he failed to prove his innocence; that the appellant was afforded opportunity of personal hearing and all codal formalities were fulfilled; that the appellant was rightly awarded major penalty of removal from service as the appellant was a habitual offender, as previously he had also prepared fake mutation, for which the appellant was penalized; that service record of the appellant is full of bad entries and the appellant is not honest to his duty; that again the appellant was found guilty of misconduct, therefore after hearing the appellant, order of his removal from service was maintained and his departmental appeal was rejected; that the

impugned orders are in accordance with law and appeal of the appellant being devoid of merit may be dismissed.

- 04. We have heard learned counsel for the parties and have perused the record.
- 05. Record reveals that the appellant while serving as Patwari in Patwar Halga Bezan Khel, entered five number mutations for verification but the appellant was transferred after some time from the said Halqa. One Mr. Gul Mar Khan lodged a complaint against the appellant with the allegation that he had paid rupees fifty thousand as tax to the appellant for transfer of the property in the said mutations. To this effect an inquiry was conducted by AAC-II Bannu, who found that the mutations were entered as per law and were verified by Girdawar Circle. The inquiry report further reveals that some of the mutations were rejected by Revenue Officer on 30-06-2017 due to non-attendance of the parties and the rest are under process and stance of the complainant to the effect that his mutations were missing is not based on facts. The inquiry officer exonerated the appellant of the charges of mutation as well as of the charges of corruption. The inquiry report was submitted to the authority on 22-12-2017, but the competent authority without recording any reason appointed another inquiry officer and the inquiry officer conducted another fact finding inquiry and submitted its report on 16-06-2019 and held the appellant guilty of misconduct, but without proving such allegations against the appellant. In the said inquiry neither the appellant was associated with proceedings of the inquiry nor statement of the witnesses were recorded in presence of the appellant, thus the appellant was deprived of the opportunity to cross-examine witnesses. Still another inquiry on the same charges and on the same pattern was conducted and the inquiry officer again held the appellant guilty of the charges and submitted its report on 24-01-2020. The appellant was served with a show cause notice without issuing charge sheet/statement of allegation, thus the authorized officer, failed to frame the

proper charge sheet properly explaining the charges and other relevant circumstances proposed to be taken into consideration, as framing of charge and its communication was not merely a formality but it was a mandatory pre-requisite, which was to be followed. Reliance is placed on 2000 SCMR 1743. The appellant was finally awarded with major punishment of removal from service.

- 06. In the first place, it was noted that the appellant had rightly made entry in the register of mutation as per provisions contained in Section 42 of the Land Revenue Act 1967 read with Para 7.4(i) of the Land Record Manual, which infers that Patwari is required to make entry in the register of mutation every report made to him either by the person acquiring any rights in the landed property or on the information of any other person having charge of the property intended to be transferred through mutation and the appellant was rightly exonerated of the charges by the inquiry officer in the first inquiry report submitted on 22-12-2017. It was further noted that such entry is made with pencil, which are later on verified by Girdawar and finally attested by Tehsildar in Jalsa-e-Aam, thereafter it is entered with ink pen, so omission if any, would not be the sole responsibility of the appellant, but inspite of the fact only the appellant was malafiedly implicated on the issue of entering mutation and there is every possibility of rectification of error if any under Para 7.44 of the land record manual and which does not constitute gross misconduct entailing major penalty of dismissal from service. It was further noted that no damage whatsoever was caused either to State or to any individual due to entry of the subject mutation.
- 07. We have also noted that the respondents, while conducting another inquiry by another inquiry officer has not completed codal formalities under the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011, as the appellant was not issued fresh charge sheet/statement of allegations nor any reason was recorded for disagreement with the inquiry officer, which shows malafide on part of the respondents. The inquiries so conducted are replete with

deficiencies, as the inquiry officer did not bother to record statement of the main complainant Mr. Gul Mar Khan, hence deprived the appellant of the opportunity to cross-examine such witness, thus the respondents also violated Section 11 (1) and (4) of the Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 by not affording opportunity to cross examine witnesses, nor recorded statements of witnesses in presence of appellant, thus deprived the appellant of his lawful right, which was not warranted by law. Reliance is placed on 2002 SCMR 433, 2012 PLC (CS) 728 and 1997 SCMR 1073. We are of the considered opinion that the appellant has been treated discriminately and the respondents were bent upon removing the appellant from service at any cost.

- 08. Three inquires were conducted on the same charges against the appellant but the allegations so leveled were flimsy in nature and no specific charge was framed against the appellant. Perusal of the inquiry reports would suggest that such inquiries were fact-finding inquires and not a regular inquiry as statements of witnesses and particularly of the complainants have not been recorded, which was mandatory for affording opportunity to the appellant to cross-examine such witnesses, thus skipping a mandatory step in the disciplinary proceedings, therefore action of authority in awarding major penalty of removal from service, in circumstances, was in sheer violation of principles of natural justice. Reliance is placed on 2011 PLC (CS) 387.
- 09. We have noticed that the disciplinary proceedings against the appellant have been conducted in a haphazard manner without adhering to the manner prescribed in law and to this effect, the august Supreme Court of Pakistan in its judgment reported as 2008 SCMR 1369 has held that in case of imposing major penalty, the principles of natural justice required that a regular inquiry was to be conducted in the matter, otherwise civil servant would be condemned unheard and major penalty of dismissal from service would be imposed upon him without adopting the required mandatory procedure, resulting in manifest injustice. Main

task of the inquiry officer was to prove such allegations with solid evidence, but

the inquiry officer badly failed to prove such allegations. The respondents

preferred to punish the appellant only based on presumptions; facts however, had

to be proved and not presumed, particularly for awarding major penalty of

dismissal from service. Reliance is placed on 2002 PLC (CS) 503 and 2008 SCMR

1369.

10. In order to justify their stance, the respondents had projected the

appellant with a tainted past, whereas on the strength of PLJ 2005 Tr.C (Services)

107 and PLJ 2016 Tr.C. (Services) 324, it cannot be made a ground for awarding

penalty to a government servant.

11. There are enough grounds available on record to show that the appellant

has not been treated in accordance with law and was treated discriminately.

Neither the charges of corruption were proved against him nor the entry of fake

mutation, despite he was removed from service in an unlawful manner without

adhering to the method prescribed in law and without any fault of the appellant.

In view of the foregoing, the instant appeal is accepted. The impugned orders

dated 15-07-20202 and 24-09-2020 are set aside and the appellant is re-instated

in service with all back benefits. Parties are left to bear their own costs. File be

consigned to record room.


FACTS:

- 1. That the appellant was appointed as Halqa patwari and work with full zeal and zest. The appellant while workings as Halqa Patwari Bezan kheil enter 5 mutations for verification and just after 4 months transferred from the said halqa.
- 2. That, subsequently the complainant file complaint to DC for fake mutations on the basis of that report inquiry was conducted wherein appellant was exonerated from the charges. copy of inquiry report is attached as Annexure-A.
- 3. That thereafter another inquiry was conducted against the appellant without any reason and specific order and which is in questionnaire form. And inquiry officer recommended that the allegation of changing parth sarkar is incorrect. Copy of inquiry report is attached as annexure-B.
- 4. That third time fact finding inquiry was conducted wherein appellant again held responsible. Copy of inqury report is attached as annexure-C.
- 5. That the deptt direct issued show cause notice to the appellant. The appellant properly replied to the show cause notice and denied the entire allegations. Copy of show cause notice is attached as Annexure-D.
- 6. That thereafter, without personal hearing the major penalty of Removal from service was imposed upon the appellant vide order dated 15.07.2020. The appellant being aggrieved filed departmental appeal against the order dated 15.07.2020 but the same was rejected vide order dated 24.09.2020 for no good grounds. Hence the present Sevice appeal on the following grounds amongst others. Copy of impugned order, departmental appeal and rejection order is attached as annexure-E, F & G.

GROUNDS:

- A. That the orders dated 15.07.2020 and rejection order dated 24.09.2020 are against the law, facts, norms of justice and material on record, therefore not tenable and liable to be set aside.
- B. That in first inquiry the appellant was exonerated and without showing season for denovo Enquiry. in second inquiry the appellant held guilty without issuing charge sheet and regular inquiry, which is violation of Article-10-A of the constitution...
- C. That if the authority disagree with the inquiry officer he must be given reason but in the case of appellant no order was passed for inquiry and no reason was shown for disagreement with the inquiry which is violation of the superior court judgment.
- D. That no charge sheet statement of allegation was served upon the appellant, no proper regular inquiry was conducted if any then the appellant not associated with the inquiry, neither the statement recorded in presence of appellant nor the chance of cross examination provided to the appellant and if any inquiry conducted at back of the appellant so, also not provided the inquiry report to the appellant and without final show cause notice the impugned order was passed which is against the law and rules, void ab initio and norms of justice.
- E. That the complainant was neither examined before the appellant not given any chance of cross examination to the appellant during inquiry.
- F. That all the 5 mutation was prepared by the appellant which were rejected by the Tehsildar the appellant has not role in this but punished for no fault. copy of mutation is attached as annexure-
- G. That the appellant was punished for no fault but to save the skin of the high officials and threating the appellant for ulterior motives.
- H. That as per the provision of sec 42 of the land revenue act read with para 7.4 of the land record manual, patwari halqa shall enter in his register of mutation every report made to him either by the person acquiring any right in the landed property or on the information of any other person having charge of property intended to be transferred through mutation. So it is clear that the Patwari has limited roll, further it is added that the mutation was

- cancelled by the tehsildar not appellant but despite that the appellant was awarded penalty of removal of service.
- I. That the mutation in question has been correctly prepared by appellant in the light of the contents the revenue record of the mouza concerned there exists no mistake or irregularity either in the factum of the sale transaction reported to appellant or the contents of the sheet of the subject mutation, all the columns of both the foil and counter foil have correctly been filled by appellant exactly in accordance with the nature of landed property i.e khata number, khasara number, name of land owner/vendors and vendee.
- J. That the impugned order of Dc Bannu is void, contrary to law, facts and available record the appellant was treated discriminatory the inquiry conducted was biased one. The inquiry was not fair and against mandate of service rules and policy.
- K. That, the entry appellant was thoroughly scrutinized and checked by girdawar circle concerned and later the mutation in question was attested in the presence of required witness.
- L. That, the appellant has done his job accordingly to law and has made the entry for mutation in question only.
- M. That, if the complainant is aggrieved, then he would be from girdawar circle and tehsildar concerned who have attested mutation but action was taken against the patwari by exonerating the tehsildar and Girdawar and punished the appellant to save the skin of High ups.
- N. That, the Inquiry was not conducted as per the mandate of law. Neither any statement of any witness was recorded in the presence of appellant neither he was afforded opportunity of cross examination.
- O. That, personal hearing, being mandatory, was not afforded to appellant which is against the law and rules.
- P. That no inquiry report was provided to the appellant with show cause notice which is against the law and rules.
- Q. That, appellant being employee, was not tenable to any penal action so the impugned order is based on ulterior motive.



S. That the appellant seeks permission to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

- a. The applicant had purchased 52 K land @,26000/per Kanal. He paid Rs.1000000/- to the seller on the spot. Rest of the payment will be made after mutation.
- b. The applicant went to Patwari Nafirullah for entry/attesting the mutation for the same and paid Rs.54000 to him for the purpose.
- c. Patwari Nafirullah entered various mutations. Nafirullah (Patwari) delayed attestation of the same. Meanwhile, he was transferred. When the complainant approached the new Patwari. The Patwari stated that the mutations are not available/traceable
- d. Therefore, he submitted complaint to DC, Bannu against Patwari Nafirullah, but after some time mutation were found with office Kanungo Domel being rejected/disposed off.
- e. The complainant stated that the rejected mutations are bogus one. He provided another copy of the mutations which has the partal of Girdawar but the rejected copy has not the partal of Girdawar, which reveals that the rejected mutations are bogus.
- f. He requested to take disciplinary action against the Nafirullah (partwari) and attested the mutations as he already deposited/paid taxes to Nafirullah (Patwari).



He stated that;

- a. He has entered mutation No. <u>10049</u>, <u>10050</u>, <u>10051</u>, <u>10057</u>, <u>10060</u>, <u>10064</u>, <u>10061</u>. and <u>10048</u> on 24.05.2012 and the Girdawar has made parthal on Parth Patwar.
- b. He has not taken any amount from the complainant.
- c. The complaint is baseless and may be filed.
- d. On a question that "why parth Sarkar has not the parthal of Girdawar" he replied that "the Girdawar should record parthal but it is the responsibility of Girdawar.
- e. On a question that "handwriting of parth sarkar and Parth partwar is difference" he replied that to hurry and change of pen, difference may occurred.
- f. On a question that "why the mutations have been delayed and why he has not presented the same to Tehsildar for attestation/rejection" he replied that "The mutations were lying with Girdawar."
- g. On question that "the complainant has paid amount to Nafirullah through Amir Hamza. He replied that "he does not know Amir Hamza.
- h. About writing he stated that he does not know.

 - b. Parthal of Girdawar was not quoted on the said mutations.

Statement of Mir Shah Ali Khan (partwari Bizan Khel) (Flag F)

- a. Difference in Page No. may also occur due to damages of pages.
- b. Difference in handwriting may also occur due to change of pen.
- c. Parthal of Girdawar is necessary on both i.e. parth Sarkar and Parth
- d. After recording parthal mutation has been handed over to Patwari.

Statement of Amirullah (present Patwari Bizan Khel) (Flag G)

He stated that:

a. He stated that most of the land under question has been sold vide difference mutations.

Statement of Sabil (Partner of complainant) (Flag H)

He stated that:

- a. They have purchased 33 K land from Hanzada Khan, Qamar Zaman Khan Etc and amount has been paid to them.
- b. Rs. 26000/ as taxes have also been paid to Ayub Khan (Ex.Tehsildar)
- c. He does not know about revenue record whether the Patwari has attested the mutations or not.
- d. Later on he left partnership with complainant and now he has not concerned with the land.

Findings:

After going through the record and statements of the accused/Patwari, complainant & witness, it reveals that the accused Patwari change the Parth Sarkar of the mutation NO.10049, 10050, 10051, 10057, 10060, 10064. Further statement of complainant Mr. Gul Mar Khan seems genuine that he gives tax money to Patwari (Nafeerullah) in the presence of Mr. Aamir Humza at shamimly Hotel.

Recommendations:

Keeping in view track record of Nafirullah Patwari (presently dismissed in corruption cases & filled a writ petition in high court for his restoration), interesting on the same allegation and record, Azizullah Jan the-then AAC (Rev) Bannu, conduct an inquiry and come up with report on 20/03/2018 with the recommendation that the allegation of Gul Mar Khan seems to be genuine (Flag I).

Therefore, it is recommended that Mr. Nafeerullah the-then Patwari Mouza Bizan Khel seems to be guilty of changing Parth sarkar of Mutations no 10049, 10050, 10051, 10057, 10060, 10064. And Major penalty may be imposed on him-according to E&D Rules 2011.

ENQUIRY REPORT INTO THE ALLEGATIONS LEVELLED AGAINST MR.NAFEER ULLAH THE THEN PATWARI HALQA BIZEN KHEL TEHSIL DOMEL DISTRICT BANNU BY GUI. MAR KHAN R/O DOGAR UMERZAI TEHSIL DOMEL

The Deputy Commissioner, Bannu appointed the undersigned as an Inquiry Officer vide charge sheet and statement of allegation bearing No.7330/DC/AE dated 27.11.2019 to conduct inquiry into the allegations regarding guilty of changing Parth Sarkar of mutations on account of illegal gratification.

Summary of the case

One Mr.Gul Mar Khan s/o Bostan Khan r/o Dogar Umerzai Tehsil Domel District Bannu complained that Mr.Nafeerullah Khan the then Patwari Halqa Bizen Khel Tehsil Domel had changed the Parth Sarkar of Mutations No.10049, 10050, 10057, 10060 & 10064 on account of illegal gratification. Accordingly, the Additional Deputy Commissioner, Bannu probe into the allegations which were proved to be genuine upon which he recommended award of major penalty to the accused Patwari.

Proceedings

In order to ascertain factual position and to record statements, the complainant, all stakeholders and the accused Patwari Mr.Nafeerullah were summoned on 10.12.2019 at 11.30 am and 3.00 pm vide letters No.4545-50/AC/F.5 dated 3.12.2019 and No.4551-52/AC/F.5 dated 3.12.2019 respectively. The eight number respondents who were summoned through Patwari concerned did not attend this office despite of the facts that they were informed by the Patwari well in time vide Annex-A. The complainant (Gul Mar Khan), Asmatullah, the then Tehsildar Domel (now retired), Asghar Khan, the then Office Kanungo Tehsil Domel (now HVC Commissioner's office), Shafiullah the then Girdawar Circle Tehsil Domel (now retired) Mir Shah Ali Khan, the then Patwari Halqa Bizen Khel attended this office and their statements were recorded which are reproduced as follows:-

Statement of the complainant (Gul Mar Khan)

In his written statement at Annex-B, the complainant Gul Mar Khan has stated that he had already given statement to ADC Bannu in the said inquiry and his current statement is the same.

In his previous statement (Annex-C), the complainant stated that he purchased 52 Kanal land @ Rs.26000/- per kanal located in Mauza Chak

Shaheed Tehsil Domel and paid Rs.10,00,000/- to the seller on the spot while as per commitment the outstanding balance will be paid during the time of mutation. He further stated that three Parth Sarkar of mutations No.10048, 10061 & 10064 were found pending while the other Parth Sarkar of mutations No.10049, 10050, 10051, 10057 & 10060 were missing which were later-on presented by the concerned Patwari and the serial number of the said parth Sarkar of Mutations do not match with the Parth Patwar of the said mutations. The complainant also stated that the said parth sarkar of mutations No.10049, 10050, 10051, 10057 & 10060 were bogus and not original.

The complainant therefore requested that necessary legal action may be taken against the concerned Patwari.

Statement of the then Tehsildar Domel (Asmatullah)

In his written statement at Annex-D, Mr. Asmatullah, the then Tehsildar Domel (now retired) has stated that he had given the statement to the Additional Deputy Commissioner Bannu on 1.1.2019 about Mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10064 Mauza Bizen Khel and his current statement is the same.

In his previous statement (Annex-E), the then Tehsildar stated that:-

- (1) Mutations No.10049, 10050, 10051, 10057 & 10060 which were lying since 2012 and no action was taken on it were rejected in
- (2) Since the mutations were old, therefore, the same were rejected.
- (3) The concerned Patwari prepared detail of rejected mutations which were rejected in Jalsa-e-Aam.
- (4) There was no verification report of Girdawar Circle on Parth Sarkar.
- (5) When there was no verification report available on parth sarkar, then how can signature of Girdawar Circle exist?
- (6) Mutations No.10061 & 10064 were rejected in Jalsa-e-Aam on 22.1.2018 while mutation No.10048 was still pending and was presentwith concerned Patwari Halqa.

Statement of the then Office Kanungo Tehsil Domel (Asghar Khan)

In his written statement at Annex-F, Mr. Asghar Khan, the then Office Kanungo Tehsil Domel (now HVC Commissionerate Bannu) has stated that he had given the statement in the inquiry of Nafeer to the then Additional Deputy Commissioner Bannu about Mutation No.10049 etc and his statement is the same.

In his previous statement (Annex-G), the then office Kanungo stated that he had brought register of mutations of Mauza Bizen Khel and presented photocopies of rejected Parth Sarkar of Mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10064. He further stated that Parth Sarkar of Mutation No.10048 was not available in the office of Kanungo Tehsil Domel. He also

stated that serial numbers of Parth Sarkar, of mutations No.10050, 10051, 10057 & 10060 had been overwritten which is not known to him that who had do it.

Statement of the then Girdawar Circle Tehsil Domel (Shafiullah Khan)

In his written statement at Annex-H, Mr. Shafiullah Khan, the then Girdawqar Circle Tehsil Domel (now retired) has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement (Annex-I), the then Girdawar Circle had stated that his signatures were exist on Parth Patwar and Parth Sarkar of Mutations No.10048 and 10061 while his signatures on Parth Patwar of mutations No.10049, 10050, 10051, 10057 & 10064 are exist but the same on Parth Sarkar were not exist. He also stated that the serial number of the Parth Patwar and Parth Sarkar does not clear and accurate which make that suspicious.

He further stated that when Girdawar Circle sign (verification report) parth patwar then he also sign the parth sarkar which shows that the pages of parth sarkar had been changed.

Statement of the then Patwari Halqa Bizen Khel (Mir Shah Ali Khan)

In his written statement at Annex-J, Mr.Mir Shah Ali Khan, the then Patwari Halqa Bizen Khel (now Patwari Mauza Aral-I Tehsil Domel) has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement (Annex-K), the then Patwari had stated that difference in page number occurred due to damages of pages while difference in hand writing occurred due to change of pen. He further stated that parthal of Girdawar was necessary on both i.e. parth sarkar andn parth patwar and after recording parthal, mutation handed over to Patwari.

Statement of the present Patwari Halqa Bizen Khel (Amirullah Khan)

In his written statement at Annex-L, Mr.Amir Ullah Khan, Patwari Halqa Bizen Khel has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement given to the ADC Bannu (Annex-M), Mr.Amirullah Khan has stated that he had brought himself parth sarkar & parth patwar of Mutation No.10048 while parth patwar of mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10062, for perusal. He further stated that most of the land in question had been sold vide above mutations.

In his statement (Annex-N), Mr.Nafeerullah Khan, the then Patwari Halqa Bizen Khel Tehsil Domel has stated that he had entered mutations No.10048, 10049, 10050, 10057, 10060, 10061 & 10064 Mauza Bizen Khel-i Tehsil Domel of the complainant on 24.5.2012 and the Girdawar Circle made parthal on parth patwar. He further stated that the complainant (Gul Markhan) produced only sellers of mutation No.10048 while the sellers of other mutations did not produced to Girdawar Circle and Tehsildar since 2012 todate out of which mutations No.10048, 10061 & 10064 were still pending while other mutations were rejected by the Revenue Officer on 30.6.2017 due to absence of sellers.

The accused Patwari further stated that neither he had taken any tax amount from anyone nor it is his job. He also stated that he did not take any amount for any officer.

He further stated that the complaint of the complainant is baseless as the complainant made false accusations on him in the complaint. The accused Patwari therefore requested that since he is innocent, therefore, the complaint of the complainant may please be filed.

Findings:

After thorough probing into the matter and going through the record and statements, it revealed that the accused Patwari (Nafirullah) has acted in an irresponsible manner about the missing of parth sarkar of the mutations and later-on presented by the accused Patwari but the serial number of the said parth sarkar of mutations were not match with the parth patwar of the said mutations. The accused Patwari prepared bogus mutations for the complainant. The complaint of the complainant seems to be genuine.

Recommendations:

Keeping in view the above, It is recommended that:-

(a) Mr. Nafeerullah, the then Patwari Mouza Bizen Khel, Tehsil Domel may be awarded major penalty.

(b) Any relief regarding preparation of fresh mutations of the disputed landed property cannot be granted by this office for which he should file appeal in the proper forum.







Preliminary Objections.

- i. That the appellant has got no cause of action/locus standi to file the instant appeal.
- ii. That the appellant has not come to this honorable Tribunal with clean hands.
- iii. That the appellant is estopped by his own conduct, to file the instant appeal.
- iv. That the appeal is bad due to non-joinder and mis-joinder of necessary parties, hence, liable to be dismissed.
- v. That the instant Service Appeal is based on malafide.
- vi. That the appellant is habitual offender. Previously, he has also prepared fake mutations and on the complaint of one Hayat Ullah S/O Wali Ullah, inquiry was conducted and on the report of inquiry officer, after fulfillment of all codal formalities, major penalty of removal from service was imposed on the appellant. The respondent No. 3 directed respondent No.1 to reinstate the appellant only for the purpose of inquiry vide his letter No.Estt:VII/C.Case/5975 dated 28.02.2019 and accordingly the respondent No.2 reinstated the appellant in service only for the purpose of inquiry and not for duty vide order dated 2203/DC/AE dated 04.04.2019. Thereafter, the

appellant filed writ petition before Peshawar High Peshawar (copy of writ petition is enclosed as annexure R-1. On first dated the Hon'ble Court vide order dated 23.07.2019, directed the respondents for submission of comments and to release the salary of the appellant. In compliance to the direction of Hon'ble Court joint Para-wise comments were submitted and respondent No. 2 vide order No.5156/DC/AE/BC dated 29.08.2019 also release the salary of appellant from the dated of re-instatement of the appellant in to service. (Copy of Joint Para-wise comments is enclosed as <u>annexure R-2</u>). All the above mentioned documents available in annexure R-2. Later on, the case was transferred from Peshawar to Bannu Bench and is still pending.

FACTS.

- 1. Pertains to record.
- 2. Incorrect. The appellant was not exonerated from the charge. Furthermore, the complainant Gul Mar Khan and Sabeel Khan filed an application before respondent No.2 for initiation of legal proceeding against the Patwari Halqa, which was marked to Additional Assistant Commissioner-II, Bannu for conducting of inquiry, who submitted his report for legal proceedings. Copy of complaint and report of AAC-II, Bannu is enclosed as annexure R-3 and R-4.
- 3. Incorrect. On the report of AAC-II, Bannu, respondent No.2 directed Additional Deputy commissioner, Bannu for conducting of preliminary inquiry on the application of complainant Gul Mar Khan etc. The ADC, Bannu after conducting inquiry submitted inquiry, wherein report confirmed allegations to be genuine and recommended for major penalty under E&D Rules, 2011. (Copy of inquiry report and statements recoded by the ADC, Bannu are

enclosed as annexure R-5). Thereafter, as per law, the appellant was charge sheeted by the Respondent No.2, issued statement of allegations and Assistant Commissioner, Bannu was appointed as Inquiry Officer. (Copy of Charge Sheet and statement of allegations are enclosed as annexure $\underline{R-6}$ & $\underline{R-7}$). The inquiry officer recorded statement of appellant and other PWs and submitted inquiry report vide letter No. 88/AC/F-5 dated 27.01.2020, copy enclosed as annexure **R-8**, while inquiry report along with statement of PWs and appellant are enclosed as annexure **R-9**. Findings of inquiry officer is narrated as under: "After thorough probing into the matter and going through the record and statements, it reveals that the accused/Patwari (Nafirullah) acted in irresponsible manner about the missing of Parth Sarkar of the mutations and later on presented by the accused Patwari but the serial number of the said Parth Sarkar of mutations were not match with parth patwar of the said mutations. The accused Patwari prepared bogus mutations for the complainant. The complaint of the complainant seems to be genuine. The AC/inquiry officer, Bannu has recommended for major Penalty. In light of inquiry report of Assistant commissioner/inquiry officer, Bannu, Show Cause Notice vide No. 1615-16/AE/BC dated 05.03.2020 was issued to him. (Copy of Show Cause Notice is enclosed as annexure R-10). Reply to the Show Cause Notice dated 05.03.2020 was submitted by the appellant duly by him. (Copy enclosed as annexure R-11). Thereafter, as per law, an opportunity of personal hearing was given to the appellant vide No. 2727/DC/AC/BC dated 03.07.2020 and vide his attendance sheet dated 08.07.2020 he availed the same. (Copy enclosed as annexure R-12 & R-13). After fulfillment of all codal formalities, major penalty of



removal from service was imposed on the appellant vide order No. 2914/DC/AE dated 15.07.2020. (Copy enclosed as annexure **R-14**).

- 4. Detail reply is given in Para-3 above.
- 5. Detail reply is given in Para-3 above.
- 6. As the appellant has been found guilty of mis-conduct, therefore, after hearing the appellant and the order of removal from service of respondent No. 2 was maintained and the appeal of the appellant was dismissed by the respondent No. 1.


Grounds.

- A. Incorrect. The order of respondent No. 1 and 2 is according to law, rules and principle of natural justice. Detailed is given in para-3 of the **Facts** above.
- B. Incorrect. Detail is given in Para-3 of the Facts above.
- C. Incorrect. All the proceedings were carried out according to Law and in accordance with the judgments of the superior courts.
- D. Incorrect. After fulfillment of all codel formalities, final order for removal from service was issued by respondent No.2 which is purely according to law, rules and norms of Justice.
- E. Incorrect. Detail is given in Para-3 of the Facts above.
- F. The 5 bogus mutations No. 1049, 10050, 10051, 10057 and 10060 were prepared by the appellant. Firstly, he showed irresponsibility about missing of Parth Sarkar of the said mutations and later on when he presented the same, it shows that serial No of the Parth Patwar did not match with the serial No. of the Parth Sarkar as the serial No. of the Parth Sarkar has been erased/removed. Furthermore, Partal of the Girdawar has been made on Parth Patwar but the same is not done on Parth Sarkar, which is essential. Copy of above mentioned mutations (both



Parth Patwar and Parth Sarkar) are enclosed as annexure <u>R-15</u> and <u>R-16</u>)

- G. Incorrect. The appellant was found guilty of mis-conduct. Hence, after fulfillment of codal formalities, he was removed from the service.
- H. Correct to the extent that the bogus mutations prepared by the appellant has been rejected by the Tehsildar. However, the bogus mutations were prepared by the appellant and firstly he showed irresponsibility regarding missing Partt Sarkar of the said mutation and later on when he presented the same and on perusal, it transpired that no sign of the Girdawar Circle is available on part Sarkar. Furthermore, the serial No. of the Partt Patwar of the bogus mutations were also not matching with Partt Sarkar. This fact has also been confirmed by the Girdawar Circle Shafillah Khan and Patwari Mir Shah Ali Khan in their statements before inquiry officer. Copy already enclosed in annexure R-9.
- I. Incorrect. The area mentioned in the bogus mutation are different from the revenue record. Detail is available in statement of Amir Ullah Khan, the present Patwari recorded before inquiry officer already annexed in annexure **R-9**.
- J. The order of the respondent No.2 is according to law, facts and the appellant has not been treated discriminatory and the inquiry officer had submitted impartial inquiry report.
- K. Incorrect. Detail is given in the above.
- L. Incorrect. He has registered fake mutations; detail is given in the above Paras.
- M. The illegality has been committed by the appellant and after fulfillment of all codal formalities, he was removed from service, detail is given in Para-3 of the Facts above.



- O. Incorrect. The appellant has been given opportunity of personal hearing vide annexure R-12 and he availed the same vide annexure R-13.
- P. Incorrect.
- Q. Incorrect.
- R. The order of respondent No.2 regarding imposing of major Penalty upon the appellant is according to law.

That respondent No. 4 issued a charged sheet to the appellant on 26/02/2018 containing the allegation that as per allegations leveled by one Hayat Ullah S/o Wali Ullah, you had prepared bogus and fake mutations due to which the complainant has sustained huge financial loss and accordingly a Show Cause Notice was issued to petitioner on 31/08/2018 by the respondent No. 4 (Copy of SCN is attached as Annexure "A")
- 3. That respondent No. 4 with out giving proper opportunity of hearing to petitioner passed an order dated 27/09/2018 vide which the petitioner has been awarded major penalty of "Removal from Service" (Copy of the and a service).



- e. That order dated 24/01/2019 clearly reflect that petitioner has been made an escaped goat in the whole episode, but still his salary has not been released to him which is totally against the nor of justice.



Para No. (3) Incorrect. Complaints No.57014 and No.57017 dated 31.1.2018 of one Hayatullah s/o Waliullah were received via Khyber Pakhtunkhwa Citizen Portal (Annex-A) wherein he complained against the Petitioner





for making fake/illegal mutations, which caused him financial loss. The complainant request to conduct of inquiry. The complaints were initially marked to Additional Assistant Commissioner (Revenue), Bannu for preliminary enquiry who after probing into the case reported that there is truth in the allegations and the mutations have been wrongly prepared. The AAC (Revenue) Bannu further recommended for initiating formal inquiry into the matter vide his report dated 8.2.2018 (copy attached at Annex-B).

Accordingly, the petitioner was charge sheeted vide charge sheet & statement of allegations dated 26.2.2018 (Annex-C) and the Additional Assistant Commissioner-III, Bannu was appointed as an Inquiry Officer to conduct inquiry in the subject case vide letter No.1263/AE/BC dated 26.2.2018 (Annex-D). The Inquiry carried out a thorough probe and submitted a comprehensive report vide No.214/AAC-III dated 17.8.2018 (Annex-E), on the basis of which, all concerned were summoned before the Respondent No.4 for personal hearing on 19.9.2018. The record was perused, enquiry report alongwith supporting documents examined by the Respondent No.4. Since the Inquiry Officer had declared the petitioner as guilty, therefore a formal show cause notice vide No.4429/DC/AE dated 31.8.2018 (Annex-F) was issued. Reply to the show cause notice dated 6.9.2018 received vide Annex-G.

The <u>opportunity of personal hearing was given to the petitioner</u> vide letter No.4752-55/AE/BC dated 14.9.2018 (Annex-H) and vide his attendance dated 18.9.2018 (Annex-I). After fulfillment of all codal formalities, major penalty of removal from service was imposed on the petitioner vide order No.4986-99/DC/AE dated 27.9.2018 (Annex-J).

Later-on, the petitioner submitted application to Respondent No.3 for release of pay who forwarded the case to respondent No.4 vide letter No. 3063-66 dated 23.4.2019 (Annex-N) and accordingly he was informed that the petitioner had been reinstated only for the purpose of inquiry not for duty and the issue of release of pay was kept pending till outcome/disposal of inquiry by the Respondent No.1 vide letter No.3005/DC/AE dated 16.5.2019 (Annex-O).



The complainat, Nafirullah (ex patwari halqa Bizan khel) and Turab Shah (present τ 2... patwari halqa Bizan khel) were summoned. They appeared before the undersigned. Turab Shah (patwari) submitted written statement (Flag-A), wherein he reported that: 25K - 19M land has been mutated from Asmatullah khan s/o Asat khan to Wali khan s/o Gulbat Shah and Hayatullah s/o Wali khan equally vide Mutations bearing No.8943, 8944, 8945, 8946, 8947, 8948 & 8949. ii. Mutations No.8943, 8944, 8945, 8946, 8947, 8948 were entered in Khata No.940 Khasrajat No.908, 1341, 3503, 1339, 1338, 3307, 3304, 3309, 3310, 3311, 3312, 3313, 3314, 3315 whereas these khasrajat Nos did not exist in khata No.940 as per revenue record. iii. Memo:

Kindly riter to your letter No. 1263 dated 26/02/2017 on the subjected noted above (Annex- A).

Introduction:

A complaint on Citizen Portal was made by Mr. Hayatullah s/o Waliullah wherein he complained about the preparation of bogus and fake mutations for him by the then patwari halqa Bizenkheil. The complainant implored for justice in the form of initiating a disciplinary proceeding against the said patwari and correction of the record regarding the mutations. The task to inquire into the matter was handed over to the undersigned by the worthy Deputy Commissioner.

Background:

A complaint on Citizen Portal (Annex- B) was lodged by Mr. Hayatullah s/o Waliullah against Mr. Nafirullah, the then halga patwari Bizen Kheil, presently suspended in another case, wherein he (the complainant) alleged that the said patwari had prepared bogus and fake mutations for him and that he had been suffering a great financial loss due to this act of the said patwari. The complainant had prayed for conducting an inquiry against the patwari and correction of the revenue record. The complaint was marked to AAC-R. Subsequently AAC-R drafted a self- explanatory report (Annex-C) wherein he mentioned some irregularities/illegalities of very severe nature allegedly committed by Nafir patwari while making the mutations.

The undersigned was tasked by the esteemed addressee to conduct an inquiry regarding the complaint against the patwari.

Procedure of the Inquiry:

The complainant submitted his written statement(Annex-D) wherein he asserted that Nafir, the then patwari halqa Bizenkheil, had made fake and bogus mutations (no.8943, 8944, 8945, 8946, 8947, 8948 and 8949) for him due to which he suffered a great financial loss and that he wanted Nafir patwari be prosecuted in the case. In order to delve into the matter, statement of the incumbent patwari of the halqa Bizenkheil Mr. Turab Shah (Annex-E) was sought. Mr. Turab Shah reported that ...

- 1. 25K-19M land had been mutated from Asmatullah Khan s/o Asat Khan to Wali Khan s/o Gulbat Shah and Hayatullah s/o Wali Khan equally vide mutations bearing No.8943, 8944, 8945, 8946, 8947, 8948 and 8949(Annex-F)
- 2. Mutations No.8943, 8944, 8945, 8946, 8947, and 8948 were entered in khata No.940 khasrajat No.908, 1341,3503,1339,1338,3307,3304,3309,3310,3311,3312,3313,3314,3315, whereas these khasrajat did not exist in khasra No.940 as per revenue record.
- 3. Similarly khasra No.1341 had once wrongly been shown in khata No.940 with measurement 04K--15M. But the same khasra No. has again been shown in mutation No.8948 with measurement 130K--o1M.
 - 4. There are also irregularities/illegalities in the property so transferred.
 - 5. The mutations were made with a reference to mutations instead of jamabandi.

Statement of Mr. Nafir, the accused patwari (Annex-G)


Nafir patwari was called and appraised of the allegations being leveled against him. He was provided with full opportunity of being personally heard. He was given full opportunity to prove his indocence in the case and was cross-questioned. He submitted his written statement wherein he stated in at.

1. Mutations from 8943 to 8949 were registered with reference to mutations (bahawala-eintigal)

2. Khasrat No.908,1341,3503,1339,1338,3307,3304,3305 and 3310 were in different khatajat \tilde{v}_{L} as khatajat oftenly get changed during the preparation of charsala.







Statement of Mr. Shafiullah, the then girdawar Halqa Bizenkheil(Annex-H):

As Shafiullah (Retd girdawar), the then girdawar of the halqa was, by virtue of his designation, responsible for checking an irregularity/illegality, if any, in the mutations he was going to confirm. Henceforth he was summoned and an attempt was made to know his response regarding all the irregularities/illegalities that were reported in the mutations he had signed. He submitted a

Wherein he stated that he had made the mutations no. 8943,8944,8945,8946,8947,8948 and written statement 8949 bahawal-e-intiqalat and cross-checked it with mutations no. 8349,8353,8355,8257,8258,8404 and 8315 respectively. He further stated that the mutations he registered were legal bahawal-eintigalat.

Statement of Mr Fariq Nawaz, acting patwari halqa (Annex-I):

The patwari stated in his statement that khasra No.1341 is registered in Jamabandi 2005-06 in khata No.926/5126 having an area of 130K-01M. He further stated that in Field Book of settlement of 1992-93 area of the said khasra No. was correctly registered.

Findings:

From perusal of the record, statement of the complainant and cross-examination of the patwari Nafir and Shafiullah, the then girdawar of the halqa, following findings have been established

- 1. Nafir patwari and Shafiullah girdawar(Retired) have failed in justifying, in the eye of the law by the undersigned. and rules, their act of making and confirming the mutations vid no.8943,8944,8945,8946,8947,8948 and 8945 from mutations vide no.8349,8353,8355, 8257,8258, 8404 and 8315 respectively which are in itself unapproved and unconfirmed(copies of unapproved mutations are attatched herewith as Annex-J). It is concluded that these mutations are fake amd bogus and that the patwari and girdawar have intentionally made and confirmed it with malafide intentions; most probably for the sake of the obviously involved monetary considerations.
- 2. Nafir patwari and Shafiullah girdawar(Retired) have entered and subsequently confirmed mutations no. 8943,8944,8945,8946,8947 and 8948 in khata No. 940 having khasarajat No.908, 1341, 3503, 1339,1338,3307,3304,3309,3310,3311,3312,3313,3314 and 3315 whereas these khasrajat do not exist in the said khata. It is therefore established that this entry and consequent mutations are illegal, fake, and misleading. This whole practice speaks of the pecuniary interests being considered on the part of the patwari and the girdawar.
- 3. Patwari Nafir and girdawar Shafiullah have shown their incompetency by showing two different measurements of khasra no. 1341. The actual measurement/position of the said khasra No.,in accordance with the Field Book 1992-93, is 130K-01M and its khata No. is 926/5126 in accordance with the Jambandi 2005-06.
- 4. An irregularity has been committed by the patwari and the girdawar here as they have made the mutations bahawal-e-intigal where, by law and rules, they were supposed to do it from jamabandi. They have abdicated their responsibility of making mutations from jamabandi.

5. The complainant may apply at an appropriate forum for rectifying the record.





INQUIRY REPORT AGAINST MR. NAFEER PATWARI,

COMPLAINT

To dig out facts, various stakeholders in the case were summoned and their statements were recorded.

Statement of Complainant Gul Mar khan: (Flag A)


He stated that

- a. The applicant had purchased 52 K land @ 26000/per Kanal. He paid Rs.1000000/- to the seller on the spot. Rest of the payment will be made after mutation.
- b. The applicant went to Patwari Nafirullah for entry/attesting the mutation for the same and paid Rs.54000 to him for the purpose.
- c. Patwari Nafirullah entered various mutations. Nafirullah (Patwari) delayed attestation of the same. Meanwhile, he was transferred. When the complainant approached the new Patwari. The Patwari stated that the mutations are not available/traceable
- d. Therefore, he submitted complaint to DC, Bannu against Patwari Nafirullah, but after some time mutation were found with office Kanungo Domel being rejected/disposed off.
- e. The complainant stated that the rejected mutations are bogus one. He provided another copy of the mutations which has the partal of Girdawar but the rejected copy has not the partal of Girdawar, which reveals that the rejected mutations are bogus.
- f. He requested to take disciplinary action against the Nafīrullah (partwari) and attested the mutations as he already deposited/paid taxes to Nafīrullah (Patwari).

He stated that;

- a. He has entered mutation No. <u>10049</u>, <u>10050</u>, <u>10051</u>, <u>10057</u>, <u>10060</u>, <u>10064</u>, <u>10061</u>. and <u>10048</u> on 24.05.2012 and the Girdawar has made parthal on Parth Patwar.
- b. He has not taken any amount from the complainant.
- c. The complaint is baseless and may be filed.
- d. On a question that "why parth Sarkar has not the parthal of Girdawar" he replied that "the Girdawar should record parthal but it is the responsibility of Girdawar.
- e. On a question that "handwriting of parth sarkar and Parth partwar is difference" he replied that to hurry and change of pen, difference may occurred.
- f. On a question that "why the mutations have been delayed and why he has not presented the same to Tehsildar for attestation/rejection" he replied that "The mutations were lying with Girdawar."
- g. On question that "the complainant has paid amount to Nafirullah through Amir Hamza. He replied that "he does not know Amir Hamza.
- h. About writing he stated that he does not know.

Statement of Asghar (ADK): (Flag C)

- a. He provide copy of Mutation No <u>10049</u>, <u>10050</u>, <u>10051</u>, <u>10057</u>, <u>10060</u>, <u>10061</u>, <u>10064</u>.which are rejected.
- b. There is no record of Mutation No. 10048 in his office.
- c. He does not know about overwriting as he has recently joined this office.

Statement of Shafiullah (Girdawar): (Flag D)

He stated that

- a. He has written parthal on the parth patwar of the mutation No. 10049, 10050, 10051, 10057, 10060, 10064, 10061. and 10048
- b. Parth sarkar of mutation No. 10049, 10050, 10051, 10057, 10060, 10064, 10061. and 10048 has signature of him but signature of him





does not exist on parth sarkar, which means that Parth Sarkars have been replaced. Over writing on page No. has also indicates that there is something wrong.

Statement of Tehsildar (Asmat Ullah):

He stated that:

- a. He rejected Mutation No. 10061, 10049, 10050, 10051, 10057, 10060, 10064, in Jalsa AAm as they were pending since long.
- b. Parthal of Girdawar was not quoted on the said mutations.

Statement of Mir Shah Ali Khan (partwari Bizan Khel) (Flag F) He stated that

- a. Difference in Page No. may also occur due to damages of pages.
- b. Difference in handwriting may also occur due to change of pen.
- c. Parthal of Girdawar is necessary on both i.e. parth Sarkar and Parth Patwar.
- d. After recording parthal mutation has been handed over to Patwari.

Statement of Amirullah (present Patwari Bizan Khel)

He stated that:

a. He stated that most of the land under question has been sold vide difference mutations.

Statement of Sabil (Partner of complainant) (Flag H)

He stated that:

- a. They have purchased 33 K land from Hanzada Khan, Qamar Zaman Khan Etc and amount has been paid to them.
- b. Rs. 26000/ as taxes have also been paid to Ayub Khan (Ex.Tehsildar) by hand.
- c. He does not know about revenue record whether the Patwari has attested the mutations or not.
- d. Later on he left partnership with complainant and now he has not concerned with the land.





Findings:

After going through the record and statements of the accused/Patwari, complainant & witness, it reveals that the accused Patwari change the Parth Sarkar of the mutation NO.10049, 10050, 10051, 10057, 10060, 10064. Further statement of complainant Mr. Gul Mar Khan seems genuine that he gives tax money to Patwari (Nafeerullah) in the presence of Mr. Aamir Humza at shamimly Hotel.

Recommendations:

Keeping in view track record of Nafirullah Patwari (presently dismissed in corruption cases & filled a writ petition in high court for his restoration), interesting on the same allegation and record, Azizullah Jan the-then AAC (Rev) Bannu, conduct an inquiry and come up with report on 20/03/2018 with the recommendation that the allegation of Gul Mar Khan seems to be genuine (Flag I).

Therefore, it is recommended that Mr. Nafeerullah the-then Patwari Mouza Bizan Khel seems to be guilty of changing Parth sarkar of Mutations no 10049, 10050, 10051, 10057, 10060, 10064. And Major penalty may be imposed on him according to E&D Rules 2011.

Report is submitted please.

ENQUIRY REPORT INTO THE ALLEGATIONS LEVELLED AGAINST MR.NAFEER ULLAH THE THEN PATWARI HALQA BIZEN KHEL TEHSIL DOMEL DISTRICT BANNU BY GUL MAR KHAN R/O DOGAR UMERZAI TEHSIL DOMEL

The Deputy Commissioner, Bannu appointed the undersigned as an Inquiry Officer vide charge sheet and statement of allegation bearing No.7330/DC/AE dated 27.11.2019 to conduct inquiry into the allegations regarding guilty of changing Parth Sarkar of mutations on account of illegal gratification.

Summary of the case

One Mr.Gul Mar Khan s/o Bostan Khan r/o Dogar Umerzai Tehsil Domel District Bannu complained that Mr.Nafeerullah Khan the then Patwari Halqa Bizen Khel Tehsil Domel had changed the Parth Sarkar of Mutations No.10049, 10050, 10057, 10060 & 10064 on account of illegal gratification. Accordingly, the Additional Deputy Commissioner, Bannu probe into the allegations which were proved to be genuine upon which he recommended award of major penalty to the accused Patwari.

Proceedings

In order to ascertain factual position and to record statements, the complainant, all stakeholders and the accused Patwari Mr.Nafeerullah were summoned on 10.12.2019 at 11.30 am and 3.00 pm vide letters No.4545-50/AC/F.5 dated 3.12.2019 and No.4551-52/AC/F.5 dated 3.12.2019 respectively. The eight number respondents who were summoned through Patwari concerned did not attend this office despite of the facts that they were informed by the Patwari well in time vide Annex-A. The complainant (Gul Mar Khan), Asmatullah, the then Tehsildar Domel (now retired), Asghar Khan, the then Office Kanungo Tehsil Domel (now HVC Commissioner's office), Shafiullah the then Girdawar Circle Tehsil Domel (now retired) Mir Shah Ali Khan, the then Patwari Halqa Bizen Khel attended this office and their statements were recorded which are reproduced as follows:-

Statement of the complainant (Gul Mar Khan)

In his written statement at Annex-B, the complainant Gul Mar Khan has stated that he had already given statement to ADC Bannu in the said inquiry and his current statement is the same.

In his previous statement (Annex-C), the complainant stated that he purchased 52 Kanal land @ Rs.26000/- per kanal located in Mauza Chak

Shaheed Tehsil Domel and paid Rs.10,00,000/, to the seller on the spot while as per commitment the outstanding balance will be paid during the time of mutation. He further stated that three Parth Sarkar of mutations No.10048, 10061 & 10064 were found pending while the other Parth Sarkar of mutations No.10049, 10050, 10051, 10057 & 10060 were missing which were later-on presented by the concerned Patwari and the serial number of the said parth Sarkar of Mutations do not match with the Parth Patwar of the said mutations. The complainant also stated that the said parth sarkar of mutations No.10049, 10050, 10051, 10057 & 10060 were bogus and not original.

The complainant therefore requested that necessary legal action may be taken against the concerned Patwari.

Statement of the then Tehsildar Domei (Asmatullah)

In his written statement at Annex-D, Mr. Asmatullah, the then Tehsildar Domel (now retired) has stated that he had given the statement to the Additional Deputy Commissioner Bannu on 1.1.2019 about Mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10064 Mauza Bizen Khel and his current statement is the same.

In his previous statement (Annex-E), the then Tehsildar stated that:-

- (1) Mutations No.10049, 10050, 10051, 10057 & 10060 which were lying since 2012 and no action was taken on it were rejected in
- (2) Since the mutations were old, therefore, the same were rejected.
- (3) The concerned Patwari prepared detail of rejected mutations which were rejected in Jalsa-e-Aam.
- (4) There was no verification report of Girdawar Circle on Parth Sarkar.
- (5) When there was no verification report available on parth sarkar, then how can signature of Girdawar Circle exist?
- (6) Mutations No.10061 & 10064 were rejected in Jalsa-e-Aam on 22.1.2018 while mutation No.10048 was still pending and was presentwith concerned Patwari Halqa.

Statement of the then Office Kanungo Tehsil Domel (Asghar Khan)

In his written statement at Annex-F, Mr. Asghar Khan, the then Office Kanungo Tehsil Domel (now HVC Commissionerate Bannu) has stated that he had given the statement in the inquiry of Nafeer to the then Additional Deputy Commissioner Bannu about Mutation No.10049 etc and his statement is the same.

In his previous statement (Annex-G), the then office Kanungo stated that he had brought register of mutations of Mauza Bizen Khel and presented photocopies of rejected Parth Sarkar of Mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10064. He further stated that Parth Sarkar of Mutation No.10048 was not available in the office of Kanungo Tehsil Domel. He also

stated that serial numbers of Parth Sarkar of mutations No.10050, 10051, 10057 & 10060 had been overwritten which is not known to him that who had do it.

Statement of the then Girdawar Circle Tehsil Domel (Shafiullah Khan)

In his written statement at **Annex-H**, Mr. Shafiullah Khan, the then Girdawqar Circle Tehsil Domel (now retired) has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement (Annex-I), the then Girdawar Circle had stated that his signatures were exist on Parth Patwar and Parth Sarkar of Mutations No.10048 and 10061 while his signatures on Parth Patwar of mutations No.10049, 10050, 10051, 10057 & 10064 are exist but the same on Parth Sarkar were not exist. He also stated that the serial number of the Parth Patwar and Parth Sarkar does not clear and accurate which make that suspicious.

He further stated that when Girdawar Circle sign (verification report) parth patwar then he also sign the parth sarkar which shows that the pages of parth sarkar had been changed.

Statement of the then Patwari Halqa Bizen Khel (Mir Shah Ali Khan)

In his written statement at Annex-J, Mr.Mir Shah Ali Khan, the then Patwari Halqa Bizen Khel (now Patwari Mauza Aral-I Tehsil Domel) has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement (Annex-K), the then Patwari had stated that difference in page number occurred due to damages of pages while difference in hand writing occurred due to change of pen. He further stated that parthal of Girdawar was necessary on both i.e. parth sarkar andn parth patwar and after recording parthal, mutation handed over to Patwari.

Statement of the present Patwari Halqa Bizen Khel (Amirullah Khan)

In his written statement at Annex-L, Mr.Amir Ullah Khan, Patwari Halqa Bizen Khel has stated that he had given statement earlier in this case, that is still his statement.

In his previous statement given to the ADC Bannu (Annex-M), Mr.Amirullah Khan has stated that he had brought himself parth sarkar & parth patwar of Mutation No.10048 while parth patwar of mutations No.10049, 10050, 10051, 10057, 10060, 10061 & 10062, for perusal. He further statedthat most of the land in question had been sold vide above mutations.

Affested

Statement of the accused Patwari (Nafeerullah Khan)

In his statement (Annex-N), Mr.Nafeerullah Khan, the then Patwari Halqa Bizen Khel Tehsil Domel has stated that he had entered mutations No.10048, 10049, 10050, 10057, 10060, 10061 & 10064 Mauza Bizen Khel-I Tehsil Domel of the complainant on 24.5.2012 and the Girdawar Circle made parthal on parth patwar. He further stated that the complainant (Gul Markhan) produced only sellers of mutation No.10048 while the sellers of other mutations did not produced to Girdawar Circle and Tehsildar since 2012 todate out of which mutations No.10048, 10061 & 10064 were still pending while other mutations were rejected by the Revenue Officer on 30.6.2017 due to absence of sellers.

The accused Patwari further stated that neither he had taken any tax amount from anyone nor it is his job. He also stated that he did not take any amount for any officer.

He further stated that the complaint of the complainant is baseless as the complainant made false accusations on him in the complaint. The accused Patwari therefore requested that since he is innocent, therefore, the complaint of the complainant may please be filed.

Findings:

After thorough probing into the matter and going through the record and statements, it revealed that the accused Patwari (Nafirullah) has acted in an irresponsible manner about the missing of parth sarkar of the mutations and later-on presented by the accused Patwari but the serial number of the said parth sarkar of mutations were not match with the parth patwar of the said mutations. The accused Patwari prepared bogus mutations for the complainant. The complaint of the complainant seems to be genuine.

Recommendations:

Keeping in view the above, It is recommended that:-

(a) Mr. Nafeerullah, the then Patwari Mouza Bizen Khel, Tehsil Domel may be awarded major penalty.

(b) Any relief regarding preparation of fresh mutations of the disputed landed property cannot be granted by this office for which he should file appeal in the proper forum.

That in 2012 I was transferred and one Mr. Mushtaq Hussain was appointed as Patwari Halqa Moza Bizan Khel District Bannu and it was 2017 I was again posted as Patwari Halqa Moza Bizan Khel and the complaint has been filed on 17/01/2018. it is partenaint to mention that during 2011 till 2017 and 2018 several Patwaris, other than me, has been transferred and posted as Patwari Halqa Bizan Khel and the official record regarding the above mentioned mutations remained in the custody of several Patwaries. It is not certained nor has been fixed, during the inquiry proceeding that in whos duration the alleged changing cuttings, over writing, manufacturing has been made.

That the inquiry officer has failed to conduct the inquiry in accordance with law because it was necessary, to fix liability/responsibility, to summon all the patwaries who remained as patwari halqa Moza Bizan Khel Bannu and to

RECEIVED record their statements in this regard.

That I, entered the above mentioned mutations both in Parth-e-Patwar Commissioner Office Ban and Parth-e-Sarkar in my hand writing and in accordance with law. I have no concern with the latter changing/manufacturing of Parth-e-Sarkar. To fix the responsibility about the latter on changing/manufacturing of Parth-e-Sarkar, it was a legal requirement to take signature and hand writing specimen from all the persons who remained Patwari Halqa Moza Bizan Khel District Bannu but the inquiry officer failed to do so, hence the inquiry officer acted against the law and

settled principles of inquiry. The inquiry conducted by the inquiry officer cannot be termed as fair and impartial inquiry.

It is important to mention that the inquiry officer failed to provide opportunity of cross examination to me Vis-à-Vis statement of complainant etc which is illegal and no proposed penalty can be imposed upon its basis.

That no meaningful opportunity of defence was provided to the undersigned in the whole process of conducting inquiry. Inquiry was completed in mechanical manner without adhering to the principles of natural justice which are part and parcel of all judicial, quasi-judicial and executive proceedings. The mandatory provisions of Article-10-A of the constitution which in essence speaks about the due process of law, had also been violated, beside this, I was discriminated and has not been treated in accordance with the mandate of articles 4 and 25 of constitution of Islamic Republic of Pakistan. So much so that the inquiry officer even miserably failed to fix responsibilities Vis-à-vis various provisions of land record manuals, therefore, the inquiry cannot be termed as a regular inquiry rather the same was conducted in a manner to make space and room for the real accused.

That explanation given above by me are sufficient to justify that I am innocent and recommendation given by the inquiry officer to the effect to remove me from service is highly unjustified, illegal and cannot be justified on the basis of available record by applying its independent/unbiased mind.

Keeping in view what has been stated above I am being innocent may kindly be exonerated from the alleged baseless allegations and allow to perform my duties with all back benefits.

WHEREAS, Mr. Nafeer Ullah (then Patwari Halqa Bizan Khel) Tehsil Domel, District Bannu was proceeded under E&D rules for allegations of changing the 'Parth Sarkar' of mutation no. 10049, 10050, 10057, 10060 and 10064 and preparing bogus mutations (Parth Patwar & Parth Sarkar of which do not tally with each other) on complaint/allegation levelled by Gul Mar Khan, R/O Dogar Umerzai, Tehsil Domel, Bannu within the meaning of Rule-3 (b) & (c) of the Khyber Pakhtunkhwa Govt. Servant (Efficiency & Discipline) Rules, 2011 during his posting as Patwari Halqa Bizan Khel, Tehsil Domel, Bannu.

WHEREAS, all legal formalities were completed. Proper Charge Sheet and Statement of Allegations as well as proper show-cause notice were issued to the said Patwari and opportunity of personal hearing by the undersigned was provided as evident from show cause notice No. 1615/AE/BC dated 05/03/2020, his detailed reply to show cause notice during personal hearing before the undersigned, dated 18/03/2020 and notice for personal hearing No. 2727/DC/AE/BC dated 03/07/2020 and attendance sheet dated 08/07/2020.

WHEREAS, the said Patwari was also proceeded under E&D rules in another case for allegation of taking illegal gratification from one Uzair Aslam R/O Mitaki Bizan Khel, Tehsil Domel within the meaning of Rule-3 (b) & (c) of the Khyber Pakhtunkhwa Govt. Servant (Efficiency & Discipline) Rules, 2011 during his posting as Patwari halqa Landidak, Tehsil Baka Khel.

AND WHEREAS, ongoing through the record, including written defense of the said employee before the inquiry officers, as well as his verbal and written defense/statements before the undersigned during his personal hearings, I am satisfied that the said employee had committed the said offences thus found guilty under Rule-3(b) & (c) accordingly and the guilt/allegations have been proved without any shadow of doubt.

I, (Zubair Khan Niazi, Deputy Commissioner Bannu), as competent authority, hereby impose major penalty of "Removal from Service" as provided under rule 4 (b)(iii) of Khyber Pakhtunkhwa Govt. Servants (Efficiency & Discipline) Rule 2011 on Mr. Nafeer Ullah, Patwari with immediate effect.

Since, the complainants sustained heavy losses, hence, they may contact proper legal forum/Civil Court for compensation of their losses. Moreover, the complainant Gul Mar Khan, may also approach concern quarters for preparation of fresh mutation of disputed landed property to proper legal forum accordingly.
