

JUDGMENT

ROZINA REHMAN, MEMBER (J): The appellant has invoked the
jurisdiction of this Tribunal through above titled appeal with the prayer
as copied below:


**“It is humbly prayed that that the impugned order of
respondent No.3 dated 09.10.2019 may please be set
aside for the end of justice and the appellant may
please be graciously restored to the rank as before
with all back benefits.”**



2. Brief facts of the case are that appellant was charged for leaving his place of posting without any information/permission, therefore, he was proceeded against departmentally for willful absence from lawful duty. He was charge sheeted and was properly served with charge sheet alongwith statement of allegations. Inquiry Officer was appointed and after submission of inquiry report, he was reverted from the rank of Officiating Sub Inspector to the rank of Assistant Sub Inspector vide impugned order dated 09.10.2019. Feeling aggrieved, he filed departmental appeal which was not responded to, hence, the present service appeal.


3. We have heard Syed Mudasir Pirzada Advocate for appellant and Muhammad Adeel Butt, learned Additional Advocate General for the respondents and have gone through the record and the proceedings of the case in minute particulars.

4. Syed Mudasir Pirzada Advocate, learned counsel appearing on behalf of appellant, inter-alia, submitted that the impugned order is illegal, against law and facts as the appellant was not treated according to law and rules. Learned counsel further submitted that the appellant was served with charge sheet alongwith statement of allegations which was properly replied but the same was not taken into consideration and the proceedings were conducted against appellant; that there is nothing on record which could connect the appellant with the allegation; that no show cause notice was ever served upon appellant nor the inquiry report was issued to the appellant and he was not given ample opportunity of cross-examination. He contended that his car was taken away by his



younger brother from the police post and his mobile phone bearing No. 0333-9609176 was lying in the dashboard of the car but he was proceeded against departmentally on the strength of CDR in respect of that mobile which was lying in the dashboard. Learned counsel further contended that no proper inquiry was conducted in order to unearth the hidden facts regarding the presence and availability of the appellant in the concerned police post and that no witness was examined in this regard. He produced copies of different reports registered on behalf of the present appellant while present in the police post. Similarly, different Mudd reports were provided in respect of presence of appellant on spot with submission that the entire record was not taken into consideration by the respondents. He, therefore, requested for acceptance of the instant appeal.

5. Conversely learned AAG submitted that the appellant was posted as Incharge of a most sensitive police post Shadi Khel of Police Station Bilitang, Kohat. That he left the Police Post without permission and being the most sensitive area of his jurisdiction was left at the mercy of his subordinates/constables. On taking action of the act of appellant, departmental inquiry was initiated against him under the relevant rules. Call Data Record of the appellant was obtained, wherein, the location of appellant was ascertained in different parts of the city which established that he had left his place of posting without any information/permission of his superiors. He further submitted that appellant was served with proper charge sheet alongwith statement of allegations and that proper inquiry was initiated against him. He contended that he was afforded all opportunity of defense including




personal hearing but he failed to submit any plausible explanation and that all the codal formalities were fulfilled before awarding the punishment. He, therefore, requested for dismissal of the instant appeal.

6. From the record, it is evident that appellant Nasir Abbas was posted as Incharge of Police Post Shadi Khel of P.S Bilitang, Kohat. The allegations are in respect of his absence from his place of posting. In this regard, Call Data Record of the appellant was obtained. Charge sheet alongwith statement of allegations are available on file. He was charged for having committed the following acts/omissions:


- i. *It was reported that you usually leave your place of posting without any information/permission, which amount to willful absence from lawful duty.*
- ii. *Pertaining as per CDR, your location on different date was found out at Kohat City and District Swat, which speaks that you had left your place of duty and proceeded out of station/district without any information.*

7. For the purpose of scrutinizing the conduct of the appellant with reference to the above allegations, DSP Lachi Muhammad Inam Jan was appointed as Inquiry Officer. The charge sheet is silent in respect of proper date and time. Similarly, his cell number has not been mentioned therein. Inquiry report is available on file and during inquiry, Call Data Record of 0333-9669173 used by appellant was examined. CDR available on record shows that it was in respect of




Mobile number 0333-9669176. So, the Inquiry Officer did not take into consideration the relevant CDR rather a wrong number was mentioned in the Inquiry Report which was never taken into consideration even by the competent authority while imposing punishment. The respondents have annexed the statement of Khan Akbar Moharrir of Police Post Shadi Khel which goes in favor of the appellant and he did not deny the presence of the appellant. One of the main contention of learned AAG is that as the appellant was serving as Officiating Sub-Inspector, who was reverted to his substantive rank of ASI, which is not a punishment in view of Rule-4 (2) (b) of Police Rules, 1975, therefore, the appeal in hand is not maintainable. The contention so raised by the learned AAG is misconceived. The appellant was serving as Officiating Sub-Inspector and his reversion to substantive rank of Assistant Sub-Inspector was by way of penalty entailing consequences in the shape of attaching of stigma as well as loosing of seniority etc. Moreover, in view of Rule-4 (2) (b) of Khyber Pakhtunkhwa Police Rules, 1975, reversion from an officiating rank is not a punishment but even then the competent Authority has reverted the appellant from the rank of Officiating Sub-Inspector to the rank of Assistant Sub-Inspector considering the same as punishment. In the given circumstances, the appeal filed by the appellant is maintainable.


8. In view of the above discussion, the appeal in hand is allowed by setting-aside the impugned order and the appellant is restored to the rank of Officiating Sub-Inspector with all consequential benefits.



Parties are left to bear their own costs. File be consigned to the record room.

With great veneration the instant appeal is preferred by the appellant on the following grounds:-

Facts:

1:-Briefly facts as per alleged in impugned order that the appellant usually left his place of posting without any information /permission which amounts to willful absence from lawful duty.

~~filed to day~~ That the allegation pertaining as per CDR location on the different dates mention in impugned order and after then the charge sheet was issued wrongly mentioned that the appellant was called in orderly room and reverted the appellant without any law ful justification (Copy of Impugned order is annexed as annexure A).

That appellant was served with the charge sheet along with statement of allegation and the appellant had properly submitted his reply which was deliberately not consider nor discussed in impugned order and proceeding were conducted against the appellant.(Copy of Charge sheet & reply along with Daily roznamcha report is annexed as annexure B)

That there is nothing is on the record which connect the appellant with the allegation nor proved and the appellant is blessed with impugned punishment which not warranted by law.

That No Show cause Notice nor any Final Show cause Notice were served to appellant nor any so called enquiry findings report has been issued to appellant

That an unjust has been done with the appellant by not giving ample opportunity of cross examination as well as not heard in person nor properly enquired the allegation and ex-parte proceedings conducted against the appellant without probing held guilty the appellant without following the prescribed rules relating to enquiry proceedings as per Police Rules 1975 (amended 2014).

That all the allegations mentioned in the impugned order are base less and the appellant have been vexed for some other issues and the appellant is well aware about the fact .

That the appellant youngest brother namely Hafeez Hassan took the car of the appellant from the police post and appellant cell bearing number 0333-9609176 were in DashBoard of the car later the appellant realized that the cell of the appellant is left with in the car.

That the appellant was also in possession of another cell number which is still in use of appellant bearing number 0346-5565474 but the CDR the and nothing has been proved beyond any shadow of doubt that the appellant has committed any misconduct or tarnished the image of Police department.

That there are numerous good entries in the service record of the appellant which could be verified but this fact has not been taken in consideration while awarding the major punishment which is against to the canon of justice.

That the appellant was neither provided an opportunity to cross examine the witnesses nor to produce defense evidence and the enquiry proceedings accordingly defective. Furthermore the requirements of rules regarding enquiry have not been observed while awarding the impugned punishment.

That the appellant dragged unnecessarily into litigation which is clearly mentioned in 2008 SCMR 725.

That while awarding the impugned major punishment the enquiry report has not been given to the appellant which is very much necessary as per 1991 PLC CS 706 & PLC 1991 584.

That time and again un just has been done with the appellant by not considering nor entertaining the departmental representation till to date which shows the personal bias ness on the part of respondent's above (Copy of departmental representation is annexed as annexure C)

Grounds:

- a. That no enquiry has been conducted none from the general public/official of PS was examined in support of the charges leveled against the appellant. No allegation mentioned above are practiced by the appellant nor proved against any cogent reason against the appellant.

- b. That the appellant was neither intimated nor informed by any source of medium regarding enquiry proceedings for any disciplinary action which shows bias on the part of quarter concern.
- c. That the appellant was not heard in person nor called in orderly room and falsely mentioned in the impugned order that the appellant was called because the when the expertly proceedings were conducted then how could it possible that the appellant was heard and called for orderly room which does not appeal to a prudent mind .
- d. That it is not ascertainable that what element had promoted the competent authority to award punishment to the appellant in hasty manner.
- e. That as per the constitution of Islamic Republic Of Pakistan clearly speaks about the fundamental rights that the fair and transparent enquiry is the right of any employee.
- f. That the punishment is harsh in nature and the appellant is vexed for undone single offence which is against the constitution of Islamic republic of Pakistan 1973.
- g. That the appellant is honest and dedicated one and leave no stone unturned to discharge his duties.
- h. That as per universal declaration of human rights 1948 prohibits the arbitral / discretion.
- i. That the respondent No-3 Kohat has acted whimsically and arbitrary, which is apparent from the impugned order.
- j. That the impugned order is not based on sound reasons and same is not sustainable in the eyes of law. The same is based on wrong assumption of facts.
- k. That the departmental enquiry was not conducted according to the rules.
- l. That the impugned order is outcome of surmises and conjecture.

Pray:

In the view of above circumstances it is humbly prayed that the impugned order of respondent No-3 date 09-10-2019 Kohat may please be set aside for the end of justice and the appellant may please be graciously restored to the rank as before with all back benefits.

ORDER

This order is passed on the departmental enquiry against Offg: SI Nasir Abbas Noori under the Khyber Pakhtunkhwa, Police Rules, 1975 (amendment 2014).

Brief facts of the case are that it was reported that the accused official usually left his place of posting without any information / permission, which amounts to willful absence from lawful duty. Therefore, call data record of the accused official was checked.

Pertaining as per CDR, location on different date was found out of his place of posting and on different date were found at district Swat, which established that the accused official has left his place of posting and proceeded out of station / district without any information / permission.

In this regard charge sheet alongwith statement of allegation was issued to the accused officer and SDPO, Lachi Kohat was appointed as enquiry officer to scrutinize conducted of the accused official. Enquiry officer submitted finding report and found him guilty of the charges. Furthermore, the undersigned had satisfied from the secret probe, CDR and the charge leveled against the accused official was established beyond any shadow of doubt.

However, the accused official was called in Orderly Room, held on 01.10.2019 to explain his conduct. The accused official denied the charge leveled against him. Therefore, in order to meet end of justice, the matter was verified through other source, which transpired that the accused official remained out of station.

In view of above, CDR and secret probe I have reached to the conclusion that the accused official usually remained out of station and district on different occasion as evident from CDR without any permission, which amounts to willful absence from lawful duty and left the Police post at the mercy of his subordinates. In these circumstances any mishap and embarrassment was not ruled out. Therefore, in exercise of powers conferred upon me offg: SI Nasir Abbas Noori is hereby reverted from Offg: Sub Inspector to the rank of Assistant Sub Inspector with immediate effect.

The enquiry officer shall in accordance with provision of the Police Rule-1975, provide reasonable opportunity of hearing to the accused official, record his findings and make, within twenty five days of the receipt of this order, recommendations as to punishment or other appropriate action against the accused official.

With great veneration the instant appeal is preferred by the appellant on the following grounds:-

Facts:

1:- Briefly facts as per alleged in impugned order that the appellant usually left his place of posting without any information /permission which amounts to willful absence from lawful duty.

2:- That the allegation pertaining as per CDR location on the different dates mention in impugned order and after then the charge sheet was issued wrongly mentioned that the appellant was called in orderly room and reverted the appellant without any law ful justification .

That appellant was served with the charge sheet along with statement of allegation and the appellant had properly submitted his reply which was deliberately not consider nor discussed in impugned order and proceeding were conducted against the appellant.

That there is nothing is on the record which connect the appellant with the allegation nor proved and the appellant is blessed with impugned punishment which not warranted by law.

That an unjust has been done with the appellant by not giving ample opportunity of cross examination as well as not heard in person nor properly enquired the allegation and ex-partly proceedings conducted against the appellant without probing held guilty the appellant without following the prescribed rules relating to enquiry proceedings as per Police Rules 1975 (amended 2014).

That all the allegations mentioned in the impugned order are base less and the appellant have been vexed for some other issues and the appellant well aware about the fact .

That the appellant youngest brother namely Hafeez Hassan took the car of the appellant from the police post and my cell bearing number 0333-9609176 were in DashBoard of the my car later the appellant relized that the cell of the appellant is left with in the car .

That the appellant was also in possession of another cell number which is still in use of appellant bearing number 0346-5565474 but the CDR the and nothing has been proved beyond any shadow of doubt that the appellant has committed any misconduct or tarnished the image of Police department.

That there are numerous good entries in the service record of the appellant which could be verified but this fact has not been taken in consideration while awarding the major punishment which is against to the canon of justice.

That the appellant was neither provided an opportunity to cross examine the witnesses nor to produce defense evidence and the enquiry proceedings accordingly defective. Furthermore the requirements of rules regarding enquiry have not been observed while awarding the impugned punishment.

That the appellant dragged unnecessarily into litigation which is clearly mentioned in 2008 SCLR 725.

That while awarding the impugned major punishment the enquiry report has not been given to the appellant which is very much necessary as per 1991 PLC CS 706 & PLC 1991 584.

Grounds:

- a. That no enquiry has been conducted none from the general public was examined in support of the charges leveled against the appellant. No allegation mentioned above are practiced by the appellant nor proved against any cogent reason against the appellant.
- b. That the appellant was neither intimated nor informed by any source of medium regarding enquiry proceedings for any disciplinary action which shows bias on the part of quarter concern.
- c. That the appellant was not heard in person nor called in orderly room and falsely mentioned in the impugned order that the appellant was called because the when the expertly proceedings were conducted then how could it possible that the appellant was heard and called for orderly room which does not appeal to a prudent mind .
- d. That as per the contents of allegation in the show cause notice and the impugned order a different with each other.
- e. That it is not ascertainable that what element had promoted the competent authority to award punishment to the appellant in hasty manner.
- f. That as per the constitution of Islamic Republic Of Pakistan clearly speaks about the fundamental rights that the fair and transparent enquiry is the right of any employee.

- g. That the punishment is harsh in nature and the appellant is vexed for undone single offence which is against the constitution of Islamic republic of Pakistan 1973.
- h. That the appellant is honest and dedicated one and leave no stone unturned to discharge his duties.
- i. That as per universal declaration of human rights 1948 prohibits the arbitral / discretion.
- j. That the DPO Kohat has acted whimsically and arbitrary, which is apparent from the impugned order.
- k. That the impugned order is not based on sound reasons and same is not sustainable in the eyes of law. The same is based on wrong assumption of facts.
- l. That the departmental enquiry was not conducted according to the rules.
- m. That the impugned order is outcome of surmises and conjecture.

Pray:

In the view of above circumstances it is humbly prayed that the impugned order of DPO date 09-10-2019 Kohat may please be set aside for the end of justice and the appellant may please be graciously restored to the rank as before with all back benefits.

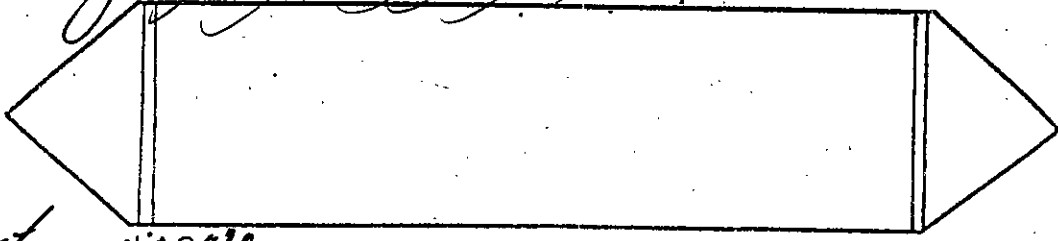



Parawise comments are submitted as under:-

Preliminary Objections:-

- i. That the appellant has got no cause of action.
- ii. The appellant has got no locus standi.
- iii. That the appeal is bad in eyes of law and not maintainable.
- iv. That the appellant has not approached the honorable Tribunal with clean hands.
- v. That the appellant is estopped to file the instant appeal for his own act.
- vi. That order of respondent No. 2 passed on departmental appeal of the appellant is not questioned by the appellant.
- vii. That the appeal is not maintainable as, the appellant was reverted from the rank of officiating sub inspector, to his substantive rank of ASI and such reversion is not a punishment.
- viii. The appeal of the appellant is badly time barred.

Facts:-

1. The appellant (officiating sub inspector) was posted as incharge of a most sensitive Police Post Shadi Khel of Police station Bilitang, Kohat. Usually, he left the Police post without any permission / leave. Being most sensitive area of his jurisdiction was left at the mercy of his subordinates / constables. On taking notice of the act of appellant the respondents No. 3 initiated departmental inquiry against him under the relevant rules.
2. The appellant usually remained out of his place of posting / station. In this regard the respondent No. 3 obtained Call Data Record of the appellant, wherein the location of appellant was ascertained in different parts of the city / district, which established that he had left his place of posting without any information / permission of his superiors. Copy of CDR is **annexure A**.

Correct, to the extent that the appellant was served with charge sheet with statement of allegations mentioned therein that a regular inquiry was initiated against him. Copy of Charge sheet enclosed as **annexure B**.

Incorrect, there is documentary evidence annexure A, wherein the charges / allegations leveled against the appellant have been proved.

Incorrect, the appellant received and submitted reply to the charge sheet, but found unsatisfactory. Furthermore, he was associated with inquiry proceedings and personally heard by respondent No. 3. Copy of inquiry report is **annexure C**.

Incorrect, the appellant was afforded all opportunities of defence including personal hearing by the respondent No. 3, but he failed to submit any plausible explanation. As evident from the order, the matter was verified besides the report of the inquiry officer and the charge leveled against the appellant was established through documentary proof.

Incorrect, the allegations/ charges leveled against the appellant were established during regular inquiry.

The stance taken by the appellant is incorrect, as it is evident from CDR that he remained out of station and his location was found at district Swat from where he constantly remained in contact with Police Post staff.

Incorrect, the charges leveled against the appellant were established beyond any shadow of doubt. All the codal formalities have been fulfilled.

Grounds:-


- a. Incorrect, proper departmental proceedings were initiated against the appellant and the charges / allegations leveled against the appellant have been proved beyond any shadow of doubt.


- c. Incorrect, reply submitted in paras of the facts.

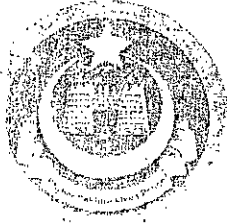

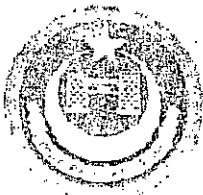


Enquiry was conducted. During enquiry following steps were taken.

During enquiry SI Nasir Abbas disclosed that his brother who has returned from Dubai has taken his car and has visited district Swat while his (Nasir Abbas) mobile remained in car and was in his brother's possession. SI Nasir Abbas has also produced entries in daily diary and FIRs in his favour but from the status of CDR regular contacts have been made with PP Staff, which reveals that he himself has visited Swat. If his brother has taken mobile, then there in no logic for regularly contacting PP Staff.

Keeping in view the above observation I am of the opinion that charges made against SI Nasir Abbas are based on facts and **he has been found guilty of misconduct. He is therefore recommended for suitable punishment.**

2. By reasons of the above, you appear to be guilty of misconduct under Rule 3 of the Rules ibid and have rendered yourself liable to all or any of the penalties specified in the Rule 4 of the Rules ibid.

3. You are, therefore, required to submit your written statement within 07 days of the receipt of this Charge Sheet to the enquiry officer.

Your written defense if any should reach the Enquiry Officer within the specified period, failing which it shall be presumed that you have no defense to put in and ex-parte action shall be taken against you.

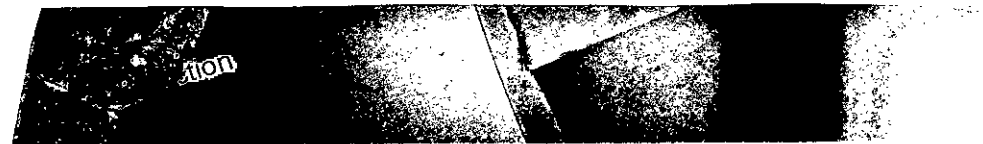

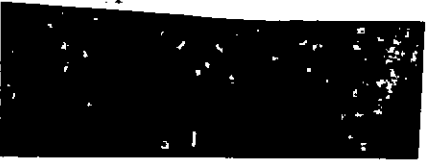
