Nihad Ali. A report to this effect was lodged vide DD No.10 dated 25-06-2019 at Traffic Office Mardan by Traffic Incharge Amjid Khan. Consequently, proper departmental enquiry proceedings were initiated against him. He was issued charge sheet alongwith statement of allegations and enquiry was entrusted to Mr. Mushtaq Ahmad, Superintendent of Police Operations Mardan. The Enquiry Officer after fulfilling necessary formalities, submitted his finding report and recommended the delinquent official for suitable punishment.
