



Arguments of learned counsel for the appellant heard. It was contended that the appellant is aggrieved of the impugned order of competent authority dated 16.09.2019 whereby major penalty of "dismissal from service" was imposed on him. The appellant challenged the same in his departmental appeal on 09.10.2019 which was rejected vide order dated 25.06.2020. The appellant preferred revision petition under Rule-11-A of the Police Rules 1975 However, the same is not available on case file whereby his major penalty of dismissal from service stands converted into minor penalty of "forfeiture of two years approved service" and "the intervening period to be treated as leave without pay", vide order on revision petition dated 29.10.2020

Let pre-admission notice to the Additional Advocate General be issued to assist the Tribunal on the issue. Adjourned to 01/07/2021 for further proceedings before S.B.
