



PRELIMINARY OBJECTIONS.

- 1. That the Appellant has not come to the Tribunal with clean hands.
- 2. That the Appellant has no cause of action /Locus standi.
- 3. The Appellant is not an aggrieved person within the meaning of article 199 of the constitution of Islamic Republic of Pakistan.
- 4. That the Appellant has been stopped by her own conduct to file the instant Appeal.
- 5. That the Appeal is bad due to the non-joinder of necessary parties.

FACTS

- 1 Para No.1 pertains to the personal information of the appellant and hence needs no comments.
- 2 Pertains to the office record hence needs no comments.
- 3. incorrect, The transfer order issued vide this office Endst.No.762-64 dated 5/3/2020 was issued by the District Education Officer Female during the period when there was ban on transfer/posting in Education Department due to the implementation of E-Transfer Policy w,e,f 1/8/2019 and has been withdrawn by the competent authority on 6/3/2020.
- Incorrect. The appellant had submitted application to the District Education Officer Female Upper Dir on 12/9/2020 and she was informed in written by the District Education Officer Female Upper Dir that the Transfer order was issued by the Ex-DEO Mst. Habiba Bibi and has withdrawn by her on very next day and the DEO (F) working presently is bound to implement the Govt. policy in letter and spirit in which the transfers/postings are allowed in the month of March only.

The Departmental Appeal should have been submitted to the next higher authority Director Elementary and Secondary Education Department Khyber Pakhtunkhwa Peshawar but the appellant has not submitted the same to the next higher authority.

No Comments.

GROUNDS

- (A) Incorrect. There is no violation of law and rules but the order issued in violation of law has been withdrawn by the competent authority and the act of the respondents in accordance with law and rules.
- (B) Incorrect. The impugned order is in accordance with law and rules.
- (C) Incorrect. The transfer order was issued in violation of E-Transfer policy and had been withdrawn by the competent authority. The appellant has kept her self silent deliberately despite the fact that she was aware that her transfer order has been withdrawn. The appellant was told by the SDEO Wari that you are performing your duty illegally in GGPS Mula Paw and reported the teacher to DEO Female for disciplinary action by not obeying the order of the competent authority. (Photocopy of the report of SDEO Wari is annexed as A). An explanation was called by the DEO Female and as a response the appellant produced the order sheet of this Honorable Tribunal dated 10/12/2020. Report of SDEO Wari regarding Teacher student ratio of GGPS Shang and GGCMS Mula Paw is (annexed as B)
- (D) Incorrect. As already stated that the transfer order having Endst. No 762-64 dated 5/3/2020 was issued in violation of E-Transfer Policy and the withdrawal of the same order was in accordance with policy and rules.
 - (E) Incorrect. As stated in Para No C above.
 - (F) No Comments.
 - (G) The respondents also seek permission of this Honorable Tribunal to produce additional grounds during the arguments.

It is therefore humbly prayed that keeping in view of the above made humble submission, the instant appeal may graciously be dismissed in favor of the answering respondents with cost please.
