The issue placed for adjudication before this Tribunal as per respective contentions of the learned counsel for the appellant is that, by ask respondents to modify posting Notification No. SO(Estt)FE&WD/V-8/2014 dated 16.01.2020 with the direction that the appellant may be appointed in BS-18 as Wild Life Management Specialist instead of own pay scale (OPS) as admitted whereas the post of BS-18 is vacant besides vacancy of other posts, it was contended by the learned counsel that appellant rendered long 13 years of services simultaneously having higher qualification, experience, seniority and unambiguous recommendation for promotion of the appellant being made by four senior members of anomaly committee.

The issue/matter agitated at the bar require proper adjudication in the light of law and rules on the subject particularly in the context of fact that formerly the department from which the appellant is hailing belonged to the Federal Government which devolved on the Provincial Governments after 18th Amendment in the Constitution of the Islamic Republic of Pakistan 1973, therefore, the appeal is admitted for regular hearing. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments. 
