

#### ..... RESPONDENTS

**APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA  
SERVICE TRIBUNAL ACT, 1974 AGAINST IMPUGNED MERIT LIST  
PROVIDED BY THE RESPONDENT NO. 3 WHEREBY APPELLANT HAS  
ILLEGALLY AND UNLAWFULLY BEEN PLACED AT SERIAL NO. 139  
INSTEAD OF SERIAL NO. 21 AND ON THE BASIS OF WHICH THE  
RESPONDENTS HAVE ASSIGNED THE SENIORITY OF THE  
APPELLANT'S CADRE AND AGAINST THE INACTION OF THE  
RESPONDENTS BY NOT DECIDING THE DEPARTMENTAL APPEAL  
WITHIN THE STATUTORY PERIOD OF NINETY DAYS.**

**PRAYER:**

That on acceptance of this appeal the impugned merit list of the respondent No. 3 to the extent of appellant and private respondents No. 5 to No. 121 may please be set aside and the respondents be directed to rectify the merit list according to the prevailing law and rules and thereafter be further directed to assign the seniority of the appellants cadre's accordingly to the rectified merit list throughout along with all back benefits. Any other remedy which this august Service Tribunal deems fit may also be awarded in favor of the appellant.

**R/SHEWETH:**

**ON FACTS:**

**Brief facts giving rise to the present appeal are as under:**

- 1- That the respondent No. 3 advertised different posts including the posts of Subject Specialist (SS) vide advertisement No. 02/98. That the appellant being eligible and qualified for the post of SS Maths, applied for that post. Copies of the educational testimonials are attached as annexure .....A
- 2- That the appellant qualified the test for the subject post and was called for interview by obtaining distinctive marks in the merit list prepared by the respondent No. 3 wherein the appellant was placed at serial No. 139 instead of serial No. 21 of that merit list and was duly appointed in the respondent department. That due to the ibid impugned merit list and seniority list the private respondents who were junior to the appellant have been placed senior to the appellant. Copies of the merit list and appointment order are attached as annexure .....B & C.
- 3- That respondents prepared the seniority and was based on the merit list assigned by the respondent No. 3 wherein the appellant was placed at serial No. 154 whereas the appellant was supposed to be placed at serial No. 44 of that seniority list if the above mentioned merit was rectified. Copy of the seniority list is attached as annexure .....D.
- 4- That due to depriving from the legal right of seniority, the appellant feeling aggrieved submitted a representation/ departmental appeal to the respondent No. 4 but the same has not been decided within the stipulate period of ninety days. Copy of the departmental appeals are attached as annexure .....E.
- 5- That appellant having no other remedy but file the instant service appeal on the following grounds amongst others.

**GROUND:**

- A. That by placing the name of appellant at Merit Order No. 139 instead of at Merit Order No. 21 and not deciding the departmental appeal is against the law, facts, norms of natural justice and rules on the subject, hence be set aside to the extent of appellant and private respondents.
- B. That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as

such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.

- C. That the respondents acted in arbitrary and mala fide manner by issuing the impugned merit whereby the appellant is without any reason was placed at serial No. 139 instead of serial No. 21.
- D. That the act and action of the respondents is discriminatory in nature as the private respondents marks were less than the appellant then how could they place the appellant at bottom of the private respondents.
- E. That under Article 38(e) of the Constitution of Pakistan 1973 state is bound to reduce disparity in the income and earning of the individuals including persons in the various service of Pakistan.
- F. That the impugned merit list followed by the seniority list is violative of section-8 of the civil servant Act, 1973 read with rule 17 of the appointment, promotion and transfer Rules, 1989.
- G. That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the appeal of the appellant may be accepted as prayed for.

MERIT LIST / ZONAL ALLOCATION / RECOMMENDATION

33. MERIT LIST.

- (1) When all the eligible candidates who applied in response to a particular advertisement have been interviewed, the Director Recruitment / Director Examination as the case may be, shall prepare a merit list as per the marks indicated on the evaluation sheet and submit the case for the Commission's consideration.
- (2) Merit list shall be prepared keeping in view the aggregate marks secured by various candidates.
- (3) When two or more than two candidates have secured equal marks in aggregate the candidate who has secured higher marks in the interview shall be marked senior. In case the marks in aggregate and also the marks in the interview are the same, the candidate who is older in age shall be placed senior to the one who is younger. In case all the above-mentioned factors are the same, marks obtained in the final examination of the prescribed qualification for the post shall be the deciding factor.
- (4) In the case of Competitive Examination the merit list shall be prepared in accordance with the laid down provisions of the syllabus of the respective service.

34. ZONAL ALLOCATION.

- (1) The zonal allocation of the vacancies shall be made in accordance with the zonal allocation formula wherever applicable.
- (2) Subject to Government Policy on zonal substitution, it is to be made, with prior approval of the Govt. due to deficiency of qualified candidates from the particular area(s). Such vacancies shall be filled in accordance with the proportionate ratio of

the zones given in zonal allocation formula as contained in Regulation 3(a) from among the qualified candidates of other zones appearing on the merit list.

### 35. RECOMMENDATIONS.

- (1) A decision about recommendations to be made shall be approved by the Commission irrespective of the fact as to whether the interviews had been conducted by a panel or by full Commission. After approval the Director concerned shall convey the recommendations to the concerned Department. In recommendations to the Department it shall be made clear that the inter-se-seniority of the recommendee is linked with other subjects and the overall merit position and zonal adjustment will be intimated on the completion of interviews in all subjects. The chronological order of the recommendees shall not confer any right of seniority.
  - (b). The combined merit list shall be against a particular advertisement where the posts were advertised collectively but recommendations were staggered due to interview schedule or any other reason.
