APPEAL UNDER SECTION 4 OF KHYBER TRIBUNAL PAKHTUNKHWA SERVICE ACT 1974, AGAINST THE IMPUGNED ORDER DATED 20.05.2022, WHEREBY SERVICE OF THE APPELLANT WAS RE-INTERVENING THE BUT INSTATED PERIOD I.E. 01.12.2017 TO 27.05.2022 "EXTRA INTO CONVERTED WAS ORDINARY LEAVE WITHOUT PAY"

Prayer in Appeal:

By acceptance of the instant Appeal, the impugned order dated 20.05.2022, may kindly be set aside partially to the extent of that the respondents department illegally, unconstitutionally converted the intervening period i.e. 01.12.2017 to 27.05.2022 of the appellant, into "Extra Ordinary Leave without pay" thus depriving the appellant from all back benefits for the said Period therefore, this Hon, ble tribunal may pleas be direct to the respondents department to convert the ibid period with pay, and granted/release his salaries of the ibid period with all back benefits.

Respectfully Sheweth:

- 1. That the petitioner is law abiding citizen and is permanent residing at the above stated address therefore, he is entitled for all the fundamental rights guaranteed by the law of land.(Copy of CNIC is attached as annexure A)
- 2. That the appellant was appointed as AT (Arabic Teacher) Male in District Hangu, and thereafter he was transferred to GHS Tori Banda, Hangu, and presently he is serving at GHS Azeeme Banda District Hangu, as AT (Arabic Teacher). (Copy of appointment order is attached as annexure B)
- 3. That on 15.02.2018, the appellant was illegally removed from his service due to absents of 17 days, upon which the appellant filed an Appeal before this Hon, ble Tribunal, which appeal was accepted vide in his order dated 12.08.2021 by this Hon, ble Tribunal and the case of the appellant was remand back to the respondents department for de-novo enquiry. (Copies of the removal order, Appeal and judgment dated 12.8.2021 are attached as annexure C, D & E)
- 4. That after remanding the instant case to the respondents department for de-novo inquiry, one Mr.Faridullah DEO (M) District Orakzai nominated as enquiry officer and the appellant was pass through the said inquiry proceedings and resultantly the impugned Order dated 20.05.2022, was issued, wherein the service of the appellant was restored, but on the other hand the period i.e.1.12.2017 to 27.5.2022, spent in the litigation with the respondents department by challenging their illegal order dated 15.02.2018, by the appellant through service appeal No 807/2018 before this Hon, ble Tribunal wherein the appellant was removed from his service and now in the impugned order dated 20.05.2022 the respondents department illegally considered the above stated period as "Extra Ordinary Leave Without Pay" instead of with pay. It

- worth to mention here that after issuance the above stated order the appellant took charge in the respective school. (Copies of the Notification dated 24.11.2021 & impugned order dated 20.5.2022 & charge report are attached F,G & H to H-3)
- 5. That after the appellant filed a departmental appeal before the respondents department, but since then till date neither rejected nor accepted. (Copy of the appeal is attached as annexure I)
- 6. That the appellant being aggrieved partially from the impugned order dated 20.05.2022, to the extent of converted the intervening period 1.12.2017 to 27.5.2022 into "Extra ordinary leave without pay" instead of with pay thus the appellant is deprived from all back benefits hence, prefer this appeal, inter alia on the following amongst other grounds:

GROUNDS:

- A. That the impugned Order dated 22.05.2022 to the extent of depriving the appellant for not considering the period which spent in litigation with the respondent department due to their illegal act is totally Illegal, against the law facts and circumstances of the case hence liable to be struck down.
- B. That the appellant is peaceful and law abiding citizen of Pakistan and is entitled for all basic law and fundamental rights guaranteed under the constitution of the country.
- C. That the act of the respondents is not following the same criteria which has been safeguard by the law, rules and guide lines provided by the Apex courts through their various judgments.
- D. That according to the Article 23 & 24 (1) of the Constitution of Pakistan, the property of every citizen of Pakistan have been protected and no one could be deprived from their due rights, but in the instant the appellant was deprived from his legal right thus the impugned order was passed, wherein the time spent by the appellant in litigation was not considered.
- E. That as stated in body of the appeal that the time spent in litigation is because of the illegal order passed by the

respondents department with due malafide intention on their part nor on the part of the appellant.

- F. That the impugned order dated 20.5.2022 is self-contradictory because on one side the service of the appellant is re-instated while on other hand he is deprived from all back benefits for the above mentioned period on this score alone the impugned is liable to be set aside.
- G. That any other additional ground will be raised at the time of arguments with the prior permission of this Honorable Tribunal.

Prayer in Appeal:

By acceptance of the instant Appeal, the impugned order dated 20.05.2022 may kindly be set aside as prayed for in heading of the appeal.



<u>JUDGMENT</u>

ROZINA REHMAN, MEMBER : The appellant has filed the present service appeal U/S 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974 against the order dated 15.02.2018 vide which major penalty of removal from service was imposed upon appellant.

02. Brief facts of the case are that appellant was appointed as A.T (Arabic Teacher) in a School at Hangu on 05.03.2010. Due to extreme militancy at Tarri Banda G.H.S Hangu, School was closed but the

appellant was compelled to ensure attendance in the said School which was already closed and the teaching staff as well as students were also not in attendance. He was proceeded against departmentally and lastly he was removed from service vide impugned order. Feeling aggrieved, he filed departmental appeal which was not responded to, hence, the present service appeal.

03. Learned counsel for the appellant contends that the impugned order is against law and facts as the appellant was not created in accordance with law. He submitted that the impugned order dated 15.02.2018 was passed in view of previous inquires and that no fresh inquiry was initiated before imposition of the major penalty. He submitted that surprise visit was paid by the authority on 07.02.2017, whereas, the impugned order shows the absence of appellant on 23.01.2017.

04. Conversely learned A.A.G submitted that the School was never closed as there was no militancy in the year 2015-16 and that the staff was performing duty regularly. He submitted that the inquiry was conducted against the appellant according to law and that proper show cause notice was issued to the appellant with direction to resume duty, where-after, he appeared before the District Education Officer and submitted judicial stamp paper that he will never remain absent in future.

05. Record shows that appellant was appointed as Arabi Teacher in School at Hangu on 05.03.2010. He was transferred to G.H.S Tarri Banda Hangu and he served in the said area till 01.10.2015; Perusal of impugned order would reveal that the District Education Officer paid a surprise visit to G.H.S Tarri Banda on 07.02.2017 at 9:00 AM but no

rather the inquiries conducted much before the surprise visit were mentioned in the impugned order. The contents of the impugned order show that the appellant was informed on 07.12.2016 with direction to fulfill the requisite in respect of the affidavit. Accordingly, he submitted his statement on a judicial stamp paper on 04.01.2017. He was found absent till 23.01.2017, therefore, he was issued absentee notices prior to the decision on 04.11.2016. All this shows previous closed transactions which have nothing to do with the surprise visit of the District Education Officer on 07.02.2017. As per Rule-3(d) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules 2011, a Government servant shall be liable to be proceeded against under these rules if he is guilty of habitual absenting himself from duty without prior approval or leave. In the instant case, if the appellant was not available in the school when surprise visit was paid on 07.02.2017, then the appellant was liable to be proceeded against Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 and the initiation of proceedings as per Rule-5 of the Rules jbid had to be followed in letter and spirit. But in the instant case, his past conduct was taken into consideration while passing the impugned order of removal from service.

06. Keeping in view the above discussion, this Tribunal is left with no option but to partially allow this appeal. Accordingly, impugned order is set aside. Case is remitted to the Department with direction to conduct de-novo inquiry in view of Rule-3 (d) of Khyber Pakhtunkhwa Government Servants (Efficiency & Discipline) Rules, 2011 within 30 days after the receipt of this judgment. Reinstatement and back benefits shall be subject to the outcome of de-novo inquiry. Parties are left to bear their own costs. File be consigned to record room.


