It was submitted by the learned counsel for the appellant that he was initially appointed as Assistant in the Social Welfare, Special Education and Women Empowerment Department. He then applied for the post of Zilladar through proper channel and was appointed on 30.05.1991. He was promoted to the post of BPS-14 and then to the post of Deputy Collector. He contends that by not granting pay fixation and not counting previous service of the appellant towards Irrigation Department is against law, facts and norms of natural justice.


