Respectfully Sheweth;

The Appellant most earnestly seeks permission of this Honourable Court to submit as under;

- That the Appellant being a peaceful, respectable and law abiding citizen of Pakistan, and is entitled for all the fundamental rights guaranteed in Part-II Chapter 1 under the Constitution of Islamic Republic of Pakistan 1973.
- 2. That the Respondents are governmental entities; performing functions in connection with the affairs of the Province, as their activities are regulated by laws made by the state and are therefore amenable to the Constitutional Jurisdiction of this Honourable Court.
- 3. That initially the Appellant was serving in Levies/Khasadar force of Sub-Division Wazir and subsequently merged in Khyber Pakhtunkhwa Police Department Sub Division Wazir Bannu in the year 2019 and still working with heart and soul and to the entire satisfaction of his high-ups.

(Copy of Service Book is attached as Annexure-A)

4. That the Appellant was absorbed as ASI (BPS-11) vide Notification No. SO (Police) HD/SMY 2019 Merged Area/87-97 dated 08/01/2021 by Secretary Home and Tribal Affairs Department with the prior approval of the cabinet and on recommendation of the Provincial Police Officer.

(Copy of Notification dated 08/01/2021 is attached as Annexure-B)

5. That after absorption as Assistant Sub Inspector (BPS-11), the Appellant was performing his duties as ASI and is regularly receiving their monthly salaries since their absorption to the Khyber Pakhtunkhwa police Department till August, 2022.



(Copy of Pay Slip is attached as attached as Annexure-C)

6. That on 11/08/2021, the Appellant was selected for 03 months Basic Police Training as Assistant Sub Inspector (BPS-11) by the District Police Officer (DPO) Bannu and the said list was forwarded to the Assistant Inspector General of Police (Training).

(Copy of letter dated 11/08/2021 is attached as attached as Annexure-D)

7. That on 17/08/2021, the District Police Officer Bannu sent letter to Assistant Inspector General of Police (Training) regarding provision of data of Head Constables/ASI/Constables and Inspectors of Newly merged districts and in response the same was forwarded back to the DPO Bannu vide letter dated 03/09/2021 and the name of the Appellant was duly verified as Assistant Sub Inspector (BPS-11).

(Copies of letter dated 17/08/2021 and 03/09/2021 and better copies are attached as attached as Annexure-E, E-1&F, F-1)

8. That the then Regional Police Officer (RPO) Bannu constituted the inquiry committee regarding Absorption in Levies/Khasadar and comprising Inspector Muhammad Farooq Khan SDPO (Chairman), Inspector Rizwan Khan SDPO/Rural-II and Senior Clerk Javed Khan Head Clerk as members and they filed the inquiry report vide No. 197-200 dated 30/06/2021.

(Copy of 1st Inquiry dated 30/06/2021 is attached as Annexure-G)

9. That suddenly, the then District Police Officer (DPO) Bannu suspended the service of the Appellant vide order No. 8836 dated 25/11/2021 till the arrival of proper verification from Home Department, Peshawar.

10. That in this regard the then District Police Officer (DPO) Bannu constituted the committee vide order No. 9004-8 dated 01/12/2021 comprising of Mr. Rizwan SDPO Rural Circle-II Bannu and Mr. Javed Iqbal Head Clerk DPO Office for the purpose to carry out verification.

(Copies of order dated 01/12/2021 and better copy are attached as Annexure-I, I-1)

11. That the Section Officer (Levy & Khasadar) Home and Tribal Affairs

Department vide order No. SO (Police) HD/SMY 2019 Merged

Area/1333-36 dated 06/12/2021 and stated therein that Mr.

Rizwan SDPO Rural Circle-II Bannu and Mr. Javed Iqbal Head Clerk

DPO Office visited the office of the undersigned and the committee was provided relevant record and verified the same.

(Copy of order dated 06/12/2021 is attached as Annexure-J)

12. That it is pertinent to mention here that committee members mentioned in para No. 11, on 14/12/2021, states that "Dispatched register of the office of Section Officer (Levies & Khasadars) Home Department was checked with regard to the numbers issued depicted on the notifications which were found correct.

(Copy of order dated 14/12/2021 is attached as Annexure-J-1)

13. That in the light of letter No. 793/EC dated 23/02/2022 received from RPO office Bannu Region Bannu with the following remarks recorded by the RPO Bannu Region Bannu;

"As they have been lawfully absorbed in Police Department in BPS-11 by Home Department, therefore proceed as per law on the subject".

(Copy of order dated 23/02/2022 is attached as Annexure-K)

14. That in compliance with the Worthy RPO order dated 23/02/2022 and in the light of the proper verification carried out, the Appellant was hereby restored w.e.f (Suspension date) i.e.

25/11/2021 by the then District Police Officer Bannu vide order No. 1270-74/SRC(SDW) dated 25/02/2022.

(Copy of Restoration order dated 25/02/2022 is attached as Annexure-L)

15. That the Appellant received different appreciation certificates from his high-ups and it is evident from that the Appellant is hardworking and he did not compromise on their official duty.

(Copies of Appreciation Certificates are attached as Annexure-M)

16. That the Respondents, given charge of Station House Officer to the Appellant upon their great performance.

(Copy of order as SHO is attached as Annexure-N)

17. That all of a sudden once again when the matter was resolved by high-ups, the District Police Officer Bannu vide impugned order dated 11/08/2022 constituted the committee regarding probe into suspicious/controversial notifications and they recommended that the absorption of the Appellant is contrary to the Khasadar Act.

(Copy of impugned 2nd inquiry committee recommendations dated 24/08/2022 is attached as Annexure-O)

18.That in the light of the recommendations raised by the inquiry committee, the District Police Officer Bannu issued an impugned order No. 3897-3906 dated 01/09/2022 and awarded the major penalty by reverted the service of the Appellant from ASI (BPS-11) to Constable (BPS-07).

(Copies of impugned reversion order dated 01/09/2022 and better copy are attached as Annexure-P, P-1)

19. That on 12/09/2022, the Appellant has filed departmental appeal under section 22 of the Civil Servant Act, 1973 against the impugned inquiry committee recommendations dated 24/08/2022 and impugned reversion dated 01/09/2022 before

the worthy Regional Police Officer Bannu Region Bannu through

(Copy of Departmental Appeal dated 12/09/2022 is hereby attached as Annexure-Q)

proper channel.

20. That despite preferred an appeal and still pending before worthy Regional Police Officer Bannu Region Bannu and the petitioners are quite hopeful to be re-instated into service with all back benefits, meanwhile on 10/11/2022, the Respondent No.2 conducted an impugned another 3rd inquiry regarding the absorption order of the Appellant.

(Copy of 3rd inquiry committee dated 10/11/2022 is attached as Annexure-R)

21. That the Appellant being aggrieved from the illegal and unlawful conduct of the Respondents by issuing the impugned Reversion order dated 01/09/2022, then statutory period of 90 days are also lapsed on the appeal of the appellant, thus having no other remedy and dissatisfied by the actions and inactions, Appellant seeks to approach this Hon'ble Tribunal inter alia on the following grounds:-

GROUNDS:

- A) That the impugned reversion order No. 3897-3906 dated 01/09/2022 is against law, illegal, unlawful, against the Civil Servant Act, 1973.
- B) That the fundamental rights of the Appellant has blatantly been violated by issuing the impugned reversion order No. 3897-3906 dated 01/09/2022 and the Appellant has been discriminated and has been denied his due rights under the Constitution of Islamic republic of Pakistan 1973.

(F)

- C) That the impugned reversion order No. 3897-3906 dated 01/09/2022 is illegal, unlawful, unnatural, void-ab-initio, null and void in the eye of law, hence liable to be declared so.
- D) That without given any notice or given an opportunity of personal hearing was given to the Appellant and issuance of the impugned reversion order No. 3897-3906 dated 01/09/2022 is the clear cut violation of Right to fair trial i.e. Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973 and also against the settled norms of service laws/rules prescribed for all the institutions.
- That according to the legal maxim, "Nemo debit bis vexari (No could be vexed twice for the same offence)" Subsequent proceedings taken against employee on same charge was not justified as no one could be vexed twice for one and same cause. Apex Court in a number of judgments held that Government, was directed to take necessary measures in such matter so that there was no repetition of such mistake in future. Meaning thereby that the Appellant is being harassed and has been vexed twice for double punishment, which is against the mandate of Article 13 of the Constitution of Islamic Republic of Pakistan, 1973.
- (Efficiency and Discipline) Rules, 2011; Section 5 (a) deals with proceed itself against the accused by showing cause notice and dispense with inquiry. Section 7 (d) deals with opportunity of personal hearing before passing any order of penalty, if it is determined that the charges have been proved against him. Section 10 (d) deals that direction to the accused to submit written defense to the inquiry officer/committee within reasonable time. Similarly, Section 15 of the said act deals with personal hearing.
- G) That according to Section 77 (2) of the Police Act, 2017 "Subject to the rules, a member of the police may at any time be

suspended, dismissed, compulsorily retired, reduced in rank or pay, within a time scale, fined, censured or awarded any other punished in the prescribed manner. But in the instant case, no proper legal procedure was taken by the Respondents.

- full-fledged inquiry. No major punishment could be imposed on the basis of fact finding enquiry, for that, regular enquiry should be conducted. According to Rule 29 of the Fundamental Rules; Period for which penalty to remain effective not mentioned in impugned order. Mentioning of such period was mandatory and not directory.
- That if the Appellant is being reverted to constable, then the dignity of the Appellant will be in danger in the Police department as well as in the entire society.
- That according to absorption Notification dated 08/01/2021, the necessary entries has already been made in the service record of the Appellant and also absorbed into the Police Constable department as ASI BPS-11 and also draw their regular salaries in ASI Rank.
- K) That the law demands justice may not only be done, it should manifestly be done, keeping in view the impugned reversion order No. 3897-3906 dated 01/09/2022 is the clear cut disparity amongst the other officials of the Police Department, as the domain of Article 25 and 27 of the Constitution of Islamic Republic of Pakistan, 1973 have been grossly violated by the Respondents in order to adopt favoritism and biased approach. Hence impugned reversion order No. 3897-3906 dated 01/09/2022, not only illegal, ultra-vires, unjustifiable, corum-non-judice but also against the fundamental rights of the Appellant enshrined in the Constitution of Islamic Republic of Pakistan, 1973.

- That according to section 12(3) of the Civil Servant Act, 1973, "No such civil servant as aforesaid shall be dismissed or removed from service, or reduced in rank, until he has been given a reasonable opportunity of showing cause against the action proposed to be taken against him". In the instant case, the said provision did not
- M) That as mentioned in the subject, the Appellant is yet to serve the force as well as beloved country till 60 years of age, but issuing the impugned reversion order No. 3897-3906 dated 01/09/2022 is highly unlawful, against the vested right of the Appellant.

follow by the Respondents.

- N) That the Apex Court time and again held that the principle of "Audi Alterm Partam" natural justice required that a regular inquiry should be conducted in the matter and opportunity of defense and personal hearing should be provided, otherwise it would condemned unheard and in the instant matter, without adopting the required mandatory procedure resulting in manifest injustice, because of entire action was taken unilaterally by the Respondents against the Appellant by issuing the impugned reversion order No. 3897-3906 dated 01/09/2022.
- O) That the actions or omissions have infringed the fundamental rights of the Appellant, including those enshrined under articles 4, 8, 9, 18, 25 and 38 of the Constitution of Islamic republic of Pakistan 1973, these all speak about the well-being of the people, equitable adjustment of rights, protection of life and liberty etc.
- P) That the Respondents are Constitutionally, legally, morally and ethically bound to provide the same facility, provided to the other officials, living in the welfare state; Pakistan.
- Q) That the Appellant has been serving till date with utmost zeal and zest with due honesty but the Respondents owing to their personal grudges and malafide intention and ulterior motives two different inquiries were made regarding the same subject matter

and the impugned reversion order No. 3897-3906 dated 01/09/2022 is liable to be struck down.

- R) That the illegal and unlawful actions taken by the Respondents by making time and again inquiry committee is the manifestation of law of jungle, finding no parallels in the service code, which is arbitrary and whimsical, hence liable to be set at naught.
- that the Apex Court in the reported case "2020 SCMR 188" held that:

"It is well settled and established law, that whenever a right has been accrued to the employee and he has received the benefits of the same and later on it has been rescinded by the authority, it would be ineffective upon the rights of employee. Further the principle of estoppel would be applicable in the present case against the department from recovering the emoluments and benefits of BPS-15 from the petitioner, petition for leave to appeal was converted into appeal and allowed".

- That the inactions and omissions of the Respondents qua the Appellant has no legal backing and as such is a nullity in the eyes of law and as well as on the rights and liabilities of the Appellant.
- U) That the illegal and unlawful conduct of the Respondents by issuing three inquiry committees is stigma on the professional unblemished career of the Appellant and is beyond the mandate and constitutional command and parameters set by the law.
- V) That when once the matter had been settled down by initiating different inquiries, meaning thereby that the matter is said to be closed and past transaction, therefore, the impugned reversion order dated 01/09/2022 is nothing but nullity in the eyes of law.
- W) That in fact for the redressal of the grievance, the Appellant has filed departmental appeal but the worthy RPO Bannu even did not



issue any show cause notice and deaf ear to the departmental appeal of the Appellant and kept the same in the cold storage and finally having no other option to put his grievance in the mercy of this Hon'ble Tribunal.

X) That the counsel for Appellant seeks permission to rely and advance additional grounds at the time of hearing of this petition.

PRAYER IN APPEAL:

In view of the above stated reasons and others to be stated at the time of arguments, it is therefore, most humbly prayed, that on acceptance of this service appeal, this Honourable Tribunal may very graciously be pleased to set-aside the impugned reversion order No. 3897-3906 dated 01/09/2022, being illegal, unlawful, unconstitutional, void-ab-initio, nullity in the eyes of law, against the rights of the Appellant and further reinstated the Appellant into service in his actual rank i.e. Assistant Sub Inspector (BPS-11) with all back benefits. And Grant any other remedy in the circumstances by this Honourable Tribunal to meet the ends of justice.

In compliance with your kind directives, the committee members thoroughly checked the office record of DPO office, Bannu, in respect of the concurred suspicious/controversial induction of individuals of Sub-Division Wazir in Bannu Police and are unanimously agreed upon the following conclusions:

CONCLUSIVE SUMMARY REPORT REGARDING PARA 1:

The induction of 11 officials in the rank of ASIs (BPS-11) consisting of ---10 officials vide notification No.SO(Police)HD/SMY 2019 merged Area/S7-97, dated 08.01.2021 (from serial No. 1 to serial No. 10) and 01 official (Muhammad Tahir) vide notification No.SO(Police)HD/SMY 2019 merged Area/2410-20, dated 16.10.2020 mentioned at serial No. 5 is totally wrong, fake and forged (Though verified from the Home and Trible Affairs Department as true) on the following grounds:

1. Neither the DPO office Bannu had sent/recommended the under-discussion it names of individuals of Khasadar Force of Wazir Sub-Division for their absorption in the Rank of ASI (BPS-11) nor their names had been recommended by the DC/APA office, Bannu for their absorption in the rank of ASIs. Some hidden hands of the CPO clerical staff and Home Department with mutual connivance and maia-fide intention have included these (11) names for their (illegal, illogical and irrational) absorption in the rank of ASIs. Similarly, no scrutiny committee (comprising DPO, DC/AC/APA & DAO) had recommended these names for their absorption in the rank of ASIs. Perhaps the hidden hands have also prepared their fake scrutiny committee reports bearing fake signatures of the committee-members for giving it a legal coyet.

- iv Shah Hussain S/O Akhtar Munir on serjal No. 119 for absorption in the rank of constable;
- v Mukhtar Ullah S/Q Mashat Khan on serial No. 172 for absorption in the rank of Constable;
- vi Javid Iqbal S/O Dawood Khan on serial No. 179 for absorption in the rank of Constable;
- vii Hafeez ur Rehman S/O Nazar Gul on serial No. 421 for absorption in the rank of Constable;
- viii Mushahid ul Wadood S/O Fazal Wadood on serial No. 425 for absorption in the rank of Constable;

They are also recommended for departmental proceedings being involved in chenting, dishonesty and forgery.

Sadam Hussain S/O Hunar Khan mentioned at serial No.10 of the notification No.SO(Police) HD/SMY 2019, Merged Area/87-97, dated 08-01-2021, and Muhammad Tahir Khan S/O Khushdil Khan mentjoned at serial No. 5 vide Home and Tribal Affairs Department notification No.SO(Police) HD/SMY 2019, Merged Area/2410-20, dated 16-10-2020 are totally outsiders and private persons and their absorption could not be warranted under any law. They are not members of Khassadar Force, Levy Force or Police Force. Their names have neither been recommended by the APA office nor sent to CPO by the DPO office, Bannu. Their names are also not been recommended by the authorized scrutiny committee. They have managed the induction of their names through back-doors with mala fide intention. Being outsiders private persons and involved in cheating, dishonesty and forgery, a criminal case is recommended to be registered against them, with their immediate removal from service and recovery of salaries.

A high level enquiry at CPO level is recommended to be conducted for tracing out the hidden hands in the whole game.



Departmental Appeal for cancellation/set-aside the impugned inquiry No. 224/ASP dated 24/08/2022 and subsequently impugned order No. 944 dated 01/09/2022 vide which the appellant has illegally been reverted from ASI (BPS-11) to Constable (BPS-07) issued by District Police Officer Bannu.

Respected Sir,

It is humbly requested with profound respect, the appellant most earnestly seeks permission to submit as under;

- 1. That initially the appellant was serving in Levies/Khasadar force of Wazir Sub-Division and subsequently merged in Khyber Pakhtunkhwa Police Department District Bannu in the year 2019.
- 2. That the appellant was absorbed as ASI (BPS-11) vide Notification No. SO (Police) HD/SMY 2019 Merged Area/87-97 dated 08/01/2021 by Secretary Home and Tribal Affairs Department.(Copy of Notification dated 08/01/2021 is attached as Annexure-A)
- 3. That after absorptic has ASI, the appellant was performing his duties as ASI and is regularly receiving his salary since 08/01/2021 till date.
- 4. That the then RPC Bannu constituted the inquiry committee regarding Absorption in Levies, Khasadar and comprising Inspector Muhammad Farooq Khan SDPO (Chairman), Inspector Rizwan Khan SDPO/Rural-II and Senior Clerk Javed Khan Head Clerk as members and they filed the inquiry report vide No. 197-200 dated 30/06/2021. (Copy of Inquiry dated 30/06/2021 is attached as Annexure-B)





- 5. That suddenly the then District Police Officer (DPO) Bannu suspended the service of the appellant vide order No. 8836 dated 25/11/2021 till the arrival of proper verification from Home Department, Peshawar (Copy of Suspension order dated 25/11/2021 is attached as Annexure-C)
- 6. That in this regard the then District Police Officer (DPO) Bannu constituted the committee vide order No. 9004-8 dated 01/12/2021 comprising of Mr. Rizwan SDPO Rural Circle-II Bannu and Mr. Javed Iqbal Head Clerk DPO Office for the purpose to carry out verification. (Copy of order dated 01/12/2021 is attached as Annexure-D)
- 7. That the Section Officer (Levy & Khasadar) Home and Tribal Affairs Department vide order No. SO (Police) HD/SMY 2019 Merged Area/1333-36 dated 06/12/2021 and stated therein that Mr. Rizwan SDPO Rural Circle-II Bannu and Mr. Javed Iqbal Head Clerk DPO Office visited the office of the undersigned and the committee was provided relevant record and verified the same.(Copy of order dated 06/12/2021 is attached as Annexure-E)
- 8. That in the light of letter No. 793/EC dated 23/02/2022 received from RPO office Bannu Region Bannu with the following remarks recorded by the RPO Bannu Region Bannu;

"As they have been lawfully absorbed in Police Department in BPS-11 by Home Department, therefore proceed as per law on the subject". (Copy of order dated 23/02/2022 is attached as Annexure-F)

9. That in compliance with the Worthy RPO order dated 23/02/2022 and in the light of the proper verification carried out, the appellant is hereby restored w.e.f (Suspension date) i.e. 25/11/2021 by the then District Police Officer Bannu vide order No. 1270-74/SRC(SDW) dated








25/02/2022. (Copy of restoration order dated 25/02/2022 is attached as Annexure-G)

- 10.That all of a sudden once again when the matter was resolved by high-ups, the District Police Officer Bannu vide impugned order dated 11/08/2022 constituted the committee regarding probe into suspicious/controversial notifications and they recommended that the absorption of the appellant is contrary to the Khasadar Act. (Copy of impugned inquiry committee dated 24/08/2022 is attached as Annexure-H)
- 11. That in the light of the recommendations raised by the inquiry committee, the District Police Officer Bannu issued an impugned order No. 3897-3906 dated 01/09/2022 and awarded the major penalty by reverted the service of the appellant from ASI (BPS-11) to Constable (BPS-07). (Copy of impugned reversion order dated 01/09/2022 is attached as Annexure-I)
- 12. That the impugned order No. 3897-3906 dated 01/09/2022 is illegal, unlawful, unnatural, void-ab-initio, null and void in the eye of law, hence liable to be declared so.
- 13. That the fundamental rights of the appellant has blatantly violated by issuing the impugned order No. 3897-3906 dated 01/09/2022 and the appellant has been discriminated and has been denied his due rights under the Constitution of Islamic Republic of Pakistan, 1973.
- 14. That without given any notice or given an opportunity of personal hearing and issuance of impugned order No. 3897-3906 dated 01/09/2022 is the clear cut violation of Right to fair trial i.e. Article 10-A of the Constitution of Islamic Republic of Pakistan, 1973 and also against the settled norms of service laws/rules prescribed for all the institutions.





16. That if the appellant is being reverted to constable then the dignity of the appellant will be in danger in the Police department as well as in the entire society.

PRAYER IN APPEAL:-

It is therefore, most humbly prayed that, on acceptance of this appeal, the impugned inquiry committee recommendations dated 24/08/2022 and impugned reverted order No. 3897-3906 dated 01/09/2022 from ASI (BPS-11) to Constable (BPS-07) being illegal, unlawful, unconstitutional, void-ab-initio, and the appellant may kindly be re-instated to the service to the actual rank ASI. (BPS-11) with all back benefits to meet the ends of justice.
