PRAYERS:-

On acceptance of the instant appeal, the final impugned order passed by the respondent No. 1 dated 16/08/2021, rejecting the departmental appeal of the appellant and upholding the first/original impugned order of "Removal from Service" dated 02-07-2021, passed by the respondent No. 2 may be set-aside and the appellant may be reinstated in services with all consequential back benefits.

RESPECTFULLY SHEWETH:-

- 1. That the Appellant was initially appointed as Chowkidar in BPS-1 vide office Order bearing No. DG(R) L&DD /Est: II (83)/2006/6645-49 Dated 19/09/2012 and served the Respondent Department as such with great zeal, zest and enthusiasm and no adverse remarks whatsoever were ever attributed/assigned to him from any quarter. (Copy of the initial appointment order Dated 19/09/2012 is annexure "A").
- 2. That astound to become aware and by handing over the termination letter by the Respondent No. 2, the Appellant, on the whimsical and biased considerations was terminated from services vide first impugned order bearing No. DG (Res)/L&DD/ Est-II /PF (269) 2021/5513-19, dated 02/07/21. (Copy of the original impugned order dated 02/07/21 is annexure "B").
- 3. That the Appellant while availing the departmental remedy, moved a departmental representation dated 06/07/21 before the respondent No. 1 but to no avail and rejected vide Final impugned order dated 16/08/21, endorsed by the respondent No. 2 dated Peshawar the 23/08/21. (Copy of the departmental representation dated 06/07/21 and final impugned order thereon dated 16/08/21 is annexure "C" & "D" respectively).
- 4. That while having been aggrieved of the colorful authority exercised by the respondents and while having no efficacious remedy been available in the circumstances of the case, the Appellant being a civil servant approaches this honorable Tribunal inter-alia on the following grounds.

GROUNDS:-

a) Because the impugned order has been passed in the exercise of colorful authority which is unlawful, without lawful authority, without jurisdiction, un-Islamic, un-constitutional, against the

law on the subject and against the norms of equity and natural

b) Because the allegation leveled against the Appellant of "failing to perform assigned duties efficiently by deliberately allowing the official/Chokudar to come and stay in the chowkidars room who, one day prior, was terminated from service despite the ban on his entry into campus" is illogical and self-nugatory as the appellant was never directed as such nor the fact of termination was ever brought to the notice of the appellant and in furtherance to prohibit his entrance therein.

justice.

- c) Because AUDI ALTERAM PARTEM has not be resorted to which is the fundamental natural justice rule that no one should be condemned unheard but conversely on the back of the appellant, the major penalty was imposed fo no fault on his part.
- d) **Because** the incumbent essentialities of proper legal regular inquiry have been overlooked and a self-concocted drama was engineered and demise of all the legal norms sanctioned by the prevalent service law have been set at naught which has the liability to be brushed aside as such.
- e) Because Coram non judice has vehemently been ignored and all the laws, rules and regulations while having proceeding against the appellant amid the so called enquiry have been overlooked and major penalty has been imposed in a slip-shod manner.
- from Service" was passed by the respondent No. 2 Appellant has been terminated from services by the respondent No. 2 who is neither the appointing authority in the case of the appellant nor legally so competent authority to pass such order and hence this sole fact is sufficient for nullifying the impugned orders.



- g) Because the act of the respondents in neglecting and refusing the right of fair and transparent regular enquiry and as such condemned unheard is also against the divine ordain of Allah Almighty as under the principle of natural justice and fundamental human rights of the appellant, the respondents have usurped the right of a human being and have thus bypassed the divine rule to give everyone his due right.
- h) **Because** the respondents are bound to provide equal protection of law and must not discriminate the appellant in service which clearly smacks with nepotism and malafide on part of the respondents whereas to enjoy the protection of law is the inviolable and jealously guarded right of the appellant under the Constitution of Islamic of Pakistan 1973.
- i) Because the impugned act of the respondents is highly unjust and against the principle of Natural Justice and if allowed to remain in field then the same would perpetuate more injustice and certainly result in complete deprivation of Constitutional right of the appellant.
- j) **Because** the act of the respondents are also violative of Article 03, 04, 08, 09, 25 and 27 of the Constitution of Islamic of Pakistan 1973.
- k) Because the respondents while passing the harsher penalty vide impugned orders have never bothered to see the unblemished service record of the appellant and at least should see the length of spot-less service for about more than 08 years rendered by the appellant and in such a circumstances the penalty and subsequent final impugned order having no value in the eyes of law, is liable to be set-aside.
- 1) That valuable right was accrued to the appellant whereas his fundamental valuable rights have been encroached by the respondents No.1 & 2 on their personal whims & wishes and such encroachment is hit by the law on the subject and the



command of the constitution of the Islamic Republic of Pakistan 1973.

m) That further submissions will be advanced at the time of hearing the appellant at the bar.

In view of the foregoing facts, circumstances and submissions, it is therefore humbly prayed that on acceptance of instant appeal, the final impugned order passed by the respondent No. 1 dated 16/08/2021, rejecting the departmental appeal of the appellant and upholding the first/original impugned order of "Removal from Service" dated 02-07-2021, passed by the respondent No. 2 may be set-aside and the appellant may be reinstated in services with all consequential back benefits.


