



Learned counsel contends that appellant was working as Tehsildar, who was senior and eligible to be promoted as PMS but he was implicated in a false case of Voluntary Return. He was deferred time and again due to pendency of inquiry. He also filed a writ petition, which was accepted as prayed for on the basis of similarly placed person. Appellant was granted promotion to the post of PMS (BPS-17) with immediate effect which order is illegal and needs to be modified as from immediate effect to his due date i.e. 30.01.2017 when junior to the appellant was promoted.

Points raised need consideration. Instant appeal is admitted for regular hearing subject to all legal exceptions. The appellant is directed to deposit security and process fee within 10 days. Notice be issued to the respondents. To come up for written reply/comments on 19.08.2020 before S.B.


