



Preliminary arguments heard.</p> <p>According to Grounds mentioned in the departmental appeal for consideration of the departmental appellate authority, the appellant has made submission about his minimum tenure among other similarly placed officers working in Hazara; and as he purports his transfer is likely to have drastic and is effect on the research process in the field with negative impacts on soil sampling of the poor farmers. That his wife is serving as Public Health Officer/Lecturer in the Government Public Health School Abbottabad and there is no paramedical school/college in Chitral to transfer her on spouse policy. According to Para xiv of the policy of the Government from Esta Code, right</p>

of appeal has been given to the government servants and accordingly, if one is aggrieved due to the orders of posting/transfer of authorities, he may seek remedy from the next higher authority/the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. It is further provided in the said Para that such appeal shall be disposed of within fifteen days. So the appeal at hand keeping in view special limitation of 15 days for decision of departmental appeal is maintainable on expiry of 15 days after departmental appeal. Let the respondents be put on notice to justify the public interest in transfer of the appellant during course of regular hearing. The appeal is admitted to regular hearing. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days of the receipt of notices positively. If the written reply/comments are not submitted within the stipulated time, the office is directed to submit the file with a report of non-compliance. File to come up for arguments on 21.09.2021 before the D.B.




