
**Subject: APPLICATION FOR RELEASE OF SALARY**

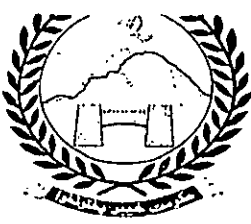
