Appellant humbly submits as under:

- 1. That appellant is qualified upto TC, BEON A (Education) of the academic documents are attached as Annexure A)
- 2. That appellant was appointed as Theology Teacher (TT) in BPS-15 w.e.f 01/09/2019 vide appointment order dated 29/07/2019 which is duly signed by the DEO(F) Swabi (Copy of the appointment order dated 29/07/2019 is attached as Annexure B)
- 3. That appellant was appointed as TT after due

recommendation of the Departmental Selection Committee wherein the minutes of the meeting dated 28/07/2019 clearly states that all codal formalities have been completed for appointment and the appellant is recommended for appointment on merit (Copy of the minutes of the Departmental Selection Committee meeting dated 28/07/2019 is attached as Annexure C)

- 4. That appellant's medical is conducted by the Medical Superintendent DHQ Teaching Hospital Swabi wherein appellant is declared medically fit (Copy of the medical certificate is attached as Annexure D)
- 5. That after observing all codal formalities and due verification, the District Education Officer (Female) Swabi issued the pay release order dated 25/09/2019 of the appellant (Copy of the pay release order dated 25/09/2019 is attached as Annexure E)
- 6. That appellant attended Induction Training Program on the orders of the respondent no 4 (Copy of the induction training program is attached as Annexure F)
- 7. That appellant performed her duty to the entire satisfaction of her superiors and was holding the post of Theology Teacher (TT) in GGHS Zaida Swabi and received salaries (Copy of the monthly salary statement for the month of February 2022 is attached as Annexure G)
- 8. That District Education Officer (F) Swabi extended the contract period of the appellant from 01/09/2020 to 31/08/2021 vide notification dated 31/12/2020 (Copy of the notification dated 31/12/2020 is attached as Annexure H)
- 9. That respondent no 4 vide notification dated 26/03/2021 further extended the contract period of appellant (Copy of the notification dated 26/03/2021 is attached as Annexure I)
- 10. That the appellant at the time of appointment was given the assurance by the Department that the contractual service of the appellant would be regularized as the services of other similarly placed employees and previous employees have been regularized by the Department and to this effect an Act by the name of Khyber Pakhtunkhwa Teachers (Appointment and

Regularization of Services) Act 2022 been passed by the Provincial Assembly of KP to regularize the services of all teachers and therefore the services of the appellant are to be considered as regular (Copy of the Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Services) Act 2022 is attached as Annexure I)

- 11. That the Head Mistress GGHS Zaida has issued a duty certificate dated 01/03/2021 in respect of the appellant wherein she affirmed that the appellant is on duty at GGHS Zaida as TT (Copy of the duty certificate dated 01/03/2021 is attached as Annexure K)
- 12. That the salary of the appellant was stopped, for release of salary the appellant submitted an application dated 19/04/2022 (Copy of the application dated 19/04/2022 is attached as Annexure L)
- 13. That neither any inquiry is conducted nor the appellant is associated with any such inquiry.
- 14. That vide notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022, the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts (Copy of the notification dated 05/08/2022 is attached as Annexure M)
- 15. That appellant filed departmental appeal dated 05/09/20202 against the notification dated 05/08/2022 received on 15/08/2022 which is duly dispatched through registered post which departmental appeal remained un-responded (Copy of the departmental appeal dated 05/09/2022 along with post office receipt is attached as Annexure N)
- 16. That the impugned notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022 is illegal against law and facts on the following grounds:

GROUNDS:

- A. Because appellant is innocent and falsely charged.
- B. Because appellant was not associated with the enquiry

proceedings nor any witness was examined in presence of the appellant nor appellant was confronted with any documents/record.

- C. Because appellant has neither been charge sheeted nor statement of allegation has been issued to the appellant nor show cause notice has been given to the appellant nor regular inquiry has been conducted.
- D. Because the concerned officers were neither interrogated nor arrayed as an accused in the instant case which is a glaring illegality and appellant being a low-paid employee has been made a scapegoat.
- E. Because all codal formalities have been completed and appellant is eligible for the post of Theology Teacher (TT).
- F. Because the whole inquiry and the whole proceedings are illegal as appellant cannot be targeted alone while excluding all the concerned government servants, their DEOs(F), the DA II/EMIS etc which is against the judgments of the Honorable Supreme Court of Pakistan and the appellant alone cannot be made a scapegoat.
- G. Because a vested right in favour of the appellant has been created wherein appellant have performed duty for almost 03 years and appellant cannot be divested of the same.
- H. Because the principle of Audi Alteram Partem is to be read into every statute.
- I. Because as per the principle of Audi Alteram Partem (No one can be condemned unheard), which principle has been defeated in the instant case as the appellant has neither been charge sheeted, nor statement of allegation has been issued nor show cause notice has been issued nor any opportunity of hearing has been afforded nor the appellant has associated with any inquiry nor any witness has been examined in presence of the appellant nor any opportunity of cross examination has been provided.
- J. Because the appointment order has been passed after observing all codal formalities and in accordance with law and once the appointment order has been acted upon and the appellant has performed duty for almost 03 years,

then the Department cannot back-track as per principle of locus poenitentiae as a vested right has been created in favour of the appellant.

- K. Because there is no provision of disowning appointment order in service laws/ Govt Servant E&D Rules 2011.
- L. Because the DEO(F) Swabi has transgressed her authority by issuing the impugned notification.
- M. Because there is no reason much less plausible for disowning the appointment order.
- N. Because the DEO(F) Swabi who signed the appointment order has not even been questioned to this effect.
- O. Because appellant has no approach to the official record of Education Department.
- P. Because the DEO(F) Swabi who signed the appointment order has never been inquired about the appointment order and she has never disowned the said appointment order and in such eventuality, the disowning of appointment order by the current DEO(F) Swabi has no legal significance and illogical.
- Q. Because appellant is jobless and entitled for back benefits.

It is therefore humbly prayed that on acceptance of this service appeal, impugned notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant may please be set aside and appellant may please be reinstated in service with all back benefits.

The Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Services) Act, 2022. Khyber Pakhtunkhwa act No. XLI of 2022).

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazettee of the Khyber Pakhtunkhwa. (Extraordinary) dated the 20th September, 2022).

AN ACT

To provide for the appointment and regularization of the services of certain teachers appointed on ad hoc contract basis in the Elementary and secondary Education Department in the province of Khyber Pakhtunkhwa

Whereas it is expedient to provide for the appointment and regularization of the services of certain teachers appointed on ad hoc contract basis in the Elementary and Secondary Education Department in the Province of Khyber Pakhtunkhwa in the public interest.

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title, application and commencement. This Act may be called the Khyber Pakhtunkhwa. (Extraordinary) dated the 20th September, 2022).
- (2) It shall apply to all the teachers as defined in clause (d) of sub section of Section 2 of this Act.
- (3) It shall come into force at once. ...
 - 2. Definitions (1) in this act, unless the context otherwise requires.

Jun Old Juntastur KHYBER PAKHTUNKHWA GOVERNMENT GAZETTE, EXTRAORDINARY, 20TH SEPTEMBER, 2022.

(a) "Government" means the Government of Khyber Pakhtunkhwa,

(b) "law or rules" means the law or rules, for the time being in force, governing the selection and appointment of civil servants:

(c) "post" means a post of teacher in the Elementary and Secondary Education Department: and

- (d) "teachers" mean duly qualified persons, who are appointed as Primary School Teachers, Certified Teachers. Drawing Masters. Physical Education Teachers. Theology Teachers. Arabic Teachers. Qari/Qaria Teachers. Certified Teachers IT. Primary Teachers and Secondary School Teachers, having different pay scales, in the Elementary and Secondary Education Department, on ad-hoc/contract basis, through National Testing Service/the Khyber Pakhtunkhwa Educational Testing and Evaluation Agency (ETEA) or any other testing service, but does not include the teachers engaged on work charge basis or who are paid out of contingencies or engaged by Parent Teachers Council.
- (2) The expressions "ad-hoc appointment" shall have the same meaning as is respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act. 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).
- 3. Regularization of services of teachers.---(1) Notwithstanding anything contained in any law or rules, for the time being in force, all the teachers, who are holding various posts from 08.03.2017 till the commencement of this Act, shall be validly appointed, on regular basis, from the date of their initial appointment: provided that.
 - (a) they possess the same qualification and experience required for a regular post:
 - (b) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the Commencement of this Act:
 - (c) the service promotion quota of all service cadres shall not be affected; and
 - (d) they shall be entitled for seniority and pay from the date of their initial appointment on ad-hoc/contract basis
- (2) The services of the teachers shall be deemed to have been regularized only on the publication of their names in the official Gazette.
- 4. Overriding effect. Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules, to the extent of inconsistency to this Act, shall cease to have effect.

- 1. Whereas the competent authority MS: SOFIA TABASSUM DEO (F) Swabi, during perusal of record, got suspected on her initial recruitment and found that some teachers of various cadres (CT, CT-IT, TT Qaria), have been appointed on extraneous grounds during 2019 & 2020.
- 2. AND Whereas, the office constituted a fact-finding enquiry committee vide DEO (F) Swabi Endstt No 462 Dated 14/02/2022 and Endstt N0 658-61 Dated 04-03-2022.

AND Whereas the DEO (F) Swabi sent a report regarding appointments on extraneous grounds to the worthy Director E & Sec Education Peshawar consequent upon which vide Endstt No. 789-92/A-23/complaint /Mardan vol-II/2021 Dated Peshawar, Mr. Sharif Gul Principal BPS-19 was nominated as enquiry officer.
- 5. AND Whereas the enquiry officer conducted his enquiry, wherein he affirmed and agreed with the enquiry report already conducted by DEO (F) Swabi as mentioned above, submitted to the Director E & SED Khyber Pakhtunkhwa vide No. 116 Dated 29/06/2022.
- 6. AND Whereas the Director E & SED Peshawar, directed the undersigned to disown the appointment order of fake and bogus teachers vide No 1577/A-23/MS/complaint/ Mardan/vol-II/2021/KC.
- 7. AND Whereas MS: SAINA was appointed as TT under 2% disabled quota vide Endstt No. 3993-G/DA-II Dated 29/07/2019. PRAYER: On acceptance of this departmental appeal, impugned notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant may please be set aside and appellant may please be reinstated in service with all back benefits.

Respected Sir,

Appellant humbly submits as under:

- 1. That appellant was appointed as Theology Teacher (TT) in BPS-15 vide w.e.f 01/09/2019 vide appointment order dated 29/07/2019 which is duly signed by the DEO(F) Swabi (Copy of the appointment order dated 01/09/2019 is attached as Annexure A)
- 2. That appellant was appointed as TT after due recommendation of the Departmental Selection Committee wherein the minutes of the meeting dated 28/07/2019 clearly states that all codal formalities have been completed for appointment and the appellant is recommended for appointment on merit (Copy of the minutes of the Departmental Selection Committee meeting dated 28/07/2019 is attached as Annexure B)
- That after observing all codal formalities and due verification, the District Education Officer (Female) Swabi issued the pay release order dated 25/09/2019 of the appellant (Copy of the pay release order dated 25/09/2019 is attached as Annexure C)
- 4. That appellant performed her duty to the entire satisfaction of her superiors and was holding the post of Theology Teacher (TT) in GGHS Zaida Swabi.

- 5. That the District Education Officer (F) Swabi extended the contract period of the appellant vide notification dated 31/12/2020 (Copy of the notification dated 31/12/2020 is attached as Annexure D)
- 6. That the appellant at the time of appointment was given the assurance by the Department that the contractual service of the appellant would be regularized as the services of other similarly placed employees and previous employees have been regularized by the Department and to this effect a resolution has been passed by the Provincial Assembly of KP to regularize the services of all employees and therefore the services of the appellant are to be considered as regular.
- 7. That the Head Mistress GGHS Zaida has issued a duty certificate dated 01/03/2021 in respect of the appellant wherein she affirmed that the appellant is on duty at GGHS Zaida as TT (Copy of the duty certificate dated 01/03/2021 is attached as Annexure E)
- 8. That the salary of the appellant was stopped, for release of salary the appellant submitted an application dated 19/04/2022 (Copy of the application dated 19/04/2022 is attached as Annexure F)
- 9. That appellant performed duty and received salaries as Theology Teacher while being posted at GGHS Ziada Swabi (Copy of the monthly salary statement is attached as Annexure G)
- 10. That neither any inquiry was conducted nor the appellant was associated with any such inquiry.
- 11. That vide notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022, the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts (Copy of the notification dated 05/08/2022 is attached as Annexure H)
- 12. That the impugned notification bearing Endst No 1914-1919/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 15/08/2022 is illegal against law and facts on the following grounds:

GROUNDS:

- A. Because appellant is innocent and falsely charged.
- B. Because appellant was not associated with the enquiry proceedings nor any witness was examined in presence of the appellant nor appellant was confronted with any documents/record.

- D. Because the concerned officers were neither interrogated nor arrayed as an accused in the instant case which is a glaring illegality and appellant being a low-paid employee has been made a scapegoat.
- E. Because all codal formalities have been completed and appellant is eligible for the post of Theology Teacher (TT).
- F. Because the whole inquiry and the whole proceedings are illegal as appellant cannot be targeted alone while excluding all the concerned government servants, their DEOs(F), the DA II/EMIS etc which is against the judgments of the Honorable Supreme Court of Pakistan and the appellant alone cannot be made a scapegoat.
- G. Because a vested right in favour of the appellant has been created wherein I have performed duty for almost 03 years and I cannot be divested of the same.
- H. Because the principle of Audi Alteram Partem is to be read into every statute.
- I. Because as per the principle of Audi Alteram Partern (No one can be condemned unheard), which principle has beend defeated in the instant case as the appellant has neither been charge sheeted, nor statement of allegation has been issued nor show cause notice has been issued nor any opportunity of hearing has been afforded nor the appellant has associated with any inquiry nor any witness has been examined in presence of the appellant nor any opportunity of cross examination has been provided.
- J. Because the appointment order has been passed after observing all codal formalities and in accordance with law and once the appointment order has been acted upon and the appellant has performed duty for almost 03 years, then the Department cannot back-track as per principle of locus poenitentiae as a vested right has been created in favour of the appellant.
- K. Because there is no provision of disowning an appointment order in service laws/ Govt Servant E&D Rules 2011.
- L. Because the DEO(F) Swabi has transgressed her authority by issuing the impugned notification.
- M. Because there is no reason much less plausible for disowning the appointment order.
- N. Because the DEO(F) Swabi who signed the appointment order has not even been guestioned to this effect.
