



SUBJECT: Appeal under section 4 of Service Tribunal Act against the notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts.

Respected Sir,

Appellant humbly submits as under:

1. That appellant is resident of District Swabi as evident from her CNIC & domicile (Copy of the CNIC and domicile is attached as Annexure A)
2. That appellant is qualified upto Bachelors (BS) in economics (Copies of the academic documents are attached as Annexure B)
3. That appellant is appointed as CT (BPS-15) vide appointment order bearing Endst No 1533-40/DA-1/APP/CT-F/2020 dated 07/07/2020 which is duly signed by respondent no 4 (Copy of the appointment order dated 07/07/2020 is attached as Annexure C)
4. That at the time of appointment, the appellant was given a

medical fitness certificate which is duly signed by the Medical Superintendent DHQ Teaching Hospital Swabi **(Copy of the medical certificate is attached as Annexure D)**

5. That appellant was appointed as CT after due recommendation of the Departmental Selection Committee after observing all codal formalities for appointment and the appellant is recommended for appointment on merit.
6. That respondent no 4 issued a corrigendum dated 08/09/2020 in respect of the appellant's place of posting **(Copy of the corrigendum is attached as Annexure E)**
7. That after observing all codal formalities and due verification, the District Education Officer (Female) Swabi issued the pay release order of the appellant **(Copy of the pay release order dated 08/09/2020 is attached as Annexure F)**
8. That appellant performed her duty to the entire satisfaction of her superiors and was holding initially the post of CT in GGMS Jamra and later on in GGHS Lahor Sharqi **(Copy of the duty certificate is attached as Annexure G)**
9. That appellant is again posted and adjusted in GGMS Tordher Swabi **(Copy of the adjustment order, transfer of charge certificates and duty relieving chit is attached as Annexure H)**
10. That the appellant at the time of appointment was given the assurance by the Department that the contractual service of the appellant would be regularized as the services of other similarly placed employees and previous employees have been regularized by the Department and to this effect an Act by the name of Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Services) Act 2022 has been passed by the Provincial Assembly of KP to regularize the services of all employees and therefore the services of the appellant are to be considered as regular. **(Copy of the Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Services) Act 2022 is attached as Annexure I)**
11. That the appellant duly performed her duty as evident from the attendance register of teachers **(Copy of the attendance register is attached as Annexure J)**
12. That appellant performed duty and received salaries as CT while being posted at GGMS Tordher Swabi **(Copies of the monthly salary statements are attached as Annexure K)**
13. That so much so that appellant performed duty at polling station

as Assistant Presiding Officer during the local government elections **(Copy of the appointment order of appellant as Assistant Presiding Officer is attached as Annexure L)**

14. That neither any inquiry was conducted nor the appellant was associated with any such inquiry.
15. That vide notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022, the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts **(Copy of the notification dated 05/08/2022 is attached as Annexure M)**.
16. That appellant dispatched departmental appeal dated 05/09/2022 against the notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 through registered post which remained un-responded **(Copy of the departmental appeal dated 05/09/2022 along with post office receipt is attached as Annexure N)**
17. That the impugned notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 is illegal against law and facts on the following grounds:

GROUND:

- A. Because appellant is innocent and falsely charged.
- B. Because appellant was not associated with the enquiry proceedings nor any witness was examined in presence of the appellant nor appellant was confronted with any documents/record.
- C. Because appellant has neither been charge sheeted nor statement of allegation has been issued to the appellant nor show cause notice has been given to the appellant.
- D. Because the concerned officers were neither interrogated nor arrayed as an accused in the instant case which is a glaring illegality and appellant being a low-paid employee has been made a scapegoat.
- E. Because all codal formalities have been completed and appellant is eligible for the post of CT.
- F. Because the whole inquiry and the whole proceedings are illegal

as appellant cannot be targeted alone while excluding all the concerned government servants, their DEOs(F), the DA II/EMIS etc which is against the judgments of the Honorable Supreme Court of Pakistan and the appellant alone cannot be made a scapegoat.

- G. Because a vested right has accrued to the appellant wherein appellant has performed duty for almost 2 years and appellant cannot be divested of the same.
- H. Because the principle of Audi Alteram Partem is to be read into every statute.
- I. Because as per the principle of Audi Alteram Partem (No one can be condemned unheard), which principle has been defeated in the instant case as the appellant has neither been charge sheeted, nor statement of allegation has been issued nor show cause notice has been issued nor any opportunity of hearing has been afforded nor the appellant has been associated with any inquiry nor any witness has been examined in presence of the appellant nor any opportunity of cross examination has been provided.
- J. Because the appointment order has been passed after observing all codal formalities and in accordance with law and once the appointment order has been acted upon and the appellant has performed duty for almost 2 years, then the Department cannot back-track as per principle of locus poenitentiae as a vested right has accrued to the appellant.
- K. Because there is no provision of disowning an appointment order in service laws/ Govt Servant E&D Rules 2011.
- L. Because the DEO(F) Swabi has transgressed her authority by issuing the impugned notification.
- M. Because there is no reason much less plausible for disowning the appointment order.
- N. Because the DEO(F) Swabi who signed the appointment order has not even been questioned to this effect.
- O. Because appellant has no approach to the official record of Education Department.
- P. Because appellant is jobless and entitled for back benefits.

It is therefore humbly prayed that on acceptance of this appeal, impugned notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant may please be set aside and appellant may please be reinstated in service with all back benefits.

The Khyber Pakhtunkhwa Teachers (Appointment and Regularization of Services) Act, 2022. Khyber Pakhtunkhwa act No. XLI of 2022).

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazettee of the Khyber Pakhtunkhwa. (Extraordinary) dated the 20th September, 2022).

AN ACT

To provide for the appointment and regularization of the services of certain teachers appointed on ad hoc contract basis in the Elementary and secondary Education Department in the province of Khyber Pakhtunkhwa

Whereas it is expedient to provide for the appointment and regularization of the services of certain teachers appointed on ad hoc contract basis in the Elementary and Secondary Education Department in the Province of Khyber Pakhtunkhwa in the public interest.

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title, application and commencement. This Act may be called the Khyber Pakhtunkhwa. (Extraordinary) dated the 20th September, 2022).

(2) It shall apply to all the teachers as defined in clause (d) of sub section of Section 2 of this Act.

(3) It shall come into force at once.

2. Definitions (1) in this act, unless the context otherwise requires.

- (a) "Government" means the Government of Khyber Pakhtunkhwa,
- (b) "law or rules" means the law or rules, for the time being in force, governing the selection and appointment of civil servants;
- (c) "post" means a post of teacher in the Elementary and Secondary Education Department; and
- (d) "teachers" mean duly qualified persons, who are appointed as Primary School Teachers, Certified Teachers, Drawing Masters, Physical Education Teachers, Theology Teachers, Arabic Teachers, Qari/Qaria Teachers, Certified Teachers II, Primary Teachers and Secondary School Teachers, having different pay scales, in the Elementary and Secondary Education Department, on ad-hoc/contract basis, through National Testing Service/the Khyber Pakhtunkhwa Educational Testing and Evaluation Agency (ETEA) or any other testing service, but does not include the teachers engaged on work charge basis or who are paid out of contingencies or engaged by Parent Teachers Council.

(2) The expressions "ad-hoc appointment" shall have the same meaning as is respectively assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973).

3. Regularization of services of teachers.---(1) Notwithstanding anything contained in any law or rules, for the time being in force, all the teachers, who are holding various posts from 08.03.2017 till the commencement of this Act, shall be validly appointed, on regular basis, from the date of their initial appointment: provided that.

- (a) they possess the same qualification and experience required for a regular post;
- (b) they have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground, before the Commencement of this Act;
- (c) the service promotion quota of all service cadres shall not be affected; and
- (d) they shall be entitled for seniority and pay from the date of their initial appointment on ad-hoc/contract basis

(2) The services of the teachers shall be deemed to have been regularized only on the publication of their names in the official Gazette.

4. Overriding effect. Notwithstanding anything to the contrary contained in any other law or rules for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rules, to the extent of inconsistency to this Act, shall cease to have effect.

5. AND whereas the enquiry officer conducted his expiry, wherein he affirmed and agreed with the enquiry report already conducted by DEO (F) Swabi as mentioned above, submitted to the Director E&SED Khyber Pakhtunkhwa vide No. 116 date 299.06.2022
6. AND whereas the Director E & SED Peshawar, director the undersigned to disown the appointment order of fake and bogus teachers vide No. 1577/A-23/MS/ Complaint/ Mardan/ Vol II/ 2021/ KC.
7. Whereas MS Qudsia was appointed as CT vide ENdst No. 1533-40/DA-I. APP/CT-F/2020 dated 07.07.2020 at GGMS Jamra (Swabi) Now at GGMS Tordher (Swabi). The Diary No. of the appointment order is absolutely fake. The pay release orders are manipulated and bogus. The employee badly failed to provide concrete justification of her appointment during enquiry proceedings. Her appointed is open adhoc contract base.

Subject: Departmental appeal against the notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts.

PRAYER: On acceptance of this departmental appeal, impugned notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 wherein the DEO(F) Swabi has opined to disown the appointment order of the appellant may please be set aside and appellant may please be reinstated in service with all back benefits.

Respected Sir,

Appellant humbly submits as under:

1. That appellant was appointed as CT GGMS Jamra Swabi **(Copy of the appointment order is attached as Annexure A)**
2. That at the time of appointment, the appellant was given a medical fitness certificate which is duly signed by the Medical Superintendent DHQ Teaching Hospital Swabi **(Copy of the medical certificate is attached as Annexure B)**
3. That appellant was appointed as CT after due recommendation of the Departmental Selection Committee after observing all codal formalities for appointment and the appellant is recommended for appointment on merit.
4. That after observing all codal formalities and due verification, the District Education Officer (Female) Swabi issued the service book of the appellant and consequently issued the pay release order of the appellant **(Copy of the service book is attached as Annexure C)**
5. That appellant performed her duty to the entire satisfaction of her superiors and was holding the post of CT in GGMS Tordher Swabi.

- 6. That the appellant at the time of appointment was given the assurance by the Department that the contractual service of the appellant would be regularized as the services of other similarly placed employees and previous employees have been regularized by the Department and to this effect a resolution has been passed by the Provincial Assembly of KP to regularize the services of all employees and therefore the services of the appellant are to be considered as regular.
- 7. That the appellant duly performed her duty as evident from the attendance register of teachers **(Copy of the attendance register is attached as Annexure D)**
- 8. That appellant performed duty and received salaries as CT while being posted at GGMS Tordher Swabi **(Copies of the monthly salary statements are attached as Annexure E)**
- 9. That neither any inquiry was conducted nor the appellant was associated with any such inquiry.
- 10. That vide notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022, the DEO(F) Swabi has opined to disown the appointment order of the appellant which is illegal against law and facts **(Copy of the notification dated 05/08/2022 is attached as Annexure F)**
- 11. That the impugned notification bearing Endst No 1902-1907/File dated 05/08/2022 passed by District Education Officer Female Swabi received on 16/08/2022 is illegal against law and facts on the following grounds:

GROUND:

- A. Because appellant is innocent and falsely charged.
- B. Because appellant was not associated with the enquiry proceedings nor any witness was examined in presence of the appellant nor appellant was confronted with any documents/record.
- C. Because appellant has neither been charge sheeted nor statement of allegation has been issued to the appellant nor show cause notice has been given to the appellant.
- D. Because the concerned officers were neither interrogated nor arrayed as an accused in the instant case which is a glaring illegality and appellant being a low-paid employee has been made a scapegoat.

- E. Because all codal formalities have been completed and appellant is eligible for the post of CT.
- F. Because the whole inquiry and the whole proceedings are illegal as appellant cannot be targeted alone while excluding all the concerned government servants, their DEOs(F), the DA II/EMIS etc which is against the judgments of the Honorable Supreme Court of Pakistan and the appellant alone cannot be made a scapegoat.
- G. Because a vested right has accrued to the appellant wherein appellant has performed duty for almost 2-3 years and appellant cannot be divested of the same.
- H. Because the principle of Audi Alteram Partem is to be read into every statute.
- I. Because as per the principle of Audi Alteram Partem (No one can be condemned unheard), which principle has been defeated in the instant case as the appellant has neither been charge sheeted, nor statement of allegation has been issued nor show cause notice has been issued nor any opportunity of hearing has been afforded nor the appellant has been associated with any inquiry nor any witness has been examined in presence of the appellant nor any opportunity of cross examination has been provided.
- J. Because the appointment order has been passed after observing all codal formalities and in accordance with law and once the appointment order has been acted upon and the appellant has performed duty for almost 2-3 years, then the Department cannot back-track as per principle of locus poenitentiae as a vested right has accrued to the appellant.
- K. Because there is no provision of disowning an appointment order in service laws/ Govt Servant E&D Rules 2011.
- L. Because the DEO(F) Swabi has transgressed her authority by issuing the impugned notification.
- M. Because there is no reason much less plausible for disowning the appointment order.
- N. Because the DEO(F) Swabi who signed the appointment order has not even been questioned to this effect.
- O. Because appellant has no approach to the official record of Education Department.
- P. Because appellant is jobless and entitled for back benefits.
