JUNIOR CLERK FROM DATE 01-06-2022 WITH ALL BACK
BENEFITS AND DECLARE THE PROMOTION ORDER OF
RESPONDENT 3 TO 8 AS AGAINST SENIORITY LIST
RULES AND REGULATION AGAINST KPK CIVIL SERVANT
ACT 1973 BASED ON MALA FIDE NEPOTISM AND
FAVORITISM.



Respectfully Sheweth :-

1. That petitioner is belong to District Bannu having certificate of higher secondary education and on dated 20-09-1987 was appointed as a chowkider and senior most class iv employees of the responents department.
(copy of the qualification and service book is annexed as annexure A & B').
2. That according to KPK Civil Servant Act 1973 for promotion joint seniority list of Class iv shall be prepared and then after promotion cases will be consider by the departmental promotion committee on the basis of seniority cum fitness where 33 % quota is given in junior clerk post from class iv employee, but till dated no seniority list is prepared nor promotion are made but on political intervention they promote the calss iv employees on their own sweet will is clear from promotion order of

Respondent No. 3 to 8 dated 01/06/2022. (Copy of Promotion policy of class iv is annexed as annexure C”).

3. That on dated 01-06-2022 respondent No. 2 without seniority list promoted respondent No. 3 to 8 on political intervention without coddle formalities denied the petitioner from promotion without any justification despite the fact that petitioner has clean service record throughout and the most senior class iv employee of the respondent department and having vested right for promotion. (Copy of the promotion order is annexed as annexure D”).
4. That after petitioner on dated 20-09-2022 preferred service appeal which is unrespond till date. (copy of service appeal and registry receipt is annexed as annexure E & F”).
5. That having no other officious remedy for relief the petitioner invokes the jurisdiction of this Hon'ble Service Tribunal for redressed of his grievance which is relates to his terms and condition of his service inter alia on the following grounds.

GROUNDS:-


- A. That no seniority list is prepared nor are appointment / promotion made from the seniority list which is against KPK Civil Servant Act 1973 hence reversible.
- B. That promotion of the respondents 3 to 8 are against norms of administration of good governance where senior is denied while junior are given the promotion which is against the policy of merit promotion policy of class iv of the respondents department.
- C. That respondent made discrimination between the class iv employees of the respondent department were above 5 hundred class iv employees serving in the respondents department and made pick and chose in the

promotion of class iv due to which senior employees are denied promotion hence promotion order dated 01-06-2022 is reversible for public interest and petitioner is entitled from promotion from 01-06-2022.

D. That promotion order of Respondent 3 to 8 is clear cut violation of article 4,5,25 of the constitution hence fundamental rights of the petitioner is infringed so this tribuna. has jurisdiction to see the violation of fundamental of the petitioner as well as other employees of the respondents department.
