### Preliminary objections:

- 1. That the appellant has got no cause of action locus standi.
- 2. That the instant Service appeal is badly time barred.
- 3. That the appellant has concealed material facts from the Hon'able Tribunal in the instant service appeal.
- 4. That the instant service appeal is against the relevant provisions of law.
- 5. That the appellant has not come to this Hon'able Tribunal with clean hands.
- 6. That the instant appeal is liable to be dismissed for mis-joinder & non-joinder of the necessary parties to the present appeal.
- 7. That the appellant is estopped by his own conduct to file the instant appeal.
- 8. That the instant service appeal is not maintainable in the present form & circumstances of the case.

### **FACTS**

- 1. That Para No: 1 of the fact memorandum of the appeal pertains to record. However the appellant services are suspended w.e.f. 18.10.2021till date (Copy of suspension order ,FIR, confirmation of FIR & DPO Kohat confirmation letters) are annexed as Annexure A)
- 2. That Para No: 2 pertain to record, however a proper criminal case was registered against the appellant by the Policy Department & wherein he has been directly charged with the specific criminal role of a criminal act which is against to the norm of state institutions & tarnished the image of the authority creating ill-will among the employees as well as general public.
- 3. That Para No: 3 pertain to record.

- 4. That Para No: 4 pertain to record.
  - 5. That Para No: 5 pertain to record.
  - 6. That Para No: 6 pertain to record, but the appellant himself admitted the criminal charges & also established the facts that being accused, he remained behind the bars. But it is to pertinent to mentioned here that the appellant till date have not produced any lawful justification before the answering department of his innocence.
  - 7. That Para No: 7 pertain to record.
  - 8. That Para No: 8 is correct and pertain to record.
  - 9. That Para No: 9 is legal, however the appellant himself admitted that the criminal case is subjudice before the court that bars the authority for issuing and appropriate order.
  - 10. That Para No: 10 is already explained vide Para No: 9 above as the order of suspension of the appellant is still intact with few observations.
  - 11. That Para No: 11 is already explained in above leading Para. Hence need no comments.
  - 12. That Para No: 12 is correct & pertains to record.
  - 13. That Para No: 13 pertain to record.
  - 14. That Para No: 14 pertain to record.
  - 15. That Para No: 15 pertain to record. Rest of the Para regarding to the apply is incorrect.

    Application is duly replied vide DEO (M) Kohat letter No: 3534 dated 07.07.2022 (Copy annexed as annexure B) as he has already exercised locus standi. Hence on the score of tendering repetition of stereo type application with the same cause of action.
  - 16. That Para No: 16 is legal.

#### **GROUNDS:-**

- a. Para (a) of the ground is incorrect, Respondent department has issued a proper order with independent mined & with lawful reason.
- b. Para (b) of the grounds is incorrect. Proper order of suspension was issued in accordance with law & duly intimated to the concerned quarters including appellant.
- c. Para(c) is incorrect. The order of the respondent is legal, lawful & in accordance with the law & mere mentioning section of law is bad in eye of law.
- d. Para(d) is incorrect already explained in Para (c).

- e. Para (e) is incorrect. The appellant services were suspended, not removed. And after the decision of the criminal case the respondent department will issue another appropriate order.
  - f. Para (f) is legal.
  - Para (g) is irrelevant.
  - h. Para (h) is irrelevant & not based on sound reasons.
  - Para (i) is incorrect and already discussed above.
  - Para (j) is incorrect and already discussed above. Hence need no comments.
  - k. Para (k) is pertaining to record & incorrect to the extent that the respondent department issue appropriate order which is still in field.
  - 1. Para (1) is incorrect. After the Court decision the respondent department will review the Court order & will pass further order which is in accordance with the law.
  - m. Para (m) is incorrect and not based on solid reason.
  - n. Para (n) is incorrect as a proper legal order has been issued which need no indulgences.

#### PRAYER:-

It is therefore humbly prayed that the appeal in hand of the appellant is pre mature as the services of any accused official cannot be re-instated until & unless the contrary is not proved.
