

APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974 AGAINST THE LETTER DATED 21-11-2022, (COPY OF WHICH HAS BEEN OBTAINED BY THE APPELLANT THROUGH HIS EFFORTS ON 08-12-2022) VIDE WHICH DEPARTMENTAL APPEAL OF THE APPELLANT FILED FOR THE MODIFICATION OF NOTIFICATION DATED 31-05-2019, HAS BEEN REGRETTEED.

PRAYER:-

On acceptance of this appeal, the impugned decision conveyed vide Letter dated 21-11-2022, may kindly be set aside and the appellant may kindly be ordered to be given proforma promotion as Principal Medical Officer (BPS-19) with effect from 31-05-2019, i.e., the date his immediate junior has been promoted with all back benefits.

Respectfully Submitted:

1. That the appellant was initially appointed as Medical Officer on contract basis in (BPS-17) vide Order dated 04-12-1995 and subsequent to amendment in Section 19 of the Civil Servants Act 1973, the services of the appellant were regularized with effect from the year 2001. Since appointment, the appellant performed his duties with honesty and full devotion and to the entire satisfaction of his high ups with no complaint during his entire service career.
2. That the appellant being perfectly, eligible and coming up to the criteria was promoted as Senior Medical Officer (BPS-18) along with others vide Notification dated 15-11-2017, the name of appellant is placed at

Serial No 258 of the stated Notification. **(Copy of Notification dated 15-11-2017 is enclosed as Annexure B).**

3. That the appellant being perfectly fit, senior eligible and coming up to the criteria, was expecting his promotion as Principal Medical Officer (BPS-19) and even vide Letter dated 13-11-2018, the necessary documents including the ACR,s in respect of 599 Doctors including the appellant were called for promotion to BPS-19, which were duly provided by the appellant vide Diary No 12175/E-1/AOL dated 01-04-2019 as also evident from Letter No 6194 of 2018. **(Copy of Letter dated 13-11-2018 & Letter No 6194 is enclosed as Annexure C).**
4. That shockingly, juniors to the appellant including Dr. Rawesh Mohmand, Dr. Gulab Khan, Dr. Said Muhammad besides others were promoted as Principal Medical Officers BPS-19 vide Notification dated 31-05-2019 while the appellant being perfectly fit, eligible and senior was denied such promotion for no fault on his part. **(Copy of Notification dated 31-05-2019 is enclosed as Annexure D).**
5. That the appellant approached respondents for his promotion as Principal Medical Officer (BPS-19) w.e.f. 31-05-2019 vide appeal dated 11-08-2022, and in the meanwhile the appellant got retired from service vide Notification dated 05-12-2022. **(Copy of departmental appeal & Notification dated 05-12-2022 is enclosed as Annexure E & F).**
6. That finally the appellant came to know about the rejection of his departmental appeal, copy of which was never communicated to the appellant despite repeated requests and finally the appellant through his own efforts obtained copy of letter dated 21-11-2022 on 08-12-2022 whereby appeal of the appellant was regretted. **(Copy of Letter dated 21-11-2022 is enclosed as Annexure G).**
7. That the impugned order/decision conveyed vide Letter dated 21-11-2022, is against the law, facts and principles of justice on grounds inter-alia as follows:

GROUND:


- A. That the omissions and commissions of the respondents and order/decision conveyed vide Letter dated 21-11-2022 is illegal, unconstitutional, and unlawful, without lawful authority and of no legal effect, therefore need the interference of this honorable Tribunal.
- B. That the appellant is not treated according to law and rules which being his fundamental right as per Article 4 and 25 of the Constitution and law of the land.

- C. That the appellant is perfectly fit, eligible, having the requisite length of service besides senior for promotion as Principal Medical Officer (BPS-19) and the impugned decision/order is as such liable to be set at naught.
- D. That the appellant has served for more than 27 years and retired from service w.e.f. 14-08-2022 with spotless service career, is senior, besides having excellent ACRs during this period and as such was perfectly fit and eligible to had been promoted as Principal Medical Officer (BPS-19) from the date juniors to him were promoted.
- E. That even the ACR,s etc of the appellant were called for in the year 2018 along with others which were duly provided by the appellant but even then he was not promoted for reasons best known to the respondents.
- F. That the appellant is perfectly fit, eligible, senior and coming up to the criteria as per law and rules on the subject, while juniors to him have been promoted denying such right to the appellant for no fault on his part.
- G. That the impugned order/decision is not tenable for the reason that Rule 17 of the Fundamental Rules allows promotion after retirement if a civil servant is entitled for the same and is deprived of the same for no fault, hence the appellant is entitled to be promoted as Principal Medical Officer (BPS-19) from the date his immediate junior was promoted.
- H. That promotion being recurring cause of action and Rule 17 of the Fundamental Rules protects such promotions.
- I. That Seniority cum fitness is the universal formula governing promotion which is also protected by law and rules on the subject, thus too the appellant is entitled to proforma promotion.
- J. That the fundamental rights of the appellant have been violated guaranteed in the Constitution and respondents are not ready to treat the appellant-as per law and rules on the subject.
- K. That the fundamental rights of the appellant guaranteed in the Constitution are badly violated and he is not treated as per law and rules governing the matter, he would suffer irreparable loss.
- L. That the appellant seeks the permission of this honorable Court for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for.

Any other relief deemed appropriate in the circumstances of the case and not specifically asked for may also be granted in favor of the appellant.
