APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA, SERVICE TRIBUNAL ACT 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 08-06-2022 OF RESPONDENT NO 1, WHEREBY DEPARTMENTAL APPEAL OF THE APPELLANT FILED AGAINST THE NOTIFICATION DATED 16-08-2021 HAS BEEN REJECTED.

PRAYER:-

On acceptance of this appeal the impugned Notification dated 08-06-2022 of respondent No 1 and Notification dated 16-08-2021 of respondent No 2, may kindly be set aside and the appellant may kindly be ordered to be reinstated in service with all back benefits.

Respectfully Submitted:-

- 1. That the appellant was initially appointed as Secondary School Teacher Bio-Chemistry on Adhoc basis vide Order dated 30-04-2014 and her services were later on regularized. Since appointment the appellant performed her duties with honesty and full devotion and to the entire satisfaction of her high ups.
- 2. That upon ex-parte proceedings, on unfounded allegations of absence from duty w.e.f 22-10-2020, the appellant was awarded the major penalty of Removal from service by respondent No 2 vide Notification dated 16-08-2021. (Copy of Notification dated 16-08-2021 is enclosed as Annexure A).
- **3.** That strangely, the on the same allegations of absence from duty, the appellant was awarded the penalty of one day salary deduction and the alleged absence period was treated as leave

without pay vide Notification dated 27-09-2021. (Copy of Notification dated 27-09-2021 is enclosed as Annexure B).

- 4. That the appellant filed departmental appeal before respondent No 1 which was also rejected vide Notification dated 08-06-2022, however copy of the said Notification was never communicated to the appellant and the appellant obtained copy of the same through her own efforts on 16-11-2022. (Copy of Appeal & Notification dated 08-06-2022 is enclosed as Annexure C & D).
- **5.** That the impugned Notification dated 08-06-2022 of respondent No 1 and Notification dated 16-08-2021 of respondent No 2, are against the law, facts and principles of justice on grounds inter-alia as follows:-

<u>G R O U N D S:-</u>

KURICALE:

- **A.** That the impugned Notifications are is illegal, unlawful, without lawful authority and void ab-initio.
- **B.** That mandatory provisions of law and rules have been badly violated by the respondents and the appellant has not been treated according to law and rules in violation of Article 4 and 25 of the Constitution.
- **C.** That the allegations against the appellant are false, baseless and unfounded which is well reflected in the Notifications dated 16-08-2021 and Notification dated 27-09-2021, which are sufficient to prove that the allegations are based on malafide.
- **D**. That due to some physical, psychological and health stress, the appellant was unable to have performed her duties for some days however, awarding major penalty does not commensurate the guilt, thus the impugned Notifications are liable to be set at naught on this score alone.
- **E.** That no Charge Sheet and Show Cause Notice was issued to the appellant.
- **F.** That no inquiry was conducted in the matter nor was any sort of evidence collected to substantiate the allegations.
- **G.** That Ex-parte action has been taken against the appellant and she has been condemned unheard in violation of Article 10-A of the Constitution.

H. That the principles of natural justice were badly violated and the appellant was not heard before adverse order.

- I. That the appellant was not afforded opportunity of personal hearing.
- J. That the appellant is jobless since her illegal removal from service.
- **K.** That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.

Any other relief deemed appropriate and not specifically asked for, may also be granted in favor of the appellant.


