

THE PETITIONER/APPELLANT

Respectfully Sheweth:

That the petitioner/appellant humbly submits as under;

1. That above noted service appeal was filed by the petitioner/appellant before this Hon'ble Tribunal, which is fixed for 12/01/2023.
2. That the this Hon'ble Tribunal call the comments from the respondents and restrained the respondents from taking any adverse action against the petitioner/appellant vide order ated 2/08/2022 but till date the respondents are failed to filed the comments. **(Copy of order dated 02/08/2022 is attached as Annexure-A)**
3. That the despite of clear cut directions the respondents stopped the salary of the petitioner / appellant vide impugned order dated 24/12/2022. **(Copy of impugned order dated 24/12/2022 is attached as Annexure-B)**
4. That the respondents by stopping the salary of the petitioner/appellant committed contempt of this Hon'ble Tribunal, the petitioner/appellant having no other remedy, approaches this Hon'ble Tribunal by filling instant contempt of court petition on the following grounds:

GROUND S:

- A. That non-compliance of the aforesaid order dated 2/08/2022 of this Hon'ble Tribunal by the respondents is illegal, without lawful authority, without jurisdiction, malafide and void ab-initio.
- B. That stopping the salary of the petitioner/appellant is fall within adverse action and this Hon'ble Tribunal restrained the respondents from taking any adverse action against the petitioner/appellant but the respondents issued the impugned letter dated 24/12/2022 by stopping the salary of the petitioner/appellant by mentioning the reason of filling of appeal before this Hon'ble Tribunal.
- C. That thereafter the petitioner approached the Respondents for the implementation of the order of this Hon'ble Tribunal and releaser of her salary, but in vain.
- D. That by not honoring the judgment of this Hon'ble Tribunal the Respondents have intentionally/ willfully and deliberately made contempt of this Hon'ble Tribunal.
- E. That every government functionary is under legal obligation to honour the order of the Court of competent jurisdiction, the respondents by not

complying with the order, have not performed their duty in accordance with law.

- F. That non-compliance of the order of the Honourable Tribunal, speaks malafide on the part of respondents and to lower the position of the judiciary in the eye of public at large.
- G. That from the facts and grounds taken the said service appeal, it has become crystal clear that the respondents have committed contempt of court.
- H. That any other grounds will be raised at the time of arguments with prior permission of this Hon'ble Tribunal.

It is, therefore, most humbly prayed that on acceptance of this application, the contempt of court proceedings may please be initiated against the Respondents, they be summoned, proceeded against and be punished in accordance with law.




1. That the above noted service appeal is pending adjudication before this Hon'ble Tribunal which is fixed for 12/01/2023.

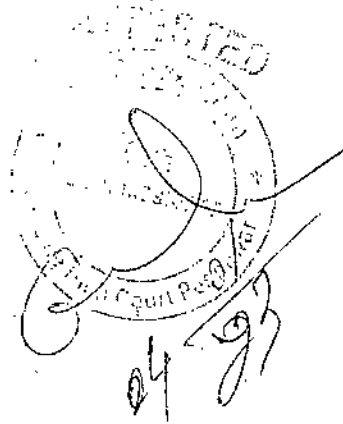

02.08.2021 Counsel for the appellant present. Preliminary arguments heard.

The appellant has impugned the transfer order dated 09.07.2021 through this Service Appeal where against the departmental representation/appeal was filed on 13.07.2021. The present appeal was filed on 16.07.2021 which was returned due to objection from this office that it was filed without completing the period of ninety days after filing of departmental appeal. However, the appeal was re-submitted that requisite period of 15 days as provided under the Policy of the Government has been completed. This Tribunal has already admitted appeals against the transfers on account of the precedent of 15 days period for decision of appeal by the competent authority by overruling the objection of the office for waiting period of ninety days. Therefore, this appeal as matter of consistency has rightly been filed after expiry of 15 days day period. When the appellate authority has failed to decide the appeal within stipulated time according to policy of the government. The appellant contends that the impugned transfer of the appellant is against the tenure as provided under the policy of the Government and no public interest is involved in the impugned order. 



The salary has stopped on your directions and report of the same is submitted for your kind attention please.

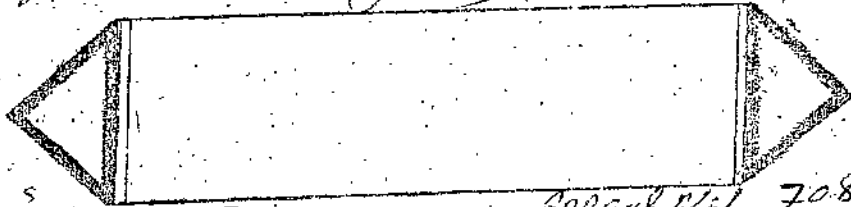
