## PARA WISE COMMENTS ON BEHALF OF RESPONDENT NO. 4.

## Preliminary Objections:

- A. That the Petitioner has no cause of action against the respondent.
- B. That the Petitioner has no locus standie.
- C. That the instant appeal is not maintainable.
- **D.** That the Petitioner has not come to this Honorable Tribunal with clean hands.

### Respectfully Sheweth:-

#### Facts:-

Para 1:- Para No. 1 pertains to records, hence needs no comments.

Para 2: Para No. 2 is incorrect, the appellant has been involved in corrupt practices and at last a complaint was forwarded against him.

Para 3:- Incorrect, the complaint made by replying respondent was proved after proper inquiry.

Para 4:- Admitted as correct.

Para 5:- Correct, the inquiry Committee after thorough Inquiry allegation leveled the appellant and the following penalty was imposed upon him:

- i. One annual increment of the appellant must be stoped.
- ii. Two hours buildozer per hour 1800 total 3600 rupees be recovered from the appellant.
- Para 6:- Para No. 6 is incorrect, the appellant has been re-instated in his service since his suspension date.
- Para 7:- The appellant has been treated in accordance with the law.

#### Grounds:

- a. Incorrect, the appellant has been treated in according to the findings of the inquiry committee and no discriminatory action has been taken against him.
- b. Incorrect, the allegations against the appellant have been proved after thorough inquiry and appellant has been found guilty.
- c. Incorrect, allegations have been proved against the appellant, the inquiry Committee after hearing statement of Gul Nagab Khan Junior flore keeper regarding the appellant misbehavior and attacking the replying respondent, put penalty upon the appellant.
- d. Para "D" is incorrect, the appellant has been treated in accordance with law, the appellant has been given full opportunity to clear his position, further the replying respondent has been promoted on his turn and according to the procedure.
- e. That the appellant was given penalty on solid grounds in light of the inquirty.
- f. Incorrect, the answer has been given in above paras.
- g. Incorrect, the penalty given to the appellant in accordance with the Rules & procedure and no discriminatory treatment has been done with the appellant.

- h. Incorrect, the appellant has been given full opportunity to clear his position before the inquiry Committee, but he badly failed to negate the allegations.
- i. That the appellant has been treated according to the rules and policy.
- j. Incorrect, the appellant has been given penalty on his own rude behavior and committing corrupt practices.
- k. Incorrect, the appellant has been dealt according to law and no discriminatory treatment has been done with the appellant.
- l. The answering respondent has treated the appellant in accordance with the rules and policy.

Whereas Syed Yaqoot Ali Shah, Junior Clerk office of the Assistant Agricultural Engineer, Chitral filed a complaint against Mr. Abdul Aziz Baig, Dozer Operator (BPS-07) in the said office, regarding Misbehaved and beaten him and involvement in different corrupt practices. In this regards inquiry committee was constituted vide office order No.4186-91/DAE/Estt: 3/68 dated 23.04.2020 to inquire into the charges mentioned above against him. The Committee submitted a report wherein the above named officials was found guilty of charges against him. The findings and recommendations of the Committee are as under:-

#### A. FINDINGS:

- i. According to personal hearing, replies and written statements, the committee finds that Syed Yaqoot Ali used abusive works and Mr. Abdul Aziz Baig had beaten Syed Yaqoot Ali Shah.
- ii. The allegation of 600 liters corruption was false as the payment is cleared.
- Deduction of 02 hours was found as admitted by Mr. Abdul Aziz Baig, Dozer Operator in his replies to questionnaire.

#### 8. RECOMMENDATIONS:

- a) Censure must be issued to Syed Yaqoot Ali Shah, Junior Clerk/Unit Supervisor.
- b) One Annual increment of Mr. Abdul Aziz Baig, Dozer Operator must be stopped.
- c). Two Hours i.e. Rs.3600/- of New Holland Bulldozer @Rs.1800/-hour must be recovered from Mr. Abdul Aziz Baig, Dozer Operator through proper challan.

In light of the findings and recommendations of the Inquiry Committee mentioned above, the undersigned is pleased to impose the above mentioned penalties against the officials concerned as per Lifficiency and Disciplinary Rules-2011. The services of Mr. Abdul Aziz Baig, Dozer Operator in office of the Assistant Agricultural Engineer, Chitral are hereby re-instated from the date of suspension.
