

RESPECTFULLAY SHEWETH,

1- That the petitioner in pursuance of the judgment passed by Learned Service Tribunal Khyber Pakhtunkhwa Peshawar dated 30.11.2021 succeeded to get his due seniority as prayed for as

i) The Appellant Name is Placed at list "E" with affect from the date of appointment i.e 10/02/2011.

ii) The Appellant officiating promotion order i.e 03/06/2016 to the rank of Sub Inspector be revised and be given affect from the date of illegibility and be confirmed as Sub Inspector under Rule 13-18 Police Rule 1934

with all back benefit (copy attached as A).

2. That CPLA was moved by Department which was rejected by law department and the judgment got finality. Vide no 159/-dated 11-01-2022- Worthy PPO Khyber Pakhtunkhwa Peshawar ordered RPO Bannu to implement the judgment in its true letter and spirit.as CPLA is rejected. (copies attached as B,C).

3- RPO / Bannu did not implement the judgment despite of clear cut order of PPO / KPK, -EP No 154/2022 into service appeal no 12438/2022 was moved to Service Tribunal Khyber Pakhtunkhwa

4. Last chance was given by service Tribunal to respondents for implementation of the judgment of Service Tribunal dated: 30-11-2021.

5-To implement the judgement RPO/Bannu issued order vide no 353 dated 18.11.21 despite of notification which was not relevant. Written reply was made on 19.11.2021 about its non-relevancy and submitted before Service Tribunal on 21.11.2021.

6- On 20.12.2022 the representative of respondents produce before court the RPO/ Bannu order no 370 dated 12.12.2022 issued vide no 4795- 98 which is 100% similar and conformity to order no 353 dated 18.11.2022 vide no 4516-19.Both the orders are rejected by petitioner vide written replies dated 15.12 2022 and 19.11.2022.It is worth to mention that on production of order no 353 dated 18.11.2022, salaries of respondent no 2 and 3 were attached due to non-implementation of judgment dated 30.11.21 (copy attached as D)

7. Court was requested that according to written reply submitted to Service Tribunal on 21.11.2022 ,if respondents issue notification according to para no 7 reproduce as (RPO Bannu was bound to issue proper gazette notification to admit the name of appellant to list "E" with the Officers already admitted to list "E" on 10-02-2011 vide seniority list No. 827/EC issued on 06-04-2015 of Bannu Region is very much clear the name of appellant deserve to be placed below the name of OSI Muhammad Salim No. 31/B and above the name of OSI Javid Iqbal, and be confirmed as Sub Inspector under 13, 18 of Police Rule 1934 in which seniority list and 3 type of specimens of notifications duly attached with written reply as C.D.E.F then petitioner will be satisfied.

written replay dated 15.12.2012 and fresh specimen of notification are attached as E,F)

8- The representative of the respondents has assured that he will accordingly get the order modified with in week but in vain as representative of respondents produce nothing and looks that he also joking with court. (copy of order sheet attached as H )

9-The respondents while throwing back the well transparent direction and precious judgment of Service Tribunal dated 30.11.2021 has committed a gross illegality which comes within ambit of the contempt of court.

10- The article 204 of the constitution of Islamic republic of Pakistan 1973 read with section 3&4 of the contempt of court ordinance 2003 Service Tribunal has jurisdiction and power to punish the contempter.

11- That while being succeeded to get the judgment dated 30.11.2021.the petitioner has occurred a vested and valuable right and violation thereof will hit by the command of the constitution and by doing so that respondents have exposed themselves to the penal section of the contempt ordinance.

12- That further submission will be advanced at the time of hearing the petitioner at the bar.

**It is therefore humbly prayed that on acceptance of this petition the respondents may be asked with iron hands as to why the petitioner who being eligible, deserving and having proper right of his due seniority in the light of the judgment dated 30 11.2021.is still deprived of his seniority as prayed for and they further be directed to ensure early implementation thereof accordingly.**

JUDGMENT

ATIO-UR-REHMAN WAZIR MEMBER (E):- Brief facts of the

case are that consequent upon recommendations of Public Service Commission, the appellant was initially appointed as Assistant Sub Inspector (ASI) in Police Department vide order dated 15-12-2010. After completion of officiating period, the appellant was confirmed as ASI with effect from the date of his regular appointment against such post i.e. 10-02-2011. The respondents instead of his date of confirmation entered his name in E list on 08-05-2014 and on the basis of which a revised seniority list dated 27-07-2020 was drawn, which was bad for his future maneuver for promotion, hence he preferred a departmental appeal, which was filed vide order dated 20-05-2020. The appellant filed review petition

dated 23-06-2020, which was not responded within the statutory period, hence the instant service appeal with prayers that the impugned order dated 20-05-2020 may be set aside and seniority list dated 27-07-2020 may be revised to the extent that the appellant name be placed at list E with effect from the date of appointment i.e. 10-02-2011 and in view whereof, his officiating promotion order dated 03-06-2016 to the rank of Sub Inspector be revised and be given effect from the date of his eligibility and be confirmed as Sub Inspector under Rule-13(18) of Khyber Pakhtunkhwa Police Rules, 1934 with all consequential benefits.

02. Learned counsel for the appellant has contended that the appellant has neither been treated in accordance with law nor has he been extended equal protection of law, rather his legal vested rights have been violated; that as per rule, list E of all ASIs to be published in the police gazette annually in accordance with Rule-13:11 of Police Rules, 1934; that entry of the officers to such list shall be made from the date of confirmation, but the said list has neither been issued nor circulated to the officers concerned; that the impugned list has been prepared in deviation of rules, hence illegal, therefore, required to be rectified to meet the ends of justice; that Rule-12:2(3) of Khyber Pakhtunkhwa Police Rules, 1934 provides criteria for determining seniority of subordinate ranks of police force from the date of their confirmation, which is 10-02-2011 in case of the appellant, which however is recorded as 08-05-2014, which adversely affected seniority/promotion of the appellant; that similarly placed other colleagues of the appellant had approached Peshawar High Court in Writ Petition No. 3720-P/2018, which was disposed of vide judgment dated 24-04-2019 with direction to respondents to revise list E as per date of confirmation, which was rectified vide order dated 05-06-2020, therefore, the appellant having similar case, is also entitled for the same relief within the meaning of judgment of the Apex Court reported as 2009 SCMR 1:



03. Learned Deputy District Attorney for the respondents has contended that the judgment of Peshawar High Court dated 05-06-2020, as referred to by the learned counsel for the appellant was judgment in personam, hence was not applicable in case of the appellant as the appellant was not petitioner in the said writ petition, that name of the appellant was removed from list E vide order dated 01-06-2018 under Rule-16(33) of Khyber Pakhtunkhwa Police Rules, 1934. The appellant was promoted back to the rank of ASI, but upon acceptance of his department the rank of the appellant was restored on promotion list E with restoration of his existing rank of Sub-Inspector with all back benefits vide order dated 23-10-2018; that a committee for the purpose was constituted to settle the list of promotion of officials on list E from the date of confirmation, but the appellant did not appear before the committee for placing him on list E; that contention of the appellant to bring his name on list E with retrospective effect is not justified under the rule.

04. We have heard learned counsel for the parties and have perused the records. Criteria for placing names of upper sub-ordinates has been devised in Rule-12:2 of Khyber Pakhtunkhwa Police Rules, 1934, which is reproduced as under:

*Rule-12:2 Seniority in the case of upper subordinates, will be reckoned in the following order from date of first appointment, officers promoted from a lower rank being considered senior to persons appointed direct on the same date and the seniority of officers appointed direct on the same date being reckoned according to the date of confirmation. Seniority shall, however, be finally settled by dates of confirmation, the seniority inter se of several officers confirmed on the same date being that allotted to them on first appointment. Provided that any officer whose promotion or confirmation is delayed by reason of his being on deputation outside his range or district shall, on being promoted or confirmed, regain the seniority which he originally held vis-à-vis any officers promoted or confirmed before him during his deputation.*

05. We have noted that the issue of seniority based on list E and criteria for placing names of officials on list E was strongly agitated by the official concerned, for which a committee was constituted to settle the issue once and for all. The committee submitted its report vide order dated 31-08-2017 and in light of Rule-12:2 as well as judgments reported as 2002 PLC (C.S) 1403 and 1999 SCMR 1594, very clearly recommended that confirmation of PASIs would be made from the date of their regular appointment against their posts and their placement on list E would be from the date of confirmation and not with immediate effect. Such report was not implemented, until some of the batch-mates of the appellant filed Writ Petition No. 3720-P/2018 with prayers to implement the decision of the committee regarding fixation of seniority, whereas seniority list E be revised and the petitioner be brought and placed at their due place of seniority and also to ensure the circulation of the seniority list prepared in accordance with law and rules. The said writ petition was disposed of vide judgment dated 24-04-2019 with direction to the respondents to implement recommendations of the committee already submitted to them. In pursuance of the said judgment, confirmation as well as placement of the petitioners on list E was rectified and were confirmed from the date of their appointments vide order dated 05-06-2020. Case of the appellant is also the same but respondents did not bother to consider his case on the same analogy. To this effect, the Supreme Court of Pakistan in its judgment reported as 1996 SCMR 1185 have held that when a court decide a point of law relating to the terms of service of a civil servant which covers not only the case of civil servant who litigated, but also of other civil servants, who may have not taken legal proceedings, in such a case, the dictates and rule of good governance demand that the benefit of such judgment be extended to other civil servants, who may not be parties to the litigation instead of compelling them to approach the tribunal or any other legal forum. In view of the verdict of the apex court, the respondents were required to extend the same benefit to the appellant as well, which however was not

granted to the appellant and which was not warranted. The issue of confirmation from the date of appointment has already been decided in similar cases vide judgment reported as 2001 FLC (C.S) 245 as well as judgment dated 07-12-2017 of this Tribunal in Service Appeal No. 573/2016 and judgment dated 18-03-2019 in Service Appeal No. 800/2018. In view of the clear judgments and report dated 31-03-2017 of the committee constituted for the purpose, case of the appellant squarely falls within the purview of similarly placed employees and the department cannot ignore the appellant from extending the benefit of that very judgments.

A Scrutiny Committee was held on 22.12.2021 at 11:00 A.M. in the Law, Parliamentary Affairs & Human Rights Department under the Chairmanship of the Secretary for the subject case for filing of Appeal/CPLA in the Supreme Court of Pakistan. (Mr. H. Jafar Naveed) represented the Advocate General, Khyber

Department. Mr. Umar Nawaz, DS alongwith Mr. M. Iqbal Supdt. Police apprised the Committee about the background of the case and that the subject service appeal with the prayer that the impugned order dated 20.05.2020 regarding seniority list dated 27.07.2020 may be revised so that the appellant's seniority date of appointment i.e. 10.02.2011 and in view whereof, his promotion to the rank of Sub-Inspector be revised and be given effect from the date 03.06.2016 to be confirmed as Sub-Inspector under rule 13(18) of Khyber Pakhtunkhwa Police Rules 1973 with consequential benefits. The Khyber Pakhtunkhwa Service Tribunal vide order dated 20.05.2020 accepted the subject service appeal as prayed for. The Scrutiny Committee declared the following grounds:

REASONED DISCUSSIONS:

1. The Scrutiny Committee perused the record of the case and the impugned judgment which revealed that some of the batch mates of the appellant filed W.P. Petition No. 3720-P/2018 with prayer to implement the decision of the Committee regarding fixation of seniority whereas seniority list E be revised and the petitioner be brought and placed at their due place of seniority and to ensure the circulation of the seniority list prepared in accordance with law which was disposed of by the Hon'ble High Court vide judgment dated: 24.04.2019 with a direction to the respondents to implement recommendation of the Committee. In pursuance of the said judgment, confirmation as well as placement of the petitioners in List-E was rectified and were confirmed from the date of their appointment vide order dated: 05.06.2020 and the case of the appellant was the same but the Department did not consider the case of the appellant on the same analogy.
2. The Scrutiny Committee held that not granting the benefit to the appellant and granting the benefits to his batch mates amounts to discrimination which is not tenable in the eyes of law. The Scrutiny Committee held that no plausible grounds exist against which CPLA in the upper forum could be filed.

ADVICE:

3. Hence in view of above, it was decided with consensus by the Scrutiny Committee that the subject case was not a fit case for filing of Appeal/CPLA in the Supreme Court of Pakistan.





1. Service appeal no 12438/2021 was decided in favor of appellant vide judgment dated 30.11.2021.
2. <sup>Proposed for</sup> CPLA was moved by worthy PPO Kpk Peshawar which was rejected, after getting finality the judgment dt 30.11.2021 WPPO issued direction to RPO Bannu vide order no 159/ 2022 to implement the judgment as prayed for (copy attached as A).
3. Rpo Bannu did not obey the order of service Tribunal nor of WPPO kpk Peshawar to implement the judgment.
4. To implement the judgment as prayed for Execution petition is filed in Service Tribunal.
5. Last chance was given to Respondents vide order sheet dated 19.10.11, to implement the judgment in true letter and spirit.
6. That was the responsibility of Rpo Bannu to implement the judgment of Service Tribunal Kpk despite of it the judgment of honorable Service Tribunal was put in cycle bin by imposing his own unprecedented and desultory decision through OB 353 dated 18.11.2022 vide memo no.4516 dated 18.11.2022 which is not in accordance of prayer of judgment nor of procedure laid down in 13.10 and 13.11 of police rules 1934 (copy attached as B).
7. Rpo Bannu was bond to issue proper gazette notification to admit the name of appellant to list "E" with the officers already admitted to list "E" on 10.02.2011 vide seniority list "E" No 827/EC issued on 06.04.2015 of Bannu region is very much clear, the name of appellant deserved to be place below the name of OSI Mohammad Salim no 31/B and above the name of OSI Javed Iqbal as well as 3 specimens of notification are enclosed (copies attached as CDEF).
8. Appellant promotion as sub inspector dated 28.03.2016, be revised in the light of list "E" dated 10.02.2011 and also be confirmed under 13.18 from the date of promotion as sub inspector vide seniority list "E" no 827/ Ec dated 06.04.2015.
